COMMISSION ANNOUNCEMENTS

CANCELLATION OF MARKET OVERSIGHT AND FINANCIAL SERVICES ADVISORY COMMITTEE MEETING

The meeting of the Securities and Exchange Commission Market Oversight and Financial Services Advisory Committee scheduled for December 1, 1992 has been cancelled. (Rel. 34-31517; File No. 265-17)

ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS AGAINST THREE FORMER GRAYSTONE NASH, INCORPORATED MANAGERS

The Commission instituted public administrative proceedings pursuant to Sections 15(b)(6) and 21C of the Securities Exchange Act of 1934 as to James L. Copley, Richard D. DeMaio and James F Ricketts, Jr., former managers in the Boca Raton, Florida office of Graystone Nash, Incorporated. The Commission's Division of Enforcement alleged that the three, among other things, willfully violated, aided and abetted or caused violations of antifraud provisions in connection with initial public offerings and post-offering selling practices in 1987 and 1988. A hearing will be held to take evidence on the charges and allow respondents an opportunity to establish any defenses. (Rel. 34-31454)

NASD ACTION AGAINST ARISTO INVESTMENTS OF AMERICA, INC. AND JOHN HARALAMBIDES SUSTAINED

The Commission sustained the NASD'S findings that Aristo Investments of America, Inc., a former Miami, Florida brokerage firm, and John A. Haralambides, its president and owner, violated a financial reporting requirement by filing the firm's FOCUS Part I Report for May 1990 late. The Commission also sustained sanctions imposed on the applicants by the NASD. The NASD censured applicants and fined them \$2,000, jointly and severally.

Noting that this was the forth time the firm had been sanctioned for such late filings, the Commission observed that the requirement to file timely FOCUS reports is an important means of monitoring the financial health of broker-dealers and of protecting public investors. (Rel. 34-31516)

INVESTMENT COMPANY ACT RELEASES

TRANSAMERICA OCCIDENTAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until December 21, 1992 to request a hearing on an application filed by Transamerica Occidental Life Insurance Company (Transamerica) Separate Account VA-2NL of Transamerica (the "Account") and Dreyfus Service Corporation for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2) and 27(c)(2) of the Act to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of the Account under certain variable annuity contracts. (Rel. IC-19119 - November 24)

INTEGRITY LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Integrity Life Insurance Company and Separate Account SF of Integrity Life Insurance Company from Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under certain individual and group variable annuity contracts. (Rel. IC-19120 - November 24)

NATIONAL INTEGRITY LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting National Integrity Life Insurance Company, Separate Account SFN of National Integrity Life Insurance Company and Integrity Financial Services, Inc. from Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under certain individual and group variable annuity contracts. (Rel. IC-19121 - November 24)

THE RUSHMORE FUND, INC., ET AL.

A conditional order has been issued pursuant to Sections 6(c) and 17(d) of the Investment Company Act and Rule 17d-1 thereunder on an application filed by The Rushmore Fund, Inc., et al. permitting applicants to operate a joint trading account in repurchase agreements. (Rel. IC-19122 - November 24)

OPPENHEIMER MANAGEMENT CORPORATION, ET AL.

A conditional order has been issued on an application filed by Oppenheimer Management Corporation, et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to (a) issue two classes of shares in each Fund representing interests in the same portfolio of securities, one of which would convert into the other after a specified period of time, and (b) impose different contingent deferred sales charge (CDSC) arrangements on shares of each class of the Funds and waive the CDSC in certain cases. (Rel. IC-19123 - November 24)

THE LATIN AMERICA INVESTMENT FUND, INC., ET AL.

A notice has been issued giving interested persons until December 21, 1992 to request a hearing on an application filed by the Latin America Investment Fund, Inc., et al., for an order under Section 10(f) of the Investment Company Act permitting applicants to purchase securities in public offerings in Mexico in which an affiliate of applicants' investment adviser participates as a principal underwriter. (Rel. IC-19124 International Series Rel. 493 - November 24)

VOYAGEUR TAX FREE FUNDS, INC., ET AL.

A conditional order has been issued on an application filed by the Voyageur group of registered investment companies (the Funds), and Voyageur Fund Distributors, Inc. for a conditional order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to impose a contingent deferred sales charge (CDSC) on redemptions of shares of the Funds sold with no initial sales charge because of a volume discount, and to waive the CDSC under certain circumstances. (Rel. IC-19125 - November 24)

HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

A supplemental order has been issued authorizing a proposal by Central and South West Corporation (CSW), a registered holding company, and its nonutility subsidiary company, Transok, Inc. (Transok), whereby CSW will make equity investments in Transok through capital contributions, the acquisition of common stock or both in aggregate principal amounts of up to \$65 million at any time prior to December 31, 1993, using internal funds or the proceeds from the sale of commercial paper. (Rel. 35-25684)

TRANSOK, INC.

A supplemental order has been issued authorizing Transok, Inc., a subsidiary company of Central and South West Corporation, a registered holding company, to amend certain terms of its medium-term notes which it was previously authorized to issue and sell in aggregate principal amounts of up to \$200 million from time-to-time through December 31, 1993. (Rel. 35-25685)

NATIONAL FUEL GAS COMPANY, ET AL.

A supplemental order has been issued authorizing National Fuel Gas Company (National), a registered holding company, and its wholly owned subsidiary companies, National Fuel Gas Distribution Corporation, Penn-York Energy Corporation, National Fuel Gas Supply Corporation and Seneca Resources Corporation to engage in financing. National proposes to issue and sell, through December 31, 1993 up to an aggregate amount of \$43 million of medium-term notes, under an exception from competitive bidding, at prices ranging between 98% and 102% of their principal amount. (Rel 35-25686) A supplemental order has been issued authorizing National Fuel Gas Company (National), a registered holding company, and its wholly owned subsidiary company, National Fuel Gas Distribution Corporation to engage in financing. National proposes to issue and sell, through December 31, 1993 an aggregate amount of \$106 million of medium-term notes, under an exception from competitive bidding, at prices ranging between 98% and 102% of their principal amount. (Rel. 35-25687)

EASTERN UTILITIES ASSOCIATES, ET AL.

A notice has been issued giving interested persons until December 16, 1992 to request a hearing on a proposal by Eastern Utilities Associates (EUA), a registered holding company, and its wholly owned subsidiaries, EUA Power Corporation (EUA Power), EUA Service Corporation and Montaup Electric Company. EUA Power filed for protection under Chapter 11 of the United States Bankruptcy Code on February 28, 1991 and has since been operating its business as a debtor-in-possession. EUA, EUA Power and the officially appointed Bondholders Committee in EUA Power's bankruptcy proceeding have entered into a settlement agreement to resolve various matters currently in dispute, as well as any and all other issues and claims that exist among the parties. The applicants request authorization to engage in certain transactions contemplated by the proposed settlement agreement. (Rel. 35-25688)

PROPOSED RULE CHANGES

The <u>New York Stock Exchange</u> filed a notice of a proposed rule change (SR-NYSE-92-32) under Exchange Act Rule 19b-4 relating to electronic "T+1" overnight comparison of Exchange bond transactions, the comparison of initial trade data in listed bonds by the Exchange through its overnight comparison system, and security position movements through the "step-out" service in listed bonds. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 23. (Rel. 34-31504)

The <u>Participants Trust Company</u> filed a notice of a proposed rule change (SR-PTC-92-13) under Exchange Act Section 19(b)(3)(A) and Rule 19b-4 relating to a policy with respect to the distribution to Participants of income from the elimination of "pennies" from the face amount of certain Government National Mortgage Association securities.
