RULES AND RELATED MATTERS

MULTIJURISDICTIONAL DISCLOSURE; ELIGIBILITY OF BRITISH COLUMBIA TRUSTEES AND EXEMPTION FOR BRITISH COLUMBIA TRUST INDENTURES FROM SPECIFIED PROVISIONS OF THE TRUST INDENTURE ACT

On December 1, the Commission proposed for comment amendments to two rules under the Trust Indenture Act of 1939 (Act), which would facilitate the Commission's proposed Multijurisdictional Disclosure System with Canada (MJDS).

As proposed, the amendment to Rule 10a-5 would permit any person incorporated and regulated as a trust company under the laws of the province of British Columbia, who is authorized to exercise corporate trust powers and subject to federal supervision or examination under the laws of Canada to act as sole trustee under indentures qualified or to be qualified under the Act in connection with offerings under the MJDS.

The proposed amendment to Rule 4d-9 would exempt trust indentures of British Columbia obligors filing registration statements in the United States under MJDS from the operation of specified provisions of the Act. ACCESS TO NONPUBLIC INFORMATION

The Commission is publishing for public comment Rule 24c-1 under the Securities Exchange Act of 1934. Under a recent amendment of the Exchange Act, Section 24(c) permits the Commission, in its discretion and upon a showing that such information is needed, to provide information in its possession to such persons, domestic and foreign, as the Commission by rule deems appropriate if the person receiving such information provides such assurances of confidentiality as the Commission deems appropriate. The proposed rule is intended to complement the Commission's current access program and to implement Section 24(c). It would designate categories of domestic and foreign governmental authorities, self-regulatory organizations and other specified persons now participating in the Commission's current program as persons who may be provided access to nonpublic information in the Commission's possession. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-92-22) to amend Section 13 of Schedule E to the NASD By-Laws to allow employees and other Section 13 associated persons of an NASD member to purchase securities issued by an entity which owns (alone or in the aggregate with any wholly-owned, non-public subsidiary) at least 51% of the outstanding voting stock of the member. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 30. (Rel. 34-31521)

<u>The Options Clearing Corporation</u> filed a proposed rule change (SR-OCC-92-38) that would allow OCC to impose exercise restrictions consistent with that of an exchange on all its clearing members who hold a particular series of options being restricted by the exchange. <u>The Depository Trust Company</u> filed a proposed rule change (SR-DTC-92-18) relating to DTC's enhancement of its Repo Tracking System. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 30. (Rel. 34-31535)

<u>The Options Clearing Corporation</u> filed a proposed rule change (SR-OCC-92-24) that would permit OCC to expand the cross-margining program with the Board of Trade Clearing Corporation to include non-proprietary positions. TEMPORARY ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted temporary accelerated approval to a proposed rule change submitted by the <u>American Stock Exchange</u> (SR-Amex-92-39) to extend for six months its use of the Amex Auto-Ex System for select equities in periods of extremely high order flow. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 7. (Rel. 34-31538)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the <u>Pacific Stock Exchange</u> (SR-PSE-92-32) to make permanent its current pilot program that implements certain policy statements relating to the PSE's alternate specialist system. Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
