ADMINISTRATIVE PROCEEDINGS

GEORGE SALLOUM BARRED

Administrative Law Judge Jerome K. Soffer has issued an initial decision barring George Salloum of Pittsford, New York from association with any broker or dealer. After nine months Salloum may apply to become so associated in a non-proprietary and non-supervisory capacity upon a satisfactory showing to the Commission that he will be adequately supervised.

The sanction imposed was based upon findings that Salloum, while employed as head trader and syndicate manager of Thomas James Associates, Inc., a registered brokerdealer, engaged in aiding and abetting unlawful markups of which he failed to advise investors in the sale of securities of four separate issuers. It was further found that Salloum had been permanently enjoined in the United States District Court for the Western District of New York from future violations of the securities laws. INVESTMENT COMPANY ACT RELEASES

NATIONAL GLOBAL ALLOCATION FUND

A notice has been issued giving interested persons until January 11, 1993 to request a hearing on an application filed by National Global Allocation Fund for an order under Section 8(f) of the Investment Company Act declaring that it has ceased to be an investment company. (Rel. IC-19153 - December 14)

PREVIOUSLY OWNED PARTNERSHIPS INCOME FUND - 92, ET AL.

A conditional order has been issued on an application filed by Previously Owned Partnerships Income Fund - 92 (Partnership) and MacKenzie Patterson Advisors, Inc. under Section 6(c) of the Investment Company Act. The conditional order determines that the Independent General Partners (as defined in the application) will not be deemed to be "interested persons" of the Partnership solely because of their status as general partners. The conditional order also determines that limited partners of the Partnership who own less than five percent of the voting interests in the Partnership, and who are not affiliated persons by virtue of any other provision of the Act, will not be deemed to be "affiliated persons" of the Partnership or any other partners solely by virtue of their limited partner status. VAN ECK FUNDS, ET AL.

A conditional order has been issued on an application filed by Van Eck Funds, Van Eck Associates Corporation and Van Eck Securities Corporation under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c) and 22(d) of the Act and Rule 22c-1 thereunder. The order permits certain series of the Van Eck Funds to issue two classes of shares representing interests in the same portfolio of securities, one of which would convert into the other class after a specified period permitting investors to benefit from lower Rule 12b-1 distribution fees. The order also permits certain series of Van Eck Funds to assess a contingent deferred sales charge (CDSC) on certain redemptions of shares of one of the classes and to waive the CDSC under certain circumstances. HOPE GAS, INC.

A notice has been issued giving interested persons until January 7, 1993 to request a hearing on a proposal by Hope Gas, Inc. (Hope Gas), a gas utility subsidiary company of Consolidated Natural Gas Company, a registered holding company. Hope Gas proposes to acquire up to \$1,000,000 million of nonvoting Class B Units of Vandalia Capital Limited Partnership (Partnership), a partnership formed to provide private venture capital investments in West Virginia businesses, and to receive in return certain tax credits. Hope Gas will own 25% of the equity of the Partnership, and be entitled to all of the tax credits earned by the Partnership. (Rel. 35-25707)
