ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES EXCHANGE COMMISSION

NASD ACTION AGAINST PETER LLOYD AFFIRMED

The Commission has affirmed NASD disciplinary action against Peter K. Lloyd of Odessa, Florida, a former registered representative of an NASD member firm. The NASD censured Lloyd, fined him \$10,000, suspended him from association with any member for 20 days and barred him from any such association in a principal or supervisory capacity.

The Commission found, as had the NASD, that in 1988 Lloyd made an unsuitable recommendation to a customer and failed to give his employer the required prior written notification of the resulting sale, a private securities transaction. While the Commission concluded that the sanctions assessed by the NASD were fully warranted, it stated that in light of various mitigative factors it would be appropriate for the NASD to grant an application by Lloyd for employment in a principal or supervisory capacity provided that, in accordance with his stated intention, he repaid his customer in full with appropriate interest and there was no new information relating to him or his prospective employer that reflected adversely on his ability to function in those capacities in a manner consonant with the public interest. INVESTMENT COMPANY ACT RELEASES

PACIFIC GLOBAL FUND, INC., ET AL.

A notice has been issued giving interested persons until January 18, 1993 to request a hearing on an application filed by Pacific Global Fund, Inc., et al. for a conditional order under Section 6(c) of the Investment Company Act exempting applicants from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order would permit applicants to impose a contingent deferred sales charge (CDSC) on certain redemptions of shares and to waive the CDSC under certain circumstances. (Rel. UNITED FINANCIAL GROUP, INC.

A conditional order has been issued on an application filed by United Financial Group, Inc. under Sections 6(c) and 6(e) of the Investment Company Act exempting applicant from all provisions of the Act, subject to certain exceptions, until December 30, 19^{93} . The exemption continues an exemption originally granted until December 30, 19^{90} and extended by amended orders until December 30, 1991 and December 30, 199. (Rel IC-19175 - December 22)

SHEARSON LEHMAN BROTHERS APPRECIATION FUND INC., ET AL.

A notice has been issued giving interested persons until January 15, 1993 to request a hearing on an application by Shearson Lehman Brothers Appreciation Fund Inc. and other members of the Shearson group of investment companies (Funds), their distributor and their respective investment advisers. The application is for an order amending a prior order granting exemptive relief from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c) and 22(d) of the Act and Rule 22c-1 thereunder to allow the creation of multiple class and contingent deferred sales load arrangements. The requested amended order would permit the Funds to issue and sell additional classes of shares and to modify the deferred sales load arrangement. (Rel. IC-19176 - December 22)

THE ASO OUTLOOK GROUP. ET AL.

A notice has been issued giving interested persons until January 15, 1993 to request a hearing on an application filed by The ASO Outlook Group, certain other registered investment companies, their respective advisers and The Winsbury Company. The application is for a conditional order under Section 6(c) of the Investment Company Act granting an exemption from Sections 18(f), 18(g) and 18(i) of the Act. The requested exemptive relief would permit the named investment company applicants, and any other registered investment company for which The Winsbury Company may serve in the future as principal underwriter, to create multiple classes of shares in their respective investment portfolios.
