PROPOSED AMENDMENTS TO RULES AND GUIDELINES

The Commission issued a release soliciting comment on proposed amendments to Rules 10f-3, 17a-7, 17e-1, 17f-4, and 22c-1 under the Investment Company Act. The proposed amendments would eliminate requirements in these rules that directors annually review certain arrangements and procedures, and require instead that directors make and approve changes only when necessary. The proposed amendments implement recommendations made in Chapter 7 of the Division of Investment Management's report, "Protecting Investors: A Half Century of Investment Company Regulation" (May 1992). The proposals are intended to substitute more meaningful requirements for the current annual review requirements, which are not necessary to further the purposes of the rules or to protect investors. The proposals would also make conforming changes to the Guidelines to Forms N-1A and N-3.

INVESTMENT COMPANY ACT RELEASES

THE VANGUARD GROUP, INC., ET AL.

An order has been issued denying a request for a hearing, and granting an application filed by The Vanguard Group, Inc., (TVGI), Vanguard Marketing Corporation (VMC) and the Vanguard group of registered investment companies (the Funds) for an order pursuant to Rule 17d-1 under the Investment Company Act permitting certain transactions in accordance with Section 17(d) and Rule 17d-1, and pursuant to Sections 6(c) and 17(b) permitting certain transactions that would be otherwise prohibited by Section 17(a). The order permits the Funds to solicit shareholder approval to amend the service agreement between the Funds, TVGI and VMC to increase the authorized maximum amount of the Funds' assets that may be invested as working capital in TVGI, the Funds' service company subsidiary, from 0.25% of each of the Funds' net assets, with an aggregate limit of \$25 million, to 0.40% of each of the Funds' net assets, with no aggregate dollar limit, in order to finance the Funds' operations and permit the Funds to construct new office facilities. The order also permits the boards of the directors of the Funds to amend the service agreement in certain other respects that are technical in nature. (Rel. IC-19184 - December 29)

TOST PRAIRIE MONEY MARKET FUND, ET AL.

A notice has been issued giving interested persons until January 25, 1993 to request a hearing on an application filed by First Prairie Money Market Fund (the Fund) and The First National Bank of Chicago (FNBC) for an order under Sections 6(c) and 17(b) of the Investment Company Act. The order would permit the Fund to enter into repurchase agreements with FNBC or an affiliate of FNBC. (Rel. IC-19185 - December 29)

HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until January 22 to request a hearing on a proposal by General Public Utilities Corporation, a registered holding company, to repurchase up to five million shares of its common stock through December 31, 1995. (Rel. 35-25722 - December 29)

BLACKSTONE VALLEY ELECTRIC COMPANY

An order has been issued authorizing Blackstone Valley Electric Company (Blackstone), an electric public-utility subsidiary company of Eastern Utilities Associates, a registered holding company, to enter into a letter of credit and reimbursement agreement with The Bank of New York (BONY). The letter of credit would be in an amount not to exceed \$6,941,643.84, and would have a term of three years, extendable for an additional year with the consent of BONY. ENERGY INITIATIVES, INC., ET AL.

An order has been issued authorizing a proposal by Energy Initiatives, Inc. (EII) and OLS Acquisition Corporation (OLS Acquisition), two subsidiaries of General Public Utilities Corporation, a registered holding company, under which OLS Acquisition intends to declare an \$880,000 dividend, which would be paid from unearned surplus. LOUISIANA POWER & LIGHT COMPANY

A supplemental order has been issued authorizing a proposal by Louisiana Power & Light Company (LP&L), an electric public utility subsidiary of Entergy Corporation, a registered holding company. LP&L proposes to: (1) extend the date through which LP&L's first mortgage bonds (Bonds), preferred stock (Preferred) and its tax-exempt bonds may be issued and sold to December 31, 1994; and (2) extend the date through which LP&L may acquire its outstanding Bonds, Preferred and tax-exempt bonds to December 31, 1994.
