COMMISSION ANNOUNCEMENTS

MARKET TRANSACTIONS ADVISORY COMMITTEE MEETING

On February 10, 1993, the Securities and Exchange Commission's Market Transactions Advisory Committee will hold its next meeting at 10:00 a.m. in Room 1C30 at the Commission's main offices. The meeting will be open to the public. Publication of the notice is expected in the <u>Federal Register</u> during the week of January 11. (Rel. 34-31707; File No. 265-18)

ADMINISTRATIVE PROCEEDINGS

OREGON INVESTMENT ADVISER ORDERED TO CEASE AND DESIST FROM RECORDKEEPING AND REPORTING VIOLATIONS

The Commission announced on January 4 that it accepted an offer of settlement from Stephen C. Schulmerich d/b/a Schulmerich & Associates Asset Management, a Portland, Oregon investment adviser, and Stephen C. Schulmerich, its sole proprietor in public cease and desist proceedings instituted on September 21, 1992. The proceedings were based on allegations that respondents had violated certain recordkeeping and reporting rules under the Investment Advisers Act of 1940. The respondents consented, without admitting or denying the Commission's allegations, to entry of an order making findings and an order to cease and desist from future violations of Section 204 of the Advisers Act and Rules 204-2(a)(2) and (6), 204-1(b)(1) and 204-1(c) thereunder. The respondents were also ordered to comply with certain recordkeeping and reporting undertakings. (Rel. IA-1358)

CIVIL PROCEEDINGS

COMPLAINT FILED AGAINST NINE DEFENDANTS

The Commission announced that on December 24, 1992 a complaint was filed seeking permanent injunctions against Thomas Bell (Bell), Charles Harroun (Harroun), Kurt Hermann (Hermann), Anthony Martinelli (Martinelli), Timothy Mobley (Mobley), Michael

Montana (Montana), Wenton White (White), Jeffrey Wetzel (Wetzel) and Dennis Wilk (Wilk) in the District of Nevada. In its complaint, the Commission alleged that all nine defendants engaged in violations and aiding and abetting violations of the antifraud provisions and that Mobley and Wetzel aided and abetted violations of the books and records provisions of the federal securities laws.

In its complaint, the Commission alleged that the defendants assisted in a manipulation of the offer and sale of securities of certain blind pool issuers while the defendants were employed at Stoneridge Securities, Inc. of Las Vegas, Nevada. In addition, the Commission alleged that Mobley and Wetzel inserted false information on certain of Stoneridge's books and records. All defendants except Bell, Mobley and Wetzel have consented to the entry of permanent injunctions against them. [SEC v. UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of three exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-92-05) that enables the Exchange to list additional strike prices for Exchange-traded index options. Specifically, under the new rule governing the introduction of new options series, the CBOE may add up to four strike prices above and below the current index price when a new series is opened, and up to five strike prices above and below the current index price when the current index price reaches an existing strike price. In addition, the CBOE may add up to six strike prices above and below the current index price when unusual market conditions warrant. Publication of the order is expected in the Federal Register during the week of January 11. (Rel. 34-31697)
