# FREEDOM OF INFORMATION ACT RELEASES

FOIA APPEAL DENIED

The General Counsel affirmed the decision, pursuant to FOIA Exemption 7(A), 5 U.S.C. 552(b)(7)(A), 17 C.F.R. 200.80(b)(7)(i)(A), to withhold non-public information from requester Nadeem Faruqi relating to U.S. Bioscience, Inc. The General Counsel concluded that the release of the requested documents could reasonably be expected to interfere with law enforcement proceedings, and thus, the documents were protected under Exemption 7(A). #### ADMINISTRATIVE PROCEEDINGS

SETTLEMENT OFFER OF JAMES SUNDAY ACCEPTED

The Securities and Exchange Commission announced the entry of an Order Instituting Public Administrative Proceedings and Cease and Desist Proceedings, Making Findings and Imposing Remedial Sanctions against James Earl Sunday.

Sunday, formerly a registered representative with PaineWebber, a broker-dealer registered with the Commission, consented to the issuance of the Order without admitting or denying the Commission's findings. The Order contains findings that, from May 1988 until March 1990, Sunday made misrepresentations and omitted to state material facts relating to the value of a customer's account and the risks associated with options trading. Sunday also traded that customer's account excessively.

The Order further finds that Sunday willfully violated Sections 17(a)(1), (2) and (3) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. As a result, Sunday is ordered to cease and desist from committing or causing further violations of the securities laws and is barred from association with any broker, dealer, investment company, investment adviser or municipal securities dealer, provided that Sunday may reapply to become so associated after four years from the date of the Order. ## CIVIL PROCEEDINGS

# JUDGMENT OF DISGORGEMENT ENTERED AGAINST AFDI-COLORADO

On December 23, 1992, Judge Judith N. Keep of the United States District Court for the Southern District of California entered a Final Judgment of Disgorgement Against American Financial Dimensions, Inc., a Colorado corporation (AFDI-Colorado) to which AFDI-Colorado consented. AFDI-Colorado must disgorge \$189,617.13 plus \$123,675.09 in interest.

The complaint, filed August 16, 1990, charged AFDI-Colorado and six other defendants with selling unregistered securities issued by Centre City Funding, Inc. (CCF), Financial Dimensions, Inc., American Financial Dimensions, Inc., an Iowa corporation, and AFDI-Colorado. The proceeds from these offerings, which totalled \$9 million, were to be used for CCF's factoring operations (the purchase of factored accounts receivable from companies, medical clinics and physicians). The defendants were variously charged with making false and misleading statements to investors and misappropriating investor funds by engaging in a Ponzi-like scheme. Final Judgments of Permanent Injunction against each defendant were entered on August 31 and November 6, 1990, pursuant to their consents.

The Commission continues to seek disgorgement from five remaining defendants. [SEC v. Donald D. Bader, et al., Civ. Action No. 90-1135 K, IEG, S.D. Cal.] (LR-13490)

# HOLDING COMPANY ACT RELEASES

WNC CALIFORNIA HOUSING TAX CREDITS III, L.P., ET AL.

An order has been issued under Section 6(c) of the Investment Company Act exempting WNC California Housing Tax Credits III, L.P. (the Partnership), from all provisions of the Act to permit the Partnership to invest in other limited partnerships that in turn will engage in the ownership and operation of housing for low and moderate income persons. (Rel. IC-19211 - January 13)

AMERICAN CAPITAL BOND FUND, INC., ET AL.

An order has been issued under Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder amending a prior order that allowed American Capital Bond Fund, Inc., et al. to establish a joint trading account in repurchase agreements. The amended order permits American Capital Government Target Series to participate in the joint trading account. (Rel. IC-19212 - January 13)

## HOLDING COMPANY ACT RELEASES

THE SOUTHERN COMPANY, ET AL.

An order has been issued concerning the Southern Company (Southern), a registered holding company, and its wholly owned electric public-utility subsidiary companies, Alabama Power Company (Alabama), Georgia Power Company (Georgia), Gulf Power Company, Mississippi Power Company, Savannah Electric and Power Company and Southern Electric Electric Generating Company, an electric public-utility company owned equally by Alabama and Georgia, (collectively, Operating Companies). The order authorizes the Operating Companies to acquire and finance a new railroad subsidiary (Railroad Subsidiary). Southern proposes to organize and acquire all of the outstanding capital stock of Railroad Subsidiary which will construct rail lines from the generating facilities of the Operating Companies to competing rail carriers (Rail Lines). Southern will also contribute to the equity capital of Railroad Subsidiary, through December 31, 1997, up to an aggregate principal amount of \$1 Million. Operating Companies propose to lend, through December 31, 1997, to Railroad Subsidiary all funds necessary to complete construction of the Rail Lines. (Rel. 35-25734)

#### SAVANNAH ELECTRIC AND POWER COMPANY

A supplemental order has been issued authorizing Savannah Electric and Power Company, a subsidiary company of The Southern Company, a registered holding company, to refinance up to \$4,085 million of the costs of certain pollution control and sewage and solid waste disposal facilities located in Effingham County, Georgia. #### NOTICE OF AMENDMENT OF PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed Amendment No. 3 to the NASD's proposed short sale rule (SR-NASD-92-12). The NASD is amending the proposed short sale rule or "bid test" for Nasdaq National Market system securities to include a provision regarding short sales by qualified options market makers and to add a provision identical to a section in Securities Exchange Act Rule 10a-1 exempting certain customer transactions. The NASD is also proposing amendments to the Automated Confirmation Transaction service (ACT) and an amendment to the Rules of Fair Practice to clarify the books and records requirements applicable to member sales. Publication of the proposal is expected in the <u>Federal Register</u> during the week of January 18, 1993. (Rel.34-31729)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
