RULES AND RELATED MATTERS

SECURITIES TRANSACTIONS SETTLEMENT

The Commission has approved publication of proposed Rule 15c6-1 that, if adopted, will establish three days, instead of five business days, as the standard settlement timeframe for broker-dealer securities transactions. Publication of the proposed rule in the <u>Federal Register</u> is expected to be made during the week of March 1, 1993. (Rels. 33-6976; 34-31904; IC-19282; File No. S7-5-93)

ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS ORDERED AGAINST RAY KOBAYASHI

The Commission announced that on February 16 it ordered the institution of public administrative proceedings pursuant to Section 15(b) of the Securities Exchange Act of 1934 against Ray H. Kobayashi (Kobayashi), a registered representative residing in Santa Monica, California. The order for proceedings alleges that Kobayashi wilfully violated Sections 5(a) and 5(c) of the Securities Act of 1933 (Securities Act) in connection with his July 1988 sale of 68,081 shares of American Aircraft Corporation (AAC) stock. The order further alleges that on October 30, 1992 the United States District Court for the Central District of California in SEC v. Ray H. Kobayashi et al., Civil Action No. 91-6654-CT, C.D. Cal., found that Kobayashi had violated Sections 5(a) and 5(c) of the Securities Act in connection with his July 1988 AAC stock sale and permanently enjoined him from future violations of Sections 5(a) and 5(c) of the Securities Act.

A hearing will be held to determine whether the allegations are true, to afford Kobayashi an opportunity to enter a defense to the allegations, and to determine what remedial relief, if any, is appropriate. (Rel. 34-31875)

INVESTMENT COMPANY ACT RELEASES

TOW HIGH GRADE FIXED INCOME LIMITED PARTNERSHIP, ET AL.

An order has been issued granting an application filed by TCW High Grade Fixed Income Limited Partnership, TCW High Yield Limited Partnership, TCW Latin America Equity Limited Partnership, TCW Private Equity Limited Partnership, TCW Specialized Cash Management Limited Partnership, TCW Funds, Inc., TCW Asset Management Company and TCW Funds Management, Inc. for an order under Section 17(b) of the Investment Company Act exempting applicants from the provisions of Section 17(a). The order permits the Partnerships to transfer their assets and liabilities to certain series of TCW Funds, Inc. in exchange for series shares, which then will be distributed to the partners of the Partnerships. (Rel. IC-19286 - February 23)

NEW CENTURY FUND, INC., ET AL.

A conditional order has been issued under Sections 6(c) and 23(b) of the Investment Company Act exempting New Century Fund, Inc. and New Century Management, Inc. from the provisions of Sections 18(d) and 23(b) of the Act. This order will permit New Century Fund to sell a limited amount of its shares on a delayed basis at the same price per share as the initial public offering price. (Rel. IC-19287 - February 23)

GOLDMAN SACHS EQUITY PORTFOLIOS, INC., ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting Goldman Sachs Equity Portfolios, Inc., et al. from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to issue multiple classes of shares representing interests in the same investment portfolio and to assess, and under certain circumstances to waive, a contingent deferred sales charge on certain redemptions of the shares of one of the classes. (Rel. IC-19288 - February 23)

FEDERATED VARIABLE RATE MORTGAGE SECURITIES TRUST

An order has been issued under Section 8(f) of the Investment Company Act declaring that Federated Variable Rate Mortgage Securities Trust has ceased to be an investment company. (Rel. IC-19289 - February 23)

LMS MONEY FUND

A notice has been issued giving interested persons until March 22, 1993 to request a hearing on an application filed by LMS Money Fund for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-19290 - February 23)

ALLMERICA FUNDS, ET AL.

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting Allmerica Funds, et al. from the provisions of Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder to the extent necessary to permit applicants to impose a contingent deferred sales charge (CDSC) on certain redemptions of shares and to waive the CDSC under certain circumstances. (Rel. IC-19291 - February 23)

STEADMAN FINANCIAL FUND

An order has been issued under Section 8(f) of the Investment Company Act declaring that Steadman Financial Fund has ceased to be an investment company. (Rel. IC-19292 - February 23)
