CIVIL PROCEEDINGS

ROBERT NAVARRE, II AND JAMES MARTIN, JR. CONSENT TO PERMANENT INJUNCTIONS

The Commission announced that on December 22, 1992, and February 11, 1993, respectively, the Honorable Pierre N. Leval, United States District Court Judge for the Southern District of New York, entered Final Consent Judgments of Permanent Injunction against James Martin, Jr. (Martin) and Robert W. Navarre, II (Navarre). Without admitting or denying the allegations in the Commission's complaint, Martin and Navarre consented to the entry of orders permanently enjoining them from violating Section 10(b) and Rule 10b-5 of the Securities Exchange Act, disgorgement by Navarre of his and his tippees' profits from transactions in Gelco Corp. (Gelco) securities in the amount of \$180,302.45, plus prejudgment interest and the payment of a civil penalty pursuant to the Insider Trading Sanctions Act of 1984 by Navarre in the same amount, and by Martin in the amount of \$55,252, representing Navarre's profits.

The Commission's complaint, filed on May 21, 1992, alleged that in September 1987, Navarre, while in possession of material, nonpublic information concerning the impending acquisition of Gelco by General Electric Credit Corp. (GECC), which information was disclosed to him by his brother-in-law, Martin, a GECC employee, purchased Gelco securities. It is further alleged that Navarre tipped his broker, Steven J. Timyan, and a business associate, John Rentas, both of whom traded Gelco securities and tipped others. [SEC v. Robert W. Navarre, II, John Rentas, Steven J. Timyan, Philip J. Timyan, and James V. EARL JOHNSON CONSENTS TO PERMANENT INJUNCTION

The Commission announced that on January 25, 1993 a Final Judgment of Permanent Injunction was entered against Earl R. Johnson in the case SEC v. Dana L. Anderson, et al., 92-F-1905, U.S.D.C. for the District of Colorado. The injunction prohibits Johnson from violating the antifraud provisions of the Securities Act of 1933 (Securities Act) and the Securities Exchange Act of 1934 (Exchange Act), the registration provisions of the Securities Act and the reporting provisions of the Exchange Act. The Commission filed a complaint on September 28, 1992 against Johnson and eleven other defendants alleging the defendants engaged in a fraudulent scheme to distribute unregistered securities of U.S. Mint, Inc. Johnson consented to the injunction without admitting or denying the allegations in the Commission's complaint. [SEC v. Dana L. Anderson, et al., U.S.D.C. for the District of Colorado, Civ. 92-F-1905] (LR-13536)

CRIMINAL PROCEEDINGS

MAXIMUM SENTENCES IMPOSED IN TASK FORCE CASE

The Commission and Michael J. Norton, U.S. Attorney for the District of Colorado, announced that on February 11, 1993 maximum sentences were imposed on Steven Sneed of Maryland, Herman Graulich of Florida, and Brent Gundersen of Utah following their September 22, 1992 jury convictions for participating in the manipulation and unregistered distribution of the stock of Monarch Acquisitions. Prosecution of this case began with a ten-count indictment on April 3, 1991 following a nearly two year undercover investigation into fraud and abuse in the penny stock market by the Colorado United States Attorneys Securities and Commodities Fraud Task Force. The indictment alleged, among other things, that the Stock of Monarch Acquisitions was manipulated through controlled, prearranged purchases and sales involving a shell corporation revived as a box job and sold to an undercover FBI agent. Charges in the ten-count indictment included criminal conspiracy, securities fraud, false brokerdealer books and records, mail fraud and wire fraud.

Sneed was sentenced to 33 months imprisonment, a \$15,000 fine, and three years supervised release; Graulich to 14 months imprisonment, a \$10,000 fine and three years supervised release; and Gundersen to 24 months imprisonment, a \$15,000 fine, and three years supervised release. These were the maximum sentences against each under the federal guidelines. [United States v. Steven Sneed, et al., Criminal Action No. 91-CR-122, U.S.D.C. Colorado] (LR-13535)

INDICTMENT CHARGES THERON MITCHELL WITH SECURITIES FRAUD, SALES OF UNREGISTERED SECURITIES AND INTERSTATE TRANSPORTATION OF STOLEN PROPERTY

The Securities and Exchange Commission and Charles H. Turner, United States Attorney for the District of Oregon, announced the filing of a thirteen-count indictment in the United States District Court for the District of Oregon, on February 10, 1993 against Theron D. Mitchell, formerly of Gold Hill, Oregon. The indictment charges Mitchell with Securities Fraud, Sale of Unregistered Securities, and Interstate Transportation of Stolen Property in connection with a scheme that obtained over \$3 million from the public through investments in beneficial interests in a gold recovery device, the hydroclaster, which Mitchell claimed to have invented. The indictment also alleges that Mitchell misrepresented the gold content of the ore that was to have been processed by the hydroclastor in an effort to attract investors and that he misled investors about his use of their money. [Unites States v. Theron D. Mitchell, No. CR. 93-39, U.S.D.C. Oregon] (LR-13532)
