ADMINISTRATIVE PROCEEDINGS

NASD ACTION AGAINST WILLIS BREWER, JR. AND SCOTT GRAY AFFIRMED

The Commission has affirmed sanctions imposed by the National Association of Securities Dealers, Inc. (NASD) on Willis H. Brewer, Jr. and Scott R. Gray. Brewer and Gray were salesmen for First Eagle, Inc., formerly an NASD member firm. The NASD censured Brewer and Gray, fined them \$5,000 each, suspended them from association with any member firm for one week and required them to requalify by examination as registered representatives upon completion of their suspensions.

The Commission found, as had the NASD, that Brewer and Gray effected transactions with customers at unfair prices. (Rel. 34-31964)

SETTLEMENT OFFER OF JAMES ROGERS ACCEPTED

The Commission announced the entry of an Order Instituting Public Administrative Proceedings, Making Findings and Imposing Remedial Sanctions against James Gordon Rogers (Rogers) and accepting Rogers' Offer of Settlement.

Rogers consented to the issuance of the Order without admitting or denying the Commission's findings, except for the underlying injunction, which was admitted. The Order contains findings that during the period from approximately March 1991 through November 1991, Rogers, as a registered representative at a broker-dealer registered with the Commission, obtained at least \$553,000 for investment in bonds from at least eleven investors. The Order also contains findings that Rogers made material, false and misleading statements and failed to disclose material facts to the eleven investors regarding, among other things, the use of their funds and the risks of the investments. By virtue of that conduct, Rogers willfully violated the antifraud provisions of the federal securities laws. In addition, the Order contains findings that on March 3, 1993 an Order of Permanent Injunction was entered by the United States District Court for the Southern District of Illinois which permanently enjoined Rogers from future violations of the same federal securities laws.

The Commission's Order bars Rogers from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. (Rel. 34-31965)

PROCEEDINGS INSTITUTED AGAINST MARK GREENWAY

The Commission has instituted public administrative proceedings against Mark S. Greenway (Greenway). The Order Instituting Proceedings alleges that from June 1987 to October 1990, while associated with a registered broker-dealer, Greenway violated the antifraud provisions of the federal securities laws by engaging in unauthorized, unsuitable, and excessive trading in his customers' accounts. The Order further alleges that Greenway made untrue statements of material facts and omitted to state material facts concerning, among other things, the profitability of customers' accounts and the risks relating to using margin in their accounts. Additionally, the Order alleges that Greenway placed or caused to be placed on documents signatures which purported to be, but were not, the signatures of his customers. The Order further alleges that Greenway aided and abetted the broker-dealer's violations of the books and records provisions of the federal securities laws by causing false information to be placed on the broker-dealer's records concerning, among other things, the investment risks customers were willing to assume.

NASD DISCIPLINARY ACTION AGAINST ADAMS SECURITIES, INC., JAMES ADAMS AND DANIEL PERRY SUSTAINED

The Commission has found that Adams Securities, Inc. of Las Vegas, Nevada, its chief executive officer, James W. Adams, and its president and trader, Daniel B. Perry, charged customers unfair markups in 131 sales of shares of Ivory Coast, Inc. The Commission further found that the markups, which ranged from 17 to 100 percent, were fraudulent. Applicants were each censured and fined \$79,541, jointly and severally, by the NASD. In addition, Adams and Perry were each separately fined \$15,000 and suspended for 30 days, and the firm was suspended from market making activities for 60 days.

The case focused on whether the firm's contemporaneous cost of acquiring Ivory shares was the appropriate basis for calculating its markups. Sustaining the finding of the NASD, the Commission determined that the firm, which did not buy and sell Ivory shares in the inter-dealer market, was not a market maker. The Commission reiterated that, where a firm is not a market maker, the best evidence of a security's current market price, absent countervailing evidence, is its contemporaneous costs.

In sustaining the sanctions imposed by the NASD, the Commission observed that "overcharging customers is a serious breach of a firm's obligation to deal fairly with investors." (Rel. 34-31971)

INVESTMENT COMPANY ACT RELEASES

ITT LIFE INSURANCE CORPORATION, ET AL.

A notice has been issued giving interested persons until April 9, 1993 to request a hearing on an application filed by ITT Life Insurance Corporation, ITT Life Insurance Corporation Separate Account One (Separate Account) and Hartford Equity Sales Company, Inc. The application is for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Separate Account under a deferred variable annuity contract. HOLDING COMPANY ACT RELEASES

MONONGAHELA POWER CO., ET AL.

A notice has been issued giving interested persons until April 5, 1993 to request a hearing on a proposal by the Monongahela Power Company, The Potomac Edison Company, and West Penn Power Company (collectively, Companies), all wholly owned publicutility subsidiary companies of Allegheny Power System, Inc., a registered holding company. The Companies propose to arrange for the issuance of three new series of pollution control revenue bonds (Refunding Bonds) in the aggregate principal amount of \$23.4 million. The Refunding Bonds will be used to refund outstanding pollution control revenue bonds previously issued on behalf of the Companies. (Rel. 35-25759)

NEW ORLEANS PUBLIC SERVICE INC.

A supplemental notice has been issued giving interested persons until April 5, 1993 to request a hearing on a proposal by New Orleans Public Service Inc. (NOPSI), a public-utility subsidiary company of Entergy Corporation, a registered holding company. NOPSI proposes to create one or more new classes of preferred stock with a par value other than \$100. (Rel. 35-25759)

THE COLUMBIA GAS SYSTEM, INC., ET AL.

A notice has been issued giving interested persons until April 5, 1993 to request a hearing on a proposal by The Columbia Gas System Inc., a registered holding company, and its wholly owned nonutility subsidiary company, The Inland Gas Company, Inc. (Inland), a Kentucky corporation, for Inland to engage in the marketing of natural gas and related activities. (Rel. 35-25759)

GEORGIA POWER COMPANY

A notice has been issued giving interested persons until April 5, 1993 to request a hearing on a proposal by Georgia Power Company (Georgia Power), an electric publicutility subsidiary company of The Southern Company, a registered holding company. Georgia Power proposes to sell to Sawnee Electric Membership Corporation, a nonassociate company, for an aggregate sales price of \$243,916.92 certain distribution facilities (Facilities) that were installed by Georgia Power to provide retail electric service to the Lakeland Plaza Shopping Center located in the northern portion of metropolitan Atlanta, Georgia. Georgia Power also proposes to sell to Sawnee Electric Membership Corporation for an aggregate sales price of \$243,916.92 certain easements in relation to the Facilities. (Rel. 35-25759)

OHIO VALLEY ELECTRIC CORPORATION

A notice has been issued giving interested persons until April 5, 1993 to request a hearing on a proposal by Ohio Valley Electric Corporation (OVEC), an electric utility subsidiary company of American Electric Power Company, Inc., a registered holding company.
