COMMISSION ANNOUNCEMENTS

WILLIAM MORLEY APPOINTED SENIOR ASSOCIATE DIRECTOR FOR OPERATIONS OF THE DIVISION OF CORPORATION FINANCE

On June 7, Acting Chairman Schapiro announced the appointment of William E. Morley as Senior Associate Director for Operations in the Division of Corporation Finance. Mr. Morley will be responsible for the Division's examination program. Mr. Morley succeeds Mary E.T. Beach who retired earlier in June. (Press Rel. 93-20)

SECOND ANNUAL MEETING OF THE COUNCIL OF SECURITIES REGULATORS OF THE AMERICAS

On June 3-4, the Council of Securities Regulators of the Americas (COSRA) held their Second Annual Meeting in Buenos Aires, Argentina. The meeting was chaired by Acting Chairman Mary L. Schapiro, who served as the 1992-93 Chairman of COSRA. Luis Miguel Moreno, Chairman of the Comision Nacional de Valores of Mexico, acted as Vice Chairman for the meeting. Participants included delegations from: Argentina, Brazil, Ontario and Quebec, Canada, Chile, Colombia, Costa Rica, Ecuador, Honduras, Mexico, Paraguay, Peru, the United States, and Uruguay. During the meeting, the membership jointly adopted principles in the areas of: secondary market transparency; audit trails; clearance and settlement; and surveillance of cross-border activities of investment advisers. The membership elected the U.S. Securities and Exchange Commission and the Comision Nacional de Valores of Argentina as the Chairman and Vice Chairman of COSRA, respectively, for 1993-94.

ADMINISTRATIVE PROCEEDINGS

ISSUANCE OF FINDINGS AND ORDERS IMPOSING REMEDIAL SANCTIONS

The Commission announced the issuance of Findings and Orders Imposing Remedial Sanctions by Default Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) on June 1 against Dierdre C. Steinhaus (Steinhaus), President of Revcon USA Limited (Revcon), a defunct broker-dealer, and Robert E. Ainbinder (Ainbinder), an undisclosed control person of Revcon.

The Commission issued findings that Ainbinder and Steinhaus violated the antifraud provisions of the federal securities laws by using a nominee account to purchase securities, at prices below the market, from certain Ainbinder accounts at anothe broker-dealer. Ainbinder had been told by that broker-dealer to liquidate those securities in order to cover debit balances totalling over \$420,000. Ainbinder and Steinhaus then sold those securities at the market, reaping substantial profits.

The Commission further found that Steinhaus aided and abetted Revcon's violations of the net capital, broker-dealer registration, and books and records provisions of the Securities Exchange Act of 1934. Finally, the Commission found that Ainbinder engaged in "free-riding" in two accounts at Revcon. (Rels. 34-32399, Robert E. Ainbinder; 34-32400, Dierdre C. Steinhaus)

HOLDING COMPANY ACT RELEASES

NORTHEAST UTILITIES

A notice has been issued giving interested persons until June 28 to request a hearing on a proposal by Northeast Utilities (NU), a registered holding company, and its subsidiary service company, Northeast Utilities Service Company, to acquire, issue and sell, from time to time prior to May 1, 2002 up to 15,000 shares of NU's common stock. NEW ENGLAND POWER COMPANY

A notice has been issued giving interested persons until June 28 to request a hearing on a proposal by New England Power Company (NEPCO), an electric public-utilit subsidiary company of New England Electric System, a registered holding company. NEPCO proposes to acquire and redeem at any time or from time to time through June 30, 1995 certain series of its cumulative preferred stock. (Rel. 35-25820)

MASSACHUSETTS ELECTRIC COMPANY

A notice has been issued giving interested persons until June 28 to request a hearing on a proposal by Massachusetts Electric Company (MEC), an electric public-utility subsidiary company of New England Electric System, a registered holding company. MEC proposes to acquire at any time or from time to time through December 31, 1994 all or a portion of certain series of its first mortgage bonds. (Rel. 35-25820)

ENTERGY CORPORATION, ET AL.

A notice has been issued giving interested persons until June 28 to request a hearing on a proposal by Entergy Corporation, a registered holding company, to guarantee the lease obligations of its wholly owned subsidiary company, Entergy Services, Inc., pursuant to the terms and conditions of the Amendment and Restatement of Lease entered into on April 1, 1993. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change (SR-MSE-93-12) filed by the Midwest Stock Exchange. The MSE proposes to extend its SuperMAX pilot program for an additional thirty day period. The SuperMAX program guarantees the execution price of small agency market orders received over the Midwest Automated Execution System (MAX) and automatically improves such orders from the consolidated best bid or offer according to certain pre-defined criteria. Publication of the proposal is expected in the Federal Register during the week of June 7. (Rel. 34-32407)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The Commission is soliciting comments on a proposed rule change filed by the <u>Chicago</u> <u>Board Options Exchange</u> (SR-CBOE-93-03), which became effective upon filing with the Commission, relating to a change in ceratin Exchange fees. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 7. (Rel. 34-32417)

A proposed rule change (SR-CBOE-92-32) filed by the <u>Chicago Board Options Exchange</u>, which makes certain nonsubstantive amendments to its rules relating to index options, became effective upon filing with the Commission. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 7. (Rel. 34-32418)
