# COMMISSION ANNOUNCEMENTS

#### CARREL APPLICATIONS NOW BEING ACCEPTED

Pursuant to the rules of the Public Reference Room, the July allocation of carrels and telephone privileges for recognized user organizations (information dissemination companies) is beginning. Application forms are available in the Public Reference Companies unable to pick up forms may submit written applications to Virginia Nabinett, Chief, Public Reference Branch, Securities and Exchange Commission, Room 1024, Stop 1-2, 450 Fifth Street, N.W., Washington, D.C. 20549. Applications must include the following: a brief description of the business, business address and telephone number, the name of a person who will serve as on-site contact, names of all persons who work everyday in the Room, number of employees assigned to research/sales of SEC filings, regardless of work location, and number of carrels requested. Applicants may also submit a supplemental statement in support of their request. Applications must be certified and signed by a company official, and submitted by close of business July 9, 1993. As in the past, assignment of carrels/telephone privileges is discretionary. Applicants should not assume they will receive the number of carrels for which they apply. The Commission intends to continue to reserve carrels for the general public.

Allocations will be effective July 26, 1993.

#### ADMINISTRATIVE PROCEEDINGS

#### NASD ACTION AGAINST ROBERT GIBBS AFFIRMED

The Commission has affirmed NASD disciplinary action against Robert E. Gibbs of Colorado Springs, Colorado. Gibbs was a registered representative of The Stuart-James Company, Inc., formerly a NASD member firm. The NASD censured Gibbs and fined him \$3,000. The Commission affirmed NASD findings that Gibbs engaged in unauthorized

securities trading in a customer's account. In affirming the NASD's sanctions, the Commission rejected several procedural arguments raised by Gibbs, including his claim that a member of the NASD's district committee hearing panel was biased against him. (Rel. 34-32401)

NASD ACTION AGAINST CENTURY CAPITAL CORP. OF SOUTH CAROLINA AND ITS PRESIDENT AFFIRMED

The Commission has affirmed NASD disciplinary action against Century Capital Corp. of South Carolina, a Greenville, South Carolina member firm, and John W. Brown, III, its president. The NASD censured the firm and Brown, fined them \$10,000, jointly and severally, ordered the firm to pay \$23,514 restitution to retail customers, suspended the firm for 30 days from effecting principal transactions with such customers except unsolicited liquidating transactions, and suspended Brown from association with any member for 30 days and the second supplied that the second supplied to the second suppli

The Commission found, as had the NASD, that from November 1988 through July 1989, the firm and Brown, who was responsible for the firm's pricing, charged retail customers excessive markups in the sale of six different securities. Noting that this was the second time in less than a year that it had affirmed NASD findings of unfair markups by the firm, and respondents' pattern of substantially overcharging the firm's customers, the Commission agreed with the NASD that the sanctions imposed were "relatively lenient." #### CIVIL PROCEEDINGS

CIVIL ACTION AGAINST INTERLINK DATA NETWORK OF LOS ANGELES, INC., ET AL.

On May 27, 1993, the Commission filed a complaint, alleging violations of the anti-fraud, securities registration, and broker-dealer registration provisions of the federal securities laws and seeking injunctive and emergency relief, including an asset freeze, in the U.S. District Court for the Central District of California. The complaint named as defendants InterLink Data Network of Los Angeles, Inc., InterLink Fiber Optic Partners L.P., InterLink Video Phone Partners L.P., and Michael Gartner. The Complaint alleged that defendants had defrauded over 450 investors, who invested more than \$10 million, by selling securities in a nonexistent fiber optic telecommunications network.

On May 27, 1993, after a hearing, the Court granted all the relief sought by the Commission, including a temporary restraining order, an asset freeze, and an order expediting pretrial discovery. On June 7, 1993, following a hearing, the Court entered a preliminary injunction consented to by the defendants. The Court also ordered that the assets of the defendants remain frozen, except for \$1,000 per week for living expenses of Gartner and his dependents. The Court also granted the Commission's request for a preclusion order, prohibiting the defendants from introducing evidence, based on their failure to produce documents or information in response to discovery requests made by the Commission. #### CRIMINAL PROCEEDINGS

# JIM D. SWINK, SR., AND JIM D. SWINK, JR. SENTENCED

The Commission and the United States Attorney for the Eastern District of Arkansas announced that on June 3, Jim D. Swink, Sr. (Swink), a principal of Swink & Co., Inc. (Swink & Co.), a broker-dealer registered with the Commission, was sentenced 21 months in prison, four years of supervised release, and a \$5,000 fine. Swink pled guilty on February 25, 1993 to charges that he caused Swink & Co. to fail to maintain accurate books and records by willfully causing trade tickets and month-end reports to be false and incorrect.

On March 11, 1993, Jim D. Swink, Jr. (Swink, Jr.), Swink's son and a trader for Swink & Co., was sentenced to 5 months in a halfway house, after which he will serve 11 months of home detention followed by three years of probation. Swink, Jr. was convicted in December 1992, by a jury on charges of perjury and conspiracy to make false statements to the Commission. [U.S.D.C., E.D./Ark., Western Division, C.A. # CHARTER NATIONAL LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until June 29 to request a hearing on an application filed by Charter National Life Insurance Company, Charter National Variable Annuity Account (Variable Account), and CNL, Inc. for an order under Section 6(c) of the Investment Company Act. The order would allow Applicants to deduct a mortality and expense risk charge from the assets of the Variable Account. (Rel. IC-19514 - June 4)

#### PROVIDENT MUTUAL LIFE INSURANCE COMPANY OF PHILADELPHIA, ET AL.

A notice has been issued giving interested persons until June 29 to request a hearing on an application filed by Provident Mutual Life Insurance Company of Philadelphia ("Provident Mutual"), Provident Mutual Variable Growth Separate Account, Provident Mutual Variable Bond Separate Account, Provident Mutual Variable Bond Separate Account, Provident Mutual Variable Managed Separate Account, Provident Mutual Variable Aggressive Growth Separate Account, Provident Mutual Variable International Separate Account, Provident Mutual Variable Zero Coupon Bond Separate Account, and PML Securities Company. This application is for an order under Section 6(c) of the Investment Company Act for exemptions from Section 27(c)(2) and Paragraph (c)(4)(v) of Rule 6e-3(T) under the Act. Applicants request relief to the extent necessary to permit them to deduct from premiums received under certain variable life insurance policies an amount that is reasonably related to Provident Mutual's increased tax burden resulting from the application of Section 848 of the Internal Revenue Code of 1986, as amended. PMI FUND, INC.

#### UNLISTED TRADING PRIVILEGES SOUGHT

# SELF-REGULATORY ORGANIZATIONS

# APPROVAL OF PROPOSED RULE CHANGES

The Commission has approved a proposed rule change (SR-NASD-92-50) submitted by the <u>National Association of Securities Dealers</u> that amends Part VI, Section 2 of Schedule D to the NASD By-Laws to reduce excess spread parameters for Nasdaq and Consolidated Quotation Service (CQS) securities. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 7. (Rel. 34-32419)

The Commission has approved a proposed rule change (SR-PHLX-92-21) filed by the Philadelphia Stock Exchange which adopts Options Floor Procedure Advice (OFPA) F-15, entitled "Minor Infractions of Position/Exercise Limits and Hedge Exemptions." OFPA F-15 establishes the following fine schedule for minor violations (%5 or less) of the Exchange's position and exercise limits: (i) \$500 for the first occurrence; (ii) \$1000 for the second occurence; (iii) \$2000 for the third occurrence; and (iv) a sanction discretionary with the PHLX's Business Conduct Committee (BCC) for subsequent infractions. In addition, OFPA F-15 exempts from the position and exercise limit aggregation count each option of a stock option position that is hedged by 100 shares of the underlying stock or securities convertible into the underlying stock. Failures to provide the PHLX with the requisite hedge exemption form, and to appropriately reduce option positions following a decrease in the stock position, are

also subject to fines and sanctions by the PHLX's BCC. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 7. (Rel. 34-32423)

A proposed rule change filed by the <u>Pacific Stock Exchange</u> to amend its equity Transaction Charges (SR-PSE-93-9) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act. Publication of the proposal is expected in the <u>Federal Register</u> suring the week of June 7. (Rel. 34-32429)

# ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-93-14) under Rule 19b-4 to amend its Floor Conduct and Safety Guidelines to establish a clearance procedure for Floor Clerical employees and to provide for the imposition of a \$1,000 fine on a member or member organization that fails to comply with the clerical personnel clearance procedures. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 7. (Rel. 34-32422)

The Commission granted accelerated approval to a proposed rule change submitted by the <u>American Stock Exchange</u> (SR-AMEX-93-20) filed under Rule 19b-4 to appoint additional Senior Floor Officials from among Exchange Officials who previously served as Floor Governors and who continue to spend a substantial part of their time on the floor of the Exchange. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 7. (Rel. 34-32428)

The Commission granted accelerated approval to a proposed rule change submitted by the <u>New York Stock Exchange</u> (SR-NYSE-93-24) for accelerated approval under Rules 19b-4 and 19d-1 relating to the addition of Rule 410B to the "List of Exchange Rule Violations and Fines Applicable Thereto Pursuant to Rule 476A" and amending the NYSE Minor Rule Violation Enforcement and Reporting Plan. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 7. (Rel. 34-32421)
