ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST HAZEL CANHAM d/b/a/CANHAM & CANHAM ASSOCIATES

The Commission instituted public administrative and cease and desist proceedings under the Investment Advisers Act against sole proprietor Hazel B. Canham d/b/a Canham & Canham Associates, a Coral Springs, Florida based investment adviser registered with the Commission. The Order alleges that Canham violated Sections 204, 205(a)(2), and 206(1), 206(2), and 206(4) of the Advisers Act, and Rules 204-1(b)(2), 204-2(a)(9), 204-2(a)(16), 204-2(e)(1), 204-2(e)(3), 204-3(a), and 206(4)-1(a)(5) thereunder. It is alleged that these violations occurred during various periods between at least March 15, 1990 and March 24, 1992, when Canham, among other things, distributed a composite performance record for which she could not produce documentation to support her advertised claims and which otherwise materially misstated her composite performance. She failed to utilize investment advisory contracts conforming to the requisites of the Advisers Act and failed to provide clients and prospective clients with either the Form ADV, Part II or any alternative written disclosure statement containing the information required by Form ADV, Part II. Canham failed to maintain and preserve accurate and current books and records for her investment advisory business and failed to annually amend her Form ADV as needed.

A hearing will be scheduled to determine whether the allegations against Canham are true and, if so, what, if any, remedial sanctions, including the entry of a cease and desist order and the assessment of an administrative money penalty, are appropriate. (Rel. IA-1375 - June 10)

CIVIL PROCEEDINGS

v. PREMIUM SALES CORP. AND KENNETH THENNEN

The Securities and Exchange Commission announced that on June 9 the Honorable Federico A. Moreno entered a temporary restraining order against Premium Sales Corp. (Premium Sales) and Kenneth Thennen (Thennen), an order freezing assets, an order appointing a receiver and an order prohibiting the destruction of records.

The Complaint alleges that Premium Sales has raised approximately \$515,000,000 through various limited partnerships based on misrepresentations by Thennen and Premium Sales that Premium Sales had a profitable, ongoing grocery diverting business that could make upwards of 60% annualized return on an investment. The Commission also alleges that a material amount of the transactions reported by Premium Sales as profitable diverting transactions were and are sham or overstated transactions and only

approximately \$89,000,000 is presently accounted for. Based on the above, the Commission alleges that Premium Sales and Thennen have violated Section 17(a) of the Securities Act of 1933, and Section 10(b) of the Securities Exchange Act, and Rules 10b-5, thereunder. A hearing on the Commission's motion for a preliminary injunction was set for June 11, 1993. [SEC v. Premium Sales Corp. and Kenneth Thennen, C.A. No. 93-1092-CIV-Moreno] (LR-13668)

PERMANENT INJUNCTION AGAINST MOTZFELDT FUNDING CORPORATION, BIRGIT MECHLENBURG A/K/A GITTE MECHLENBURG AND SAMUEL ABRAHAM

The Commission announced the filing of a Complaint against Motzfeldt Funding Corporation, Birgit Mechlenburg a/k/a/ Gitte Mechlenburg, and Samuel J. Abraham (together, the Defendants) charging them with violations of Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder.

The Complaint alleges that the Defendants fraudulently obtained approximately \$153,700 from at least nineteen investors through the sale of partnership interests in the Motzfeldt Investment Club. The Complaint alleges that the Defendants falsely represented to potential investors that investor funds would be invested in a "roll trade program" involving standby letters of credit, promissory bank notes, and promissory bank guarantees. Instead, the Defendants allegedly misappropriated the investors' funds and used them to pay Defendants' business and personal expenses. The Complaint seeks permanent injunctions, disgorgement of Defendants' unlawful gains, plus prejudgment interest, and civil penalties. [SEC v. Motzfeldt Funding Corporation, et al., C.A. No.3942, JES, U.S.D.C. S.D.N.Y] (LR-13669)

INVESTMENT COMPANY ACT RELEASES

FIRST INVESTORS CORPORATION, ET AL.

An order has been issued extending a temporary conditional order that exempted First Investors Corporation et al. from Section 9(a) of the Investment Company Act. The order extends the temporary order until the Commission takes final action on the application for a permanent order or, if earlier, December 12, 1993. (Rel. IC-19522 -June 10)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The <u>New York Stock Exchange</u> has filed a proposed rule change (SR-NYSE-93-20) under Rule 19b-4 of the Exchange Act to rescind NYSE Rules 391 (Special Offerings and Special Bids) and 392 (Exchange Distributions and Exchange Acquisitions) and to amend NYSE Rule 393.10 (Secondary Distributions) to delete any references to Rules 391 and 392. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 8. (Rel. 34-34233)

Pursuant to Rule 19b-4 under the Securities Exchange Act on March 9, 1993 the <u>New York</u> <u>Stock Exchange</u> filed with the Commission a proposed rule change (SR-NYSE-93-15) relating to the proposed listing and trading of options based on the New York Stock Exchange Utility Index. Publication of the notice is expected in the <u>Federal Register</u> during the week of June 8. (Rel. 34-32438)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted under Rule 19b-4 by the <u>New</u> <u>York Stock Exchange</u> (SR-NYSE-92-33) to add an Interpretation to Rule 345 (Employee Registration, Approval Records) allowing for the payment of compensation, under certain conditions, to nonregistered foreign persons and foreign entities acting as finders. (Rel. 34-32431)

TRUST INDENTURE ACT RELEASES

MULTIJURISDICTIONAL DISCLOSURE

On June 10 the Commission adopted amendments to two rules under the Trust Indenture Act, which would facilitate the Commission's proposed Multijurisdictional Disclosure System with Canada (MJDS).

The amendment to Trust Indenture Act Rule 10a-5 permits any person incorporated and regulated as a trust company under the laws of the province of British Columbia, who is authorized to exercise corporate trust powers and subject to federal supervision or examination under the laws of Canada, to act as sole trustee under indentures qualified or to be qualified under the Act in connection with offerings under the MJDS.

The amendment to Trust Indenture Act Rule 4d-9 exempts trust indentures of British Columbia obligors filing registration statements in the United States under MJDS from the operation of specified provisions of the Act. (Rels. 33-7002, 39-2313).
