ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDING INSTITUTED AGAINST WILLIAM DILLON

The Commission has issued an Order instituting public administrative proceedings (Order) pursuant to Sections 15(b)(6) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act) against William J. Dillon (Dillon), formerly associated with Merrill Lynch, Pierce, Fenner & Smith, Inc. (Merrill Lynch), a registered broker-dealer.

The Order alleges that, while associated with Merrill Lynch, Dillon purchased securities of approximately 129 companies while in possession of material, nonpublic information obtained from nonpublic editions of <u>Business Week</u> magazine that Dillon purchased from employees of a firm that prints the magazine. The Order further alleges that Dillon passed the nonpublic information to at least four other individuals who traded in the securities of companies while in possession of this material, nonpublic information.

The Order further alleges that Dillon was permanently enjoined by the U.S. District Court for the District of Connecticut from further violations of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder (SEC v. Dillon, et al., Docket No. 2:89cv00424, PCD, April 13, 1992). The Order also alleges that Dillon previously pled guilty to one count of wire fraud in each of two criminal actions brought in federal district court in Connecticut and New York City and that he served two concurrent six month terms of incarceration.

A hearing will be scheduled to determine whether the allegations against Dillon are true and, if so, to decide what remedial action is appropriate. (Rel. 34-32459)

CIVIL PROCEEDINGS

JERRY'S, INC. CONSENTS TO INJUNCTION

The Commission announced that on June 21 it filed a complaint in the U.S. District Court for the District of Columbia against Jerry's, Inc. (Jerry's), an airline caterer

of West Palm Beach, Florida. Simultaneous with the filing of the Commission's complaint, Jerry's filed a Consent to the entry of a Final Judgment of Permanent Injunction (Judgment). The Judgment would order Jerry's to file its delinquent annual and quarterly reports and would enjoin it from failing to file timely periodic reports and from violating Section 13(a) of the Securities Exchange Act of 1934 and Rules 12b-25, 13a-1 and 13a-13 thereunder in the future. Jerry's, in its Consent, admitted that it had failed to file its most recent annual report on form 10-K and two most recent quarterly reports on form 10-Q; had filed late four annual reports and eight quarterly reports; and had failed to file eleven notifications of late filing. INVESTMENT COMPANY ACT RELEASES

MASSACHUSETTS INVESTORS TRUST, ET AL.

A notice has been issued giving interested persons until July 13, 1993 to request a hearing on an application filed by Massachusetts Investors Trust, et al. for a conditional order under Section 6(c) of the Investment Company Act. Applicants seek an exemption from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), 22(d) of the Act and Rule 22c-1 thereunder. The conditional order would permit certain investment companies (Funds) to issue multiple classes of shares representing interests in the same portfolio of securities, and permit the Funds to assess and, under certain circumstances, waive, defer or reduce a contingent deferred sales charge on certain redemptions of their shares. SELF-REGULATORY ORGANIZATIONS

APPLICATION FOR EXEMPTION FROM REGISTRATION AS A CLEARING AGENCY

The <u>Clearing Corporation for Options and Securities</u> filed an application for an exemption from registration as a clearing agency under Section 17A of the Securities Exchange Act. Publication of the notice is expected in the <u>Federal Register</u> during the week of June 21. (Rel. 34-32481)
