CIVIL PROCEEDINGS

SEATTLE AREA INVESTMENT COUNSELOR ENJOINED FOR FRAUD

The Commission announced that on May 28, 1993 the Honorable Carolyn R. Dimmick, U.S. District Court Judge for the Western District of Washington, at Seattle entered a Final Order of Permanent Injunction against Gary V. Ingram enjoining him from future violations of the antifraud provisions found at Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. Ingram consented to the injunction without admitting or denying the violations.

The Commission's complaint alleged that Ingram defrauded a Seattle area couple and a Portland, Oregon investor of more than \$1.3 million in connection with financial management and investment consulting services which he ostensibly was providing to them. After gaining their trust in his professional services, Ingram fraudulently sold their securities, wrongfully converted the proceeds to himself, and then concealed from the investors the fact that the majority of their securities had been disposed of.

The investigation was conducted jointly with the U.S. Attorney's Office and the Pension and Welfare Benefits Administration of the Department of Labor, with assistance from the Federal Bureau of Investigation. [SEC v. Gary V. Ingram, Civil Action No. C93-0732, W.D. Wash.] (LR-13680)

INVESTMENT COMPANY ACT RELEASES

FFB FUNDS TRUST, ET AL.

A notice has been issued giving interested persons until July 19, 1993 to request a hearing on an application filed by FFB Funds Trust, et al. for an amended, conditional order under Section 6(c) of the Investment Company Act exempting applicants from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), 22(c), and 22(d) and Rule 22c-1 thereunder. The amended order would permit certain open-end management investment companies to issue up to three classes of shares representing interests in the same portfolio of securities, and assess and, under certain circumstances, waive a contingent deferred sales load on certain redemptions of shares. NEWTON GROWTH FUND, INC.

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-93-29) to amend Section 5(e) of Appendix F to Article III, Section 34 of the Rules of Fair Practice to Increase from \$50 to \$100 per year the aggregate value of non-cash sales incentive items allowed to be paid by a sponsor or affiliate of a sponsor of direct participation programs (DPPs) or Rollups of DPPs to any person associated with an NASD member. (Rel. 34-32497)

PROPOSED RULE CHANGES

The New York Stock Exchange filed a proposed rule change (SR-NYSE-93-25) that would amend its Floor Conduct and Safety Guidelines (Guidelines) to, among other things, impose a fine ranging from \$250 to \$1,000 for behavior prohibited by the General Conduct section of the Guidelines. The proposed rule change also adds indecorous behavior to the Guidelines and provides that the Exchange may conduct an investigation and formal disciplinary proceeding for substantial violations of the General Conduct section of the Guidelines. Publication of the proposal is expected in the Federal Register during the week of June 28. (Rel. 34-32498)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-93-19) to enhance the message disseminated by the Exchange for certain trading halts. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 28. (Rel. 34-32499)

TRUST INDENTURE ACT RELEASES

The Commission has issued an order under Section 304(d) of the Trust Indenture Act on an application filed by Kearny Street Real Estate Company, L.P. (Company) with respect to an indenture (Indenture) between the Company and State Street Bank and Trust Company as trustee, conditionally exempting specified provisions of the Indenture from the requirements of Section 314(d) of the Trust Indenture Act of 1939.
