HOLDING COMPANY ACT RELEASES

CONNECTICUT LIGHT AND POWER COMPANY

A supplemental notice has been issued giving interested persons until September 13 to request a hearing on a proposal by The Connecticut Light and Power Company (CL&P) and Western Massachusetts Electric Company (WMECO), both wholly-owned electric utility subsidiaries of Northeast Utilities, a registered holding company. The applicants propose that the Connecticut Development Authority (CDA) issue pollution control revenue refunding bonds in aggregate principal amounts of not more than \$315,516,500 on behalf of CL&P and \$53,853,500 on behalf of WMECO and lend the proceeds thereof to the applicants. The proceeds will be used by the applicants to refund certain pollution control revenue bonds that were previously issued by the CDA. (Rel. 35-25870)

GENERAL PUBLIC UTILITIES CORPORATION

A notice has been issued giving interested persons until September 13 to request a hearing on a proposal by General Public Utilities Corporation (GPU), a registered holding company. GPU proposes to issue and sell for cash from time to time through December 31, 1996 up to four million additional shares of its common stock (\$2.50 par). (Rel. 35-25870

OHIO POWER COMPANY

A notice has been issued giving interested persons until September 13 to request a hearing on a proposal by Ohio Power company, an electric public utility subsidiary of American Electric Power Company, Inc., a registered holding company, to effect by June 30, 1994 the refunding of up to \$50 million of pollution control revenue bonds issued in connection with the financing of pollution control facilities. SELF-REGULATORY ORGANIZATIONS

NATIONAL MARKET SYSTEM JOINT INDUSTRY PLANS

The Options Price Reporting Authority (OPRA) has filed with the Commission, pursuant to Rule 11Aa3-2 under the Securities Exchange Act an amendment to the Plan for the Reporting of Consolidated Options Last Sale Reports and Quotation Information. The purpose of the amendment is to extend until November 1, 1994, the pilot program that provides for the dissemination of certain implied volatility quotations in foreign currency options directly by the Philadelphia Stock Exchange through selected vendors, rather than through the OPRA network. Publication of the release in the Federal Register is expected during the week of August 27. (Rel. 34-32771)

APPROVAL OF PROPOSED RULE CHANGES

The Commission has approved a proposed rule change filed by <u>The Depository Trust Company</u> (SR-DTC-92-09) establishing procedures to facilitate the liquidation of securities held for a participating bank and broker experiencing financial or operational difficulties. The procedures will be known as the "honest broker" program. Publication of the proposal in the <u>Federal Register</u> is expected to be made during the week of August 23. (Rel. 34-32759)

The Commission has approved a proposed rule change filed by the <u>National Securities</u> <u>Clearing Corporation</u> (SR-NSCC-92-12) that gives open short positions in NSCC's Continuous Net Settlement System settlement priority over other short positions in the Depository Trust Company's honest broker program. Publication of the proposal in the <u>Federal Register</u> is expected to be made during the week of August 23. (Rel 34-32760)

PROPOSED RULE CHANGE EFFECTIVE

A proposed rule change was filed under Rule 19b-4 by the <u>International Securities Clearing Corporation</u> (SR-ISCC-93-03) that revises ISCC's fees for receipt of transactions on behalf of multiple members. The rule change has become effective on filing pursuant to Section 19(b)(3)(A) of the Securities Exchange Act. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 30. (Rel. 34-32746 and IS-574)

PROPOSED RULE CHANGE

A proposed rule change was filed by the National Association of Securities Dealers (SR-NASD-93-40) under Rule 19b relating to Part IX of Schedule D to the NASD By-Laws Regarding Rules and Procedures of the NASD Local Quotations Program. Publication of the order in the <u>Federal Register</u> was expected during the week of August 16. (Rel. 34-32764)
