PUBLICATION OF REGULATORY FLEXIBILITY ACT RULE REVIEW SCHEDULE

The Commission has authorized publication in the <u>Federal Register</u> of a list of rules scheduled for review pursuant to the Regulatory Flexibility Act. The list provides the public with notice that these rules are scheduled for review by the agency and the public is invited to comment on them. Public comments are due by January 31, 1994. (Rel. ELIMINATION OF FILING REQUIREMENTS FOR PRELIMINARY PROXY MATERIALS UNDER CERTAIN CIRCUMSTANCES

Today, the Commission adopted amendments to the proxy and information statement filing requirements under Rules 14a-6 and 14c-5. Under the amendments, the requirement to file a proxy statement in preliminary form is not triggered by shareholder action on new compensation plans or amendments to existing plans. ENFORCEMENT ACTIONS

MERRILL LYNCH, PIERCE, FENNER & SMITH INC., FREDERICK ROEMER AND ROBERT PLUNKETT SANCTIONED

The Commission has issued an Order Instituting Proceedings Pursuant to Sections 15(b) and 21C of the Securities Exchange Act of 1934, Accepting Offers of Settlement, Making Findings, Imposing Remedial Sanctions and Ordering Respondents to Cease and Desist against Merrill Lynch, Pierce, Fenner & Smith Inc., Frederick J. Roemer and Robert J. Plunkett. Simultaneously, the Commission accepted Offers of Settlement, whereby, each Respondent consented to the Order, without admitting or denying the findings contained therein.

On the basis of the Order and the Offers of Settlement, the Commission found that Merrill Lynch willfully violated Section 17(a) of the Securities Exchange Act of 1934 and Rule 17a-3 thereunder based on the firm's failure to record properly on its books and records certain securities transactions in two separate matters. In connection with one of those matters, the Commission also found that Roemer and Plunkett willfully aided and abetted and caused Merrill Lynch's violations.

Pursuant to the Order and the Offers of Settlement, Merrill Lynch was required to adopt and implement certain procedures. In addition, each Respondent was censured and ordered to cease and desist. (Rel. 34-33367)

SUNACO ENERGY, INC., AND PROMOTERS ENJOINED IN LIMITED PARTNERSHIP SCHEME

The Commission announced that on December 1 Final Judgments by consent were ordered against defendants Sunaco Energy, Inc. (Sunaco), Jerry W. Reeves (Reeves), Donald L. Hawes (Hawes) and John C. Worman (Worman) permanently enjoining them from future violations or aiding and abetting violations of the registration, antifraud, and broker-dealer provisions of the federal securities laws. Disgorgement orders were also entered against Reeves, Hawes and Worman, however, payment was waived based on their demonstrated financial inability to pay.

The Commission's complaint, filed August 20, 1992, alleged that the defendants raised approximately \$3 million from 240 investors residing in 28 states during a nationwide "cold call" campaign to sell interests in five unregistered limited partnerships. The complaint further alleged that the defendants either misrepresented or failed to state material facts concerning, among other things, the true financial condition of the corporations serving as general partners, the identity of certain of the defendants as control persons of the general partners, the rate and amount of return on the investments, the likelihood of the success of the ventures, the commingling of investor funds, and the use of investor funds to pay commissions and excessive salaries to the defendants. "BOILER ROOM" OPERATORS ENJOINED

The Commission announced that Final Judgments were entered by consent on November 12, 1993 against defendants David M. Beckham, James L. Cox, Leon W. Snearly, Alfred E. Bremers, American Royalty Corporation, Tekna Synergy Corporation, and Investamerica Financial Services Corporation (Investamerica). All the defendants are permanently enjoined from future violations of the antifraud provisions of the federal securities laws, and all of the defendants except Investamerica are additionally enjoined from future violations of the securities registration provisions. The Court ordered disgorgement for each defendant, however, payment was waived based on the defendants' demonstrated financial inability to pay.

The Commission's complaint, filed February 5, 1993, alleged that the defendants engaged in "boiler room" sales of oil and gas investments raising more than \$10 million from at least 200 investors in 15 states. The complaint further alleged the defendants used false and misleading offering documents which misrepresented, among other things, the use of investor funds, the financial condition of the companies issuing the securities, the expected returns and risks associated with the offering and the experience and background of the individual defendants. INVESTMENT COMPANY ACT RELEASES

SUNAMERICA MULTI-ASSET PORTFOLIOS, INC.

A notice has been issued giving interested persons until January 18, 1994 to request a hearing on an application filed by SunAmerica Multi-Asset Portfolios, Inc. for an order under Section 8(f) of Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-19970 - December 21)

PIONEER FUND, ET AL.

An order has been issued on an application filed by Pioneer Fund, et al. under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to issue multiple classes of shares representing interests in the same portfolio of securities, and to assess and, under certain circumstances, waive a contingent deferred sales charge (CDSC) on certain redemptions of the shares. The requested order supersedes a prior order that permits applicants to assess and, under certain circumstances, waive a CDSC on certain redemptions of the shares. (Rel. IC-19971 - December 21)

CO-OPERATIVE BANK INVESTMENT FUND

An order has been issued on an application filed by Co-operative Bank Investment Fund under Section 6(c) of the Investment Company Act for an exemption from Sections 13(a), 15(a), 16(a) and (b), 18(i), 22(d), and 32(a)(2) and (3) of the Act. The order amends applicant's existing order by permitting applicant to offer its securities to the Savings Bank Life Insurance Company of Massachusetts. (Rel. IC-19972 - December 21)

Orders have been issued under Section 8(f) of the Investment Company Act declaring that the above-named companies have ceased to be investment companies. (Rel. IC-19973; IC-19974; IC-19975; IC-19976, respectively - December 21)

AEGON NV, ET AL.

An order has been issued on an application filed by AEGON NV, et al. under Section 6(c) of the Investment Company Act granting relief from Sections 2(a)(13) and 6(b) to permit the AEGON USA Producers' Stock Purchase Plan (Plan) to be treated as an employees' security company, and pursuant to Section 6(b) exempting the Plan from all provisions of the Act and rules and regulations thereunder other than Sections 7, 8(a), 9 (except as provided in the application), 17 (except as provided in the application), 21, 30(a) (to the extent that it requires distribution of audited annual reports), and 33 through 53, and the rules thereunder. (Rel. IC-19977 - December 21)

STONE STREET FUND 1984, ET AL.

A conditional order has been issued on an application filed by Stone Street Fund 1984, et al. under Sections 6(b) and 6(e) granting relief from all of the provisions of the Act except Sections 9, 17 (except for certain provisions of Sections 17(a), (d), (f), and (g) as described in the application), 30 (except for certain provisions of Sections 30(a), (b), and (d) as described in the application), and 36-53, and the rules and regulations thereunder. The requested order supersedes a prior order that exempted applicants from most of the provisions of the Act and the regulations thereunder. (Rel. IC-19978 - December 21)

MFS HIGH YIELD MUNICIPAL BOND FUND

An order has been issued under Section 8(f) of the Investment Company declaring that MFS High Yield Municipal Bond Fund has ceased to be an investment company. (Rel. IC-19979 - December 21)

HOLDING COMPANY ACT RELEASES

EASTERN EDISON COMPANY. ET AL.

An order has been issued authorizing a proposal by Eastern Edison Company, Blackstone Valley Electric Company, Newport Electric Corporation, EUA Service Corporation, EUA Ocean State Corporation, and Montaup Electric Company, all subsidiary companies of Eastern Utilities Associates, a registered holding company, to issue and sell short-term notes to banks through December 31, 1995. (Rel. 35-25956)

AMERICAN ELECTRIC POWER COMPANY, INC., ET AL.

An order has been issued authorizing a proposal by American Electric Power Company, Inc. (AEP), a registered holding company, and its subsidiaries, AEP Generating Company (Generating), Appalachian Power Company (Appalachian), Columbus Southern Power Company (Columbus), Indiana Michigan Power Company (Indiana Michigan), Kanawha Valley Power Company (Kanawha), Kentucky Power Company (Kentucky Power), Kingsport Power Company (Kingsport), Ohio Power Company (Ohio Power) and Wheeling Power Company (Wheeling). During the period beginning January 1, 1994 and ending December 31, 1995: Appalachian, Columbus, Indiana Michigan, Kentucky Power and Ohio Power propose to issue, sell and renew short-term notes to banks and commercial paper to dealers (under an exception from competitive bidding) in aggregate principal amounts not to exceed \$150 million, \$250 million, \$200 million, \$200 million, \$100 million and \$250 million, respectively, outstanding at any one time; Generating, Kanawha, Kingsport and Wheeling propose to issue, sell and renew short-term notes to banks in aggregate principal amounts not to exceed \$50 million, \$10 million, \$20 million and \$20 million. respectively, outstanding at any one time; and AEP proposes to make certain capital contributions to its subsidiaries. NEW ENGLAND ENERGY INCORPORATED

A supplemental order has been issued authorizing a proposal by New England Energy Incorporated (NEEI), an electric public-utility subsidiary company of New England Electric System (NEES), a registered holding company. NEEI proposes to invest up to \$10 million, through December 31, 1994, in its partnership (Partnership) with Samedan Oil Corporation, an unaffiliated company, for developing existing oil and gas prospects belonging to the Partnership. In addition, NEEI requests a reservation of jurisdiction over an additional \$5 million in Partnership contributions. (Rel. 35-25958)

CSW CREDIT, INC., ET AL.

A supplemental order has been issued authorizing a proposal by CSW Credit, Inc. (CSW Credit), a non-utility subsidiary of Central and South West Corporation, a registered holding company. CSW Credit proposes to extend, through December 31, 1994, its existing authorization to borrow funds and for CSW to make equity investments in CSW Credit to finance the factoring of receivables of associate and non-affiliated electric utility companies. MONONGAHELA POWER COMPANY, ET AL.

An order has been issued authorizing a proposal by Monongahela Power Company (Monongahela), The Potomac Edison Company (Potomac Edison) and West Penn Power Company (West Penn) (collectively, Declarants), each an electric public-utility subsidiary company of Allegheny Power System, Inc., a registered holding company. Declarants propose to enter into a \$300 million Competitive Advance and Revolving Credit Facility Agreement (Agreement) for borrowings thereunder through December 31, 1997. In addition, Declarants propose to secure the Agreement with their respective shares of stock in Allegheny Generating Company, an electric utility subsidiary company jointly owned by Declarants. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-93-71), which became effective immediately, to provide notice of the adjustment of the credit against gross income assessments of NASD member firms from 62% to 67%. Publication of the order is expected in the <u>Federal Register</u> during the week of December 27. (Rel. 34-33363)

The <u>Midwest Clearing Corporation</u> filed a proposed rule change (SR-MCC-93-05), which became effective immediately. The rule change provides for the automated transfer of mutual fund assets in the form of eligible book-entry shares. (Rel. 34-33366)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the <u>Midwest Stock Exchange</u> (SR-MSE-93-15) relating to Amendments to Exchange rules regarding the authority of the Exchange's Floor Procedure Committee and the composition and authority of its subcommittees. (Rel. 34-33364)

PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-93-14) relating to a clarification of DTC Rule 5. Publication of the proposal is expected in the <u>Federal Register</u> during the week of December 27. (Rel. 34-33365)

APPROVAL OF PROPOSED RULE CHANGE AND ACCELERATED APPROVAL OF AMENDMENT TO PROPOSED RULE CHANGE

The Commission granted approval to a proposed rule change (SR-NYSE-93-44) and granted accelerated approval of Amendment No. 1 to the proposed rule change filed by the New York Stock Exchange relating to European Portfolio Market Index Target-Term Securities. Publication of the notice and approval order is expected in the Federal Register during the week of December 27. (Rel. 34-33368; International Series Rel. 624)
