TEMPORARY RULE 13f-2(T) AND FORM 13F-E ADOPTED

The Commission adopted temporary Rule 13f-2(T) and Form 13F-E under the Securities Exchange Act of 1934 to enable institutional investment managers to file Form 13F reports through Edgar, the Commission's electronic disclosure system, beginning in July 1987. (Rel. 34-24206)

# ADMINISTRATIVE PROCEEDINGS

#### PROCEEDINGS INSTITUTED AGAINST BARRY GRAISON

The Commission ordered public administrative under the Securities Exchange Act of 1934 against Barry Graison. The Order Instituting Proceedings alleges that on June 4, 1985 Graison was convicted, after a jury trial, of (1) conspiracy to defraud the United States (one count) and (2) making, uttering, and possessing a forged government security (one count). The Order further alleges that Graison committed the criminal acts which formed the basis of his convictions while employed as a registered representative by a registered broker-dealer. A hearing will be scheduled to deterine whether the allegations against Graison are true, and if so, to decide what, if any, remedial action is appropriate. (Rel. 34-24160)

## NASD ACTION AGAINST ALLEN G. DARTT AFFIRMED

The Commission affirmed sanctions imposed by the NASD on Allen George Dartt, of Huntington, New York, who was associated with a former NASD member firm. The NASD censured Dartt, fined him \$5,000, and required him to attend a staff interview dealing with the suitability of recommendations to customers.

The Commission found, as had the NASD, that Dartt made unsuitable recommendations to Miss A, 1 75 year-old woman with limited assets and income, and engaged in excessive trading inher account. In little more than a year, October 1979 to November 1980, Dartt converted Miss A's diversified, income-producing \$250,000 portfolio into one in which half of her holdings consisted of one speculative security that did not pay dividends. Moreover, during the same period, Dartt, who controlled Miss A's account, effected more than 100 transactions for Miss A in an amount totaling more than \$2 million, generating more than \$55,000 in commissions and profits for Dartt and his firm. ## **INVESTMENT COMPANY ACT RELEASES**

#### TRAMSAMERICA LIFE INSURANCE AND ANNUITY COMPANY

A notice has been issued giving interested persons until April 3 to request a hearing on an application filed by Transamerica Life Insurance and Annuity Company, et al., for an order exempting them from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act. Applicants seek an order to permit them to issue variable annuity contracts that provide for the deduction of mortality and expense risk charges from net asset value. (Rel. IC-15613 - March 9)

## PRUDENTIAL-BACHE HIGH YIELD FUND, INC.

A notice has been issued giving interested persons until April 2 to request a hearing on an application by Prudential-Bache High Yield Fund, Inc. (Fund) and Prudential-Bache Securities Inc. for an order granting retroactive exemptive relief under the Investment Company Act in connection with the over-issuance of Fund shares. (Rel. IC-156:4 - March 10)

A notice has been issued giving interested persons until April 3 to request a hearing on an application filed by The First Trust of Insured Municipal Bonds, The First Trust Combined Series, The First Trust GNMA (Funds), and Clayton Brown & Associates, Inc. (collectively with the Funds, Applicants) for an order exempting Applicants from Section 22(c) of the Investment Company Act and Rule 22c-1. The exemption will permit Applicants to sell units of beneficial ownership of the Funds on the date of deposit of the Funds at a price based upon net asset value determined with reference to the value of the securities deposited therein on the business day preceding the date of deposit. ## **HOLDING COMPANY ACT RELEASES**

#### NEW ENGLAND ELECTRIC SYSTEM

Notices have been issued giving interested persons until March 30 to request a hearing on a proposal by the following companies filed under Release 35-24334, dated March 5: New England Electric System (NEES) - a registered holding company, and its subsidiaries, Granite State Electric Company, Massachusetts Electric Company (Mass Electric), The Narragansett Electric Company, NEES Energy, Incorporated, New England Electric Transmission Corporation (NEET), New England Energy Incorporated (NEEI), New England Power Company (NEP), and New England Power Service Company (NEPSCO), (collectively, Subsidiaries). NEES and the Subsidiaries seeks authorization to lend money to the NEES system money pool (Money Pool) under the terms approved by the Commission in its order dated November 5, 1986 (Rel. 35-24232). In addition, each of the Subsidiaries, with the exception of NEES Energy and NEEI, seeks authority to borrow from the Money Pool and/or to issue short-term notes to banks, such notes to mature in less than one year, through October 31, 1988. Mass Electric and NEP also propose to issue short-term commercial paper in the form of unsecured promissory notes having maturities of not in excess of 270 days, under an exception from competitive bidding, through October 31, 1988. Borrowings by the Subsidiaries are proposed to be up to the following maximum amounts outstanding: Granite State, \$7 million; Mass Electric, \$75 million; Narragansett, \$40 million; NEET, \$10 million; NEP, \$300 million; and NEPSCO, \$8 million.
