U.S. SECURITIES AND EXCHANCE COMMISSION

CIVIL PROCEEDINGS

PERMANENT INJUNCTIONS ENTERED AGAINST GALLAGHER & CO. AND PRINCIPALS

The Boston Regional Office announced that on March 17 the U.S. District Court for the District of Connecticut entered a Final Judgment of Permanent Injunction against Gallagher & Co., Russell K. Gallagher, and Laura K. Gallagher of West Palm Beach, Florida. The Judgment enjoins the Gallaghers from further violations of the antifraud provisions of the securities laws. The Gallaghers consented to the Injunction without admitting or denying the allegations of the complaint.

The March 14 complaint alleges, among other things, that Gallagher & Co., a registered broker-dealer of which R. Gallagher and L. Gallagher are the principals, participated in the fraudulent closing of a best efforts, "mini-maxi", securities offering of The Electronics Warehouse, Inc. by substituting lenders for bona fide purchasers to make it appear that the minimum amount had been raised. The remaining defendants include the Gallaghers' counsel, William A. Calvo, III, of Fort Lauderdale, Florida. (SEC v. The Electronics Warehouse, Inc., et al., D CT 1986, Civil Action No. H86-282, PCD). (LR-11372)

INJUNCTIVE ACTION FILED AGAINST PAUL T. VAN WINKLE AND PAUL E. SHERROD

The Denver Regional Office filed a complaint on March 13 in the U.S. District Court for the District of Colorado seeking permanent injunctions against Paul T. Van Winkle and Paul E. Sherrod, both of Denver, Colorado.

The complaint, among other things, alleges that Van Winkle and Sherrod violated the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934 by causing Time Technology, Inc., a Colorado corporation headquartered in Grand Rapids, Michigan, to file a false and misleading registration statement with the Denver Regional Office for the initial public offering of the company's stock, and a false and misleading quarterly report on Form 10-Q for the quarter ended May 31, 1985. Simultaneous with the filing of the complaint, a consent to a permanent injunction by Van Winkle, without admitting or denying the allegations of the complaint, was submitted for the court's consideration. (SEC v. Paul T. Van Winkle and Paul E. Sherrod, USDC CO, Civil Action No. 87-F-378). (LR-11373)

INVESTMENT COMPANY ACT RELEASES

BEAR STEARNS SECURED INVESTORS INC.

A notice has been issued giving interested persons until April 10 to request a hearing on an application filed by Bear Stearns Secured Investors Inc. (Applicant), requesting an order exempting Applicant and certain trusts created by Applicant from all provisions of the Investment Company Act in connection with their issuance of mortgagebacked securities. DELAWARE TAX-FREE MONEY FUND, INC.

A notice has been issued giving interested persons until April 9 to request a hearing on an application of several investment companies within the Delaware Fund Group for an order permitting the issuance and sale of separate classes of shares representing interests in existing and future investment portfolios, and the allocation of certain expenses and voting privileges associated with such classes. HOLDING COMPANY ACT RELEASES

OHIO POWER COMPANY; MONONGAHELA POWER COMPANY

Notices have been issued giving interested persons until April 6 to request a hearing on a proposal by the following companies filed under Release 35-24340, dated March 12: <u>Ohio Power Company</u> - subsidiary of American Electric Power Company, Inc., and its coal-mining subsidiaries. By order dated June 6, 1986 (Rel. 35-24120), the Subsidiaries were authorized to lease mining equipment with an aggregate acquisition cost not exceeding \$16.5 million from a nonassociated company and Ohio Power was authorized to guarantee the payments of one of the Subsidiaries. Ohio Power and the Subsidiaries now propose a total aggregate acquisition cost not exceeding \$25 million; and <u>Monongahela Power Company</u>. The Potomac Edison Company, and West Penn Power Company, subsidiaries of Allegheny Power System, Inc., to issue and sell first mortgage bonds from time to time through December 31, 1987 in maximum principal amounts of up to \$115 million, \$110 million, and \$35 million, respectively.

PHILADELPHIA ELECTRIC COMPANY

An order has been issued under the Trust Indenture Act of 1939 on an application by Philadelphia Electric Company that the trusteeship of Fidelity Bank, National Association under an indenture dated May 1, 1923, as amended, and supplemented by 61 supplemental indentures, and indentures dated February 1977, February 1977, and May 1985, as amended, under which pollution control revenue bonds have been issued, is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disgualify the Bank from acting as trustee under any of these indentures.
