CIVIL PROCEEDINGS

DISGORGEMENT ORDERED FROM THE HERITAGE COMPANY AND ALVIN R. BROERMAN

The Chicago Regional Office announced that on February 26 and April 7, respectively, Judge John F. Grady, Northern District of Illinois, Eastern Division, entered a Final Judgment of Permanent Injunction and Other Equitable Relief against The Heritage Company and a Final Order of Equitable Relief against Alvin R. Broerman. The Orders direct Heritage and Broerman to disgorge certain funds and assets. Funds and the proceeds of assets disgorged by the defendants are to be distributed, under a future plan of distribution, to individuals who purchased securities by Heritage, Broerman, and others.

The complaint and an accompanying Motion for a Temporary Restraining Order, filed on May 27, 1986, allege that from about July 1985 to about May 1986, Heritage, Broerman, and others offered and sold unregistered securities in the form of partnership interests in oil and gas wells to approximately 600 investors nationwide, thereby raising about \$4.5 million. The complaint further alleges that the defendants made material misrepresentations and omissions to investors concerning, among other things, returns to be expected, risks associated with the investment, and the existence of escrow accounts. (SEC v. Alvin R. Broerman, et al., Civil Action No. 86 C 3725, filed May 27, 1986). (LR-11399)

INVESTMENT COMPANY ACT RELEASES

CALIFORNIA TAX-FREE MONEY FUND

A notice has been issued giving interested persons until May 5 to request a hearing on an application filed by California Tax-Free Money Fund for an order declaring that it has ceased to be an investment company. (Rel. IC-15677 - April 10)

BEAR STEARNS SECURED INVESTORS INC.

An order has been issued exempting Bear Stearns Secured Investors Inc. and certain trusts created by it from all provisions of the Investment Company Act in connection with the issuance of mortgage-backed securities. (Rel. IC-15678 - April 13)

FSA CAPITAL, INC.

A notice has been issued giving interested persons until May 8 to request a hearing on an application filed by FSA Capital, Inc. for an order amending an existing order exempting it from all provisions of the Investment Company Act to permit the issuance of mortgage-backed securities having adjustable interest rates, the election of REMIC status, and the sale of residual interests. HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM

A supplemental order has been issued regarding a proposal by New England Electric System, a registered holding company, and its subsidiaries, Granite State Electric Company, Massachusetts Electric Company, The Narragansett Electric Company, NEES Energy, Inc., New England Transmission Corporation (NEET), New England Energy, Inc., New England Power Company, and New England Power Service Company, in pertinent part, to lend money to the NEES system money pool, to borrow from the Money Pool and/or to issue short-term notes to banks, and to issue and sell short-term commercial paper following an exception from competitive bidding.

The supplemental order clarifies and corrects the amount of additional short-term borrowing requested by and authorized for Narragansett and for NEET. (Rel.\35-24359A - April 2)

GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing General Public Utilities Corporation (GPU), a Pennsylvania corporation and a registered holding company, to amend its by-laws to adopt a limitation on directors' liability for money damages, as permitted by Pennsylvania law, to broaden the indemnification of GPU's officers, directors and employees, and to expand the means by which GPU can satisfy indemnification obligations. GPU is authorized to solicit proxies from its common stockholders for approval of the amendments at the annual meeting to be held May 7, 1987. (Rel. 35-24361 - April 2)

CONSOLIDATED NATURAL GAS COMPANY

An order has been issued authorizing Consolidated Natural Gas Company, a registered holding company, to amend it certificate of incorporation to limit the liability of its directors for money damages as permitted by Delaware law. An order was issued on March 5, 1987 authorizing the solicitation of proxies in connection with this transaction from shareholders at the annual meeting to be held May 14, 1987. The SDFS Service would allow DTC participants to use DTC's depository services for certain types of securities that settle in same-day funds. Publication of the proposal is expected to be made in the Federal Register during the week of April 6. (Rel. 34-24320)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-87-2) to ease restrictions imposed on approved persons or member organizations affiliated with options specialists. (Rel. 34-24323)

TRUST INDENTURE ACT RELEASES

UNION CARBIDE CORPORATION

An order has been issued under the Trust Indenture Act of 1939 on an application by Union Carbide Corporation that the trusteeship of Manufacturers Hanover Trust Company under four Union Carbide indentures is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify Manufacturers from acting as trustee under the indentures.
