OPEN MEETING - WEDNESDAY, APRIL 29, 1987 - 10:00 a.m.

The subject matter of the April 29 open meeting will be:

(1) Consideration of a legislative package to be sent to Congress proposing amendments to: (1) the definitions of "broker" and "dealer" in Sections 3(a)(4) and 3(a)(5) of the Securities Exchange Act of 1934, and (2) the broker-dealer registration requirements found in Section 15(a) of the Securities Exchange Act of 1934. These amendments, if enacted, would preclude banks from engaging in securities activities, except under limited circumstances. (2) Consideration of releases concerning: (1) a joint industry reporting plan submitted by the National Association of Securities Dealers, Inc. and the Midwest Stock Exchange (MSE) for National Market System (NMS) Securities that are traded on a national securities exchange on a listed basis or pursuant to unlisted trading privileges; and (2) the MSE application for unlisted trading on 25 OTC NMS securities. RULES AND RELATED MATTERS

ADOPTION OF RULES GOVERNING REGISTRATION OF GOVERNMENT SECURITIES BROKER-DEALERS

> The Commission adopted rules and form revisions governing the registration of government securities brokers and dealers, as required by the Government Securities Act of 1986. The rules require registration using Form BD as revised. (Rel. 34-24372)

The Commission adopted revisions to Form BDW, the form used by registered brokerdealers to withdraw from registration. The adopted revisions are part of the cooperative efforts of securities regulators to simplify, standardize, and improve the forms used by registred broker-dealers. (Rel. 34-24374)

ADMINISTRATIVE PROCEEDINGS

E.S.M. "INSIDERS" SANCTIONED

The Commission issued orders instituting public administrative proceedings, making findings, and imposing remedial sanctions against Ronnie R. Ewton, George G. Mead, Nicholas B. Wallace, Thomas F. Saunders, and Timothy R. Murphy, all former officers of E.S.M. Government Securities, Inc. or its affiliates. Respondents admitted that they had been adjudicated guilty of various crimes and permanently enjoined, as a resulf of the Commission's injunctive actions against them, from further violations of the antifraud provisions of the securities laws. The Commission also found that Ewton, Mead, Saunders, and Murphy had violated the antifraud provisions in accordance with respondents' consents without admitting or denying the violations.

All respondents were permanently barred, by Commission order, from association with any broker, dealer, municipal securities dealer, investment company, or investment adviser, in accordance with their offers of settlement. (Rel. 34-24336 through 34-24340)

CIVIL PROCEEDINGS

DAVID L. WILLIAMS, OTHERS INDICTED

The U.S. Attorney for the District of New Hampshire and the Boston Regional Office announced that on April 1 a federal grand jury indicted David L. Williams, Blondheim Investment Advisers, Inc., and Blondheim Real Estate, Inc. on 15 counts of mail fraud and fraud by an investment adviser. The indictment charges that the defendants devised a scheme to defraud Blondheim Investment Advisers' clients of at least \$1 million. The indictment further charges that, among other things, Williams misrepresented to investors that their funds would be invested in individual retirement accounts managed by a trust company while funds were actually used to pay the operating expenses of certain insolvent limited partnerships controlled by Williams.

In an earlier Commission civil action, Williams was enjoined from further violations of the registration, reporting, and antifraud provisions of the securities laws. The Commission also barred Williams from association with any broker, dealer, municipal securities dealer, investment company, or investment adviser.

If convicted on all counts, Williams faces a maximum of 75 years in prison and a fine of \$250,000. (U.S. v. David L. Williams, Cr. No. 87-10-01-L, USDC DNH). (LR-11411)

INVESTMENT COMPANY ACT RELEASES

RXR U.S. GOVERNMENT FUND, INC.

An order has been issued granting RXR U.S. Government Fund, Inc. an exemption from Section 19(b) of the Investment Company Act and Rule 19b-1 to allow monthly distributions of long-term capital gains on certain options transactions. (Rel. IC-15695 -April 21)

RESIDENTIAL RESOURCES, INC.

An order has been issued exempting Residential Resources, Inc. and James C. Marshall (on behalf of certain Affiliates) from all provisions of the Investment Company Act in connection with the issuance and sale of mortgage-backed securities and equity interests. (Rel. IC-15696 - April 22) COUNSELLORS TANDEM SECURITIES FUND, INC.

A conditional order has been issued declaring that Richard Cooper is not an "interested person" of Counsellors Tandem Securities Fund, Inc. (Fund), Warburg, Pincus Counsellors, Inc. (Adviser), any principal underwriter of the Fund, or any other investment company for which the Adviser acts or may act as investment adviser or underwriter. (Rel. IC-15697 - April 22)

HOLDING COMPANY ACT RELEASES

COLUMBUS AND SOUTHERN OHIO ELECTRIC COMPANY

A notice has been issued giving interested persons until May 11 to request a hearing on a proposal by Columbus and Southern Ohio Electric Company, subsidiary of American Electric Power Company, Inc., to sell and lease electric power distribution equipment to its industrial electricity customer, Buckeye Steel Castings Company. (Rel. 35-24374 - April 16)

COLUMBUS & SOUTHERN OHIO ELECTRIC COMPANY

An order has been issued authorizing a proposal by Columbus & Southern Ohio Electric Company (C&SOE), subsidiary of American Electric Power Company, Inc., and its subsidiary, Conesville Coal Preparation Company (CCPC). CCPC has been authorized to pay to C&SOE, its sole shareholder, a distribution upon its common stock of up to \$12,450,000 out of its paid-in capital surplus as a result of CCPC's sale and leaseback, on December 30, 1986, of a substantial portion of the assets of the Conesville Coal Preparation Plant. CCPC and C&SOE also have been authorized to amend the previously authorized rate of return on C&SOE's investment in CCPC and the previously authorized Amended Coal Washing Agreement. The proposed amendment to the Agreement provides for an adjustment, effective January 1, 1987, to the rate of return on equity earned by C&SOE on its investment in CCPC so that such return with respect to the excess capital actually distributed to C&SOE will equal CCPC's investment income on such excess capital. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to proposed rule changes filed by: <u>The Chicago Board Options Exchange</u> (SR-CBOE-87-11) to establish a new option contract (NSX) on the S&P 500 Index that will settle based on the opening prices of component securities on expiration Fridays. The filing enables CBOE to list NSX contracts for the June, September, and December expiration cycles. (Rel. 34-24367); <u>The New York</u> <u>Stock Exchange</u> (SR-NYSE-87-13) to extend effectiveness of its expiration pilot that bases settlement of its Composite and Beta Index option contracts on the opening prices of the underlying stocks through the July 17, 1987 expiration Friday. (Rel. 34-24369); and <u>The Philadelphia Stock Exchange</u> (SR-Phix-87-13) to notify investors that it may determine to implement revised settlement procedures in its index option contracts. (Rel. 34-24370)

TRUST INDENTURE ACT RELEASES

CITICORP

An order has been issued under the Trust Indenture Act of 1939 on an application by Citicorp that the trusteeships of United States Trust Company of New York under four existing, previously qualified indentures, and under pooling and servicing agreements each dated December 1, 1986 under which certificates evidencing interests in a pool of mortgage loans have been issued, are not so likely to involve a material conflict of interest as to make it necessary to disgualify the Trust company from acting as trustee under the indentures or agreements.
