## **CORPORATE REORGANIZATION RELEASES**

JOHNS-MANVILLE CORP.

The Commission filed a brief addressing issues raised in an appeal by Johns-Manville Corp.'s common stockholders pending in the district court from the bankruptcy court's order confirming the debtor's plan or reorganization. The Commission first reiterated its view, urged in a case presently pending before the court of appeals, that the lower court erred in refusing to appoint an official committee to represent common stockholders. The brief went on to point to the factors the district court should consider in evaluating whether this refusal affected the fairness of the confirmation hearing so as to require reversal of the order confirming the plan of reorganization. The Commission expressed no view, however, on the ultimate issue of whether the order of confirmation should be reversed. (Rel. CR-364)

## **CIVIL PROCEEDINGS**

FINAL JUDGMENTS OF PERMANENT INJUNCTION ENTERED AGAINST WILLIAM H. MELHORN AND EUGENE BURNELL GARRETT

The Atlanta Regional and Miami Branch Offices announced that on April 10 U.S. District Judge William M. Hoeveler, Southern District of Florida, entered Final Judgments of Permanent Injunction against William H. Melhorn, of Fort Myers, Florida, and Eugene Burnell Garrett, of Naples, Florida. Melhorn and Garrett were the chief executive officer and a manager, respectively, of Charles Phillip Elliott, doing business as Elliott Enterprises, an unincorporated business with offices in Fort Myers and Naples. The Final Judgments enjoin defendants from violating the antifraud and registration provisions of the Securities Act of 1933 and the antifraud and broker registration provisions of the Securities Exchange Act of 1934, and require that each file an accounting of proceeds obtained and disgorge an amount to be subsequently determined. Both consented to the Final Judgments without admitting or denying the allegations in the Commission's complaint.

The March 31 complaint alleges that defendants sold unregistered securities, operated an unregistered broker-dealer, and obtained funds from investors by misrepresenting and omitting material facts, including, among other things, failing to disclose to investors that collateral purportedly pledged to protect investments was being rehypo thecated. The complaint further alleges that defendants obtained at least \$50 million from at least 1,000 investors under the scheme. (SEC v. Charles Phillip Elliott, et al., Civil Action No. 87-12012-CIV-HOEVELER, SDFL). (LR-11418)

NORTHSTAR MINERALS, INC. ENJOINED

The Commission announced that on April 29 the U.S. District Court for the District of Columbia entered a Final Judgment of Permanent Injunction against Northstar Minerals, Inc. of Houston, Texas. The Judgment restrains and enjoins Northstar from failing to file timely periodic reports and Notifications of Late Filing.

In its March 12 complaint, the Commission alleged that Northstar, as part of a continuing course of violative conduct extending over several years, failed to file or filed late its Annual Report on Form 10-K for its fiscal year ended June 30, 1986, its Quarterly Reports on Form 10-Q for its fiscal quarters ended September 30 and December 31, 1986, and six Notifications of Late Filing. Northstar, consenting to the Court's Judgment, admitted that it failed to file or filed late one Annual Report, six Quarterly Reports, and six Notifications of Late Filing. (SEC v. Northstar Minerals, Inc., USDC DC, Civil Action No. 87-687). (LR-11419)

#### **CRIMINAL PROCEEDINGS**

LESLIE H. ROBERTS AND JEFFREY L. ROBERTS SENTENCED

The Atlanta Regional and Miami Branch Offices announced that on March 30 Leslie Howard Roberts (L. Roberts) was sentenced to 15 years in prison, the maximum possible sentence, based on his earlier plea of guilty to conspiracy and two counts of mail fraud. His brother, Jeffrey Lee Roberts (J. Roberts), was sentenced to three years in prison based on his earlier plea of guilty to one count of mail fraud. L. Roberts, formerly an account executive employed consecutively by two registered broker-dealers, and J. Roberts, L. Roberts' assistant, were charged in a 20-count indictment with conspiracy to defraud their employers and a customer by engaging in and concealing unauthorized transactions in the customers' accounts. The fraudulent conduct began in approximately June 1984 and continued until mid-February 1986. The Roberts attempted to conceal the fraud by diverting the customer's real confirmations and monthly statements away from his correct address and mailing false confirmations and monthly statements to the customer on forms designed to resmeble those used by their employers, which were prepared without the knowledge or approval of those broker-dealers. (U.S. v. Leslie Howard Roberts and Jeffrey Lee Roberts, Indictment No. 86-8046-CR-PAINE-SS, USDC SDFL). (LR-11417)

# **INVESTMENT COMPANY ACT RELEASES**

E.F. HUTTON LIFE INSURANCE COMPANY

An order has been issued granting E.F. Hutton Life Insurance Company and its Variable Life Separate Account exemptions from Sections 2(a)(32), 2(a)(35), 9(a), 13(a), 15(a), 15(b), 22(c), 26(a), 27(c)(1), and 27(c)(2) of the Investment Company Act and Rule 22c-1, and paragraphs (b)(1), (b)(12), (b)(13)(i), (b)(13)(iv), (b)(15), (c)(1), and (c)(4) of Rule 6e-2. The exemptions will permit Applicants to issue and sell certain single premium variable life insurance contracts. (Rel. IC-15709 - April 29)

#### THE NORTHWESTERN MUTUAL LIFE INSURANCE COMPANY

An order has been issued exempting The Northwestern Mutual Life Insurance Company, NML Equity Services, Inc., NML Variable Annuity Account B, NML Variable Annuity Account 1, and NML Variable Annuity Account 2 from the provisions of Section 17(a) of the Investment Company Act to combine Accounts 1 and 2 into Account B. (Rel. IC-15710 - April 29)

#### DEAN WITTER REYNOLDS INC.

An order has been issued amending three existing orders which permit Dean Witter Reynolds Inc. and its various mutual funds to assess and waive a contingent deferred sales charge on redemption of such funds' shares and permit certain offers of exchange of the shares (Rel. IC-13126 - March 30, 1983; IC-13673 - December 14, 1983; and IC-13782 - February 22, 1984). The amended order further permits offers of exchange among existing and future Dean Witter mutual funds which are sold either with contingent deferred sales charges, front-end sales charges, or without such sales charges. ## HOLDING COMPANY ACT RELEASES

#### NORTHEAST UTILITIES

An order has been issued authorizing Northeast Utilities, a registered holding company, to amend its declaration of trust to increase the authorized number of common shares from 130,000,000 to 225,000,000 and to limit the liability of its trustees, officers, and agents for money damages for breach of fiduciary duty as permitted by Massachusetts law. Northeast was authorized by order dated March 12 to solicit proxies in connection with the transactions which are the subject of this declaration from shareholders at the annual meeting to be held May 19. (Rel. 35-24377 - April 24)

### LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING APPROVED

The Commission approved the Midwest Stock Exchange's application for unlisted trading privileges in 25 National Market System Securities. (Rel. 34-24406)

# SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

Proposed rule changes have become effective upon filing under Section 19(b)(3)(A) of the Securities Exchange Act of 1934 by: <u>The Options Clearing Corporation</u> (SR-OCC-87-8) amending its rules governing foreign currency options and the margining of settlement obligations arising therefrom. (Rel. 34-24398); (SR-OCC-87-6) clarifying that where option holders exercise prior to ex-dates, they are entitled to receive dividends and other distributions; (Rel. 34-24399); and <u>The Pacific Stock Exchange</u> (SR-PSE-87-5) authorizing the issuance to members of rights to purchase 36 additional regular memberships. (Rel. 34-24401)

NOTICE OF PROPOSED RULE CHANGE

The Midwest Stock Exchange filed a proposed rule change under Rule 19b-4 (SR-MSE-87-5) to revise procedures for customer account transfer between its member organizations. Publication of the proposal is expected to be made in the <u>Pederal Register</u> during the week of April 27. (Rel. 34-24400)

#### APPROVAL OF MSE JOINT INDUSTRY PLAN

The Commission approved a joint industry plan submitted by the Midwest Stock Exchange (MSE) and the National Association of Securities Dealers, Inc., providing for the collection, processing, and dissemination of transaction and quotation information on National Market System Securities (NMS Securities) traded on an exchange on a listed or unlisted basis. The Commission also approved the MSE's application for unlisted trading privileges on 25 NMS Securities [see Rel. 34-24406].

Publication of the release in the <u>Federal Register</u> is expected during the week of May 4. (Rel. 34-24407)

# TRUST INDENTURE ACT RELEASES

AMERICAN SOUTHWEST FINANCE CO., INC.

An order has been issued under the Trust Indenture Act of 1939 on an application by Citicorp that the trusteeships of United States Trust Company of New York under four existing, previously qualified indentures, and a Pooling and Servicing Agreement dated January 1, 1987 under which certificates evidencing interests in a pool of mortgage loans have been issued, are not so likely to involve a material conflict of interest as to make it necessary to disqualify the Trust Company from acting as trustee. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
