

## ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST MARY KATA

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Mary Kata, former financial principal of a registered broker-dealer. The Order alleges that Kata aided and abetted violations by a registered broker-dealer of Section 17(a) of the Exchange Act and Rules 17a-3, 17a-4, 17a-5, and 17a-11 in that, from approximately August 7, 1985 to September 24, 1985 while she was financial principal, she, among other things: (a) failed to maintain and preserve accurate and current books and records for the broker-dealer; (2) failed to give timely telegraphic notice of the broker-dealer's recordkeeping deficiencies to the Commission and the NASD; and (3) filed a materially misleading and inaccurate report, on Part I of Form X-17A-5, with the NASD.

A hearing will be scheduled to determine whether the allegations against Kata are true and, if so, what, if any, remedial sanctions should be imposed. (Rel. 34-24660)

### **CIVIL PROCEEDINGS**

COMPLAINT NAMES UNITED EDUCATORS, INC. AND JOSEPH KLEIN; MOTION FOR CONTEMPT AGAINST KLEIN

The Commission filed an injunctive action on July 9 in the U.S. District Court for the District of Columbia against United Educators, Inc. (UEI) of Framingham, Massachusetts and its Chief Executive Officer and Chairman of the Board, Joseph Klein, for violations of the reporting and books and records provisions of the securities laws.

The Commission also filed a motion to adjudge Klein in civil contempt for violation of a 1982 injunction relating to another issuer. That injunction prohibited Klein from causing any issuer to fail to file timely periodic reports. In its contempt motion, the Commission alleges that Klein caused UEI to fail to file complete Annual Reports for 1985 and 1986, three Quarterly Reports for 1986 and its quarter ended March 31, 1987.

UEI and Klein consented to the Judgments of Permanent Injunction. Klein also consented to a Finding of Civil Contempt and an Order Imposing Fines which would require Klein personally to pay any fines imposed. A hearing has been scheduled for July 30 on the Commission's motion for civil contempt. (SEC v. United Educators, Inc. and Joseph Klein, USDC DC, Civil Action No. 87-1840-HHG; and SEC v. Cavanagh Communities Corporation and Joseph Klein, USDC DC, Civil Action No. 82-2415-HHG). (LR-11484)

#### **INVESTMENT COMPANY ACT RELEASES**

RESIDENTIAL MORTGAGE INVESTMENTS, INC.

An order has been issued exempting Residential Mortgage Investments, Inc. and its subsidiary, Residential Mortgage Acceptance, Inc. (Applicants), and certain trusts created by Applicants from all provisions of the Investment Company Act in connection with the issuance of mortgage-backed securities and beneficial interests in such trusts. #### HUTTON INVESTMENT SERIES INC.

An order has been issued permitting Hutton Investment Series Inc. and other present and future open-end management investment companies for which E.F. Hutton acts as the investment adviser or distributor (Applicants) to make certain offers of exchange of shares among the Applicants on a basis other than their respective net asset value per share at the time of exchange. LINCOLN SERVICE CAPITAL, INC.

An order has been issued on an application filed by Lincoln Service Capital, Inc. on behalf of certain trusts for which it is, or will be, the depositor (collectively, Trusts) exempting the Trusts from all provisions of the Investment Company Act in connection with the issuance and sale of mortgage-backed securities and equity interests. CITYFED FUNDING CORP.

An order has been issued conditionally exempting CityFed Funding Corp., an indirect subsidiary of City Federal Savings Bank, and certain trusts that it may form from time to time in connection with the issuance of mortgage-backed securities and the sale of beneficial interests in such trusts. BEAR STEARNS SECURED INVESTORS INC.

An order has been issued amending an existing order (Release IC-15678, dated April 13, 1987) by Bear Stearns Secured Investors Inc. to permit issuance of variable or floating interest rate mortgage-backed bonds. (Rel. IC-15858 - July 2)

#### HOLDING COMPANY ACT RELEASES

SYSTEM ENERGY RESOURCES, INC.

Notices have been issued giving interested persons until July 27 to request a hearing on proposals by the following company filed under Release 35-24420, dated July 2: <u>System Energy Resources, Inc.</u> (SERI) - subsidiary of Middle South Utilities, Inc., to include short-term borrowings from external sources in computing its overall 10% of secured debt plus capital and surplus limitation on short-term borrowings from the System Money Pool; and SERI, Arkansas Power & Light Company, Mississippi Power & Light Company, Louisiana Power & Light Company, New Orleans Public Service, Inc., and their parent, Middle South Utilities, Inc. SERI proposes to issue and sell, in one or more series from time-to-time through March 31, 1989, up to \$300 million aggregate principal amount of its first mortgage bonds, pursuant to an exception from competitive bidding.

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the Philadelphia Stock Exchange (SR-Phlx-87-21) to apply the listing requirements for warrants under Phlx Rule 803 to the listing of foreign currency warrants. (Rel. 34-24680)

#### **TRUST INDENTURE ACT RELEASES**

#### CITICORP

An order has been issued under the Trust Indenture Act of 1939 on an application by Citicorp that the trusteeships of United States Trust Company of New York under four existing, previously gualified indentures, and two pooling and servicing agreements dated March 1, 1987 under which certificates evidencing interests in a pool of mortgage loans have been issued, are not so likely to involve a material conflict of interest as to make it necessary to disgualify the Trust Company from acting as trustee under any of the indentures or the agreements. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
