COMMISSION ANNOUNCEMENTS

U.S. SECURITIES AND EXCHANGE COMMISSION

REPORT ON THE FINANCIAL GUARANTEE MARKET

On August 31, the Commission transmitted to Congress a report on the financial guarantee market conducted pursuant to Section 105 of the Government Securities Act of 1986, Pub. L. No. 99-571. In Section 105, Congress directed the Commission to examine the use of the exemption from registration in Section 3(a)(2) of the Securities Act of 1933 for securities guaranteed by banks, and the use of insurance policies to guarantee securities. In the report, the Commission finds that the exemption in Section 3(a)(2) creates an apparent competitive advantage for banks in seeking to provide financial guarantees. To remedy this, the Commission recommends that Congress amend Section 3(a)(2) to remove the exemption from registration for securities issued or guaranteed by banks, and provide the Commission with statutory authority to grant exemptive relief from the registration requirements of the Securities Act, by rule or order. ALDEN S. ADKINS APPOINTED SPECIAL COUNSEL TO THE CHAIRMAN

Chairman Ruder has selected Alden S. Adkins to fill the position of Special Counsel to the Chairman, effective August 31, 1987.

Mr. Adkins began his Commission career in April 1982, in the Division of Market Regulation, serving as a staff attorney first in the Branch of Exchange Regulation and then in the Branch of Options Regulation. During the past year, he has served as Branch Chief for the National Market System Branch in the Division of Market Regulation. Mr. Adkins is a 1981 graduate of the Washington College of Law of the American University. He received his B.A. degree from Johns Hopkins University in 1976. (Press Release 87-59)

ADMINISTRATIVE PROCEEDINGS

REGISTRATION OF WEST COAST HAIR PRODUCTS, INC. REVOKED

The Commission ordered public administrative proceedings under Section 12(j) of the Securities Exchange Act of 1934 in the matter of the registration statement filed by West Coast Hair Products, Inc. The Commission also revoked the registration of the common stock of West Coast pursuant to Section 12(g) of the Exchange Act and found that West Coast's Form 10 registration statement, among other things, included a purported audit report fabricated by a West Coast officer, failed to disclose certain material related party transactions, and failed to disclose required information about West Coast's business and members of West Coast's management. West Coast consented to the Order without admitting or denying the findings therein. (Rel. 34-24850)

CIVIL PROCEEDINGS

TEMPORARY RESTRAINING ORDER ENTERED AGAINST GARY M. WOZNIAK

The Chicago Regional Office announced that on August 28 Judge George LaPlata, Eastern District of Michigan, entered a Temporary Restraining Order against Gary M. Wozniak. The Order enjoins Wozniak from violations of the antifraud provisions of the securities laws, freezes all of his assets, and requires him to provide an accounting to the Court.

The Complaint alleged that, as part of a fraudulent scheme, Wozniak offered and sold securities to investors, requiring them to make their checks payable to a personal bank account of Wozniak for the purchase of securities. Thereafter, defendant failed to process the orders. The Complaint further alleges that Wozniak misappropriated hundreds of thousands of dollars in connection with failing to process the orders. (SEC v. Gary M. Wozniak, EDMI, Civil Action No. 87-60283). (LR-11525)

INVESTMENT COMPANY ACT RELEASES

BACHE/KILICO VARIABLE ANNUITY ACCOUNT

A notice has been issued giving interested persons until September 28 to request a hearing on an application filed by Bache/KILICO Variable Annuity Account for an order declaring that it has ceased to be an investment company. (Rel. IC-15952 - Aug. 28)

BENJAMIN FRANKLIN FINANCIAL CORPORATION

A notice has been issued giving interested persons until September 21 to request a hearing on an application filed by Benjamin Franklin Financial Corporation, subsidiary of Benjamin Franklin Savings Association, requesting an order amending the terms of its present order exempting it from all provisions of the Investment Company Act in connection with its proposed issuance of collateralized mortgage obligations and the possible resale of its capital stock. HOLDING COMPANY ACT RELEASES

GEORGIA POWER COMPANY

A supplemental order has been issued authorizing Georgia Power Company, subsidiary of The Southern Company, an exception from the competitive bidding requirements of Rule 50(b) and (c), pursuant to Subsection 50(a)(5), for the issuance and sale of up to \$75 million of Class A preferred stock. LISTING, DELISTING AND UNLISTED TRADING ACTIONS

WITHDRAWAL GRANTED

An order has been issued granting the application of HODGSON HOUSES, INC. to withdraw the common stock, \$.01 par value, from listing and registration on the Boston Stock Exchange. (Rel. 34-24863)

UNLISTED TRADING SOUGHT

A notice has been issued giving interested persons until September 21 to comment on the application of the <u>Philadelphia Stock Exchange</u> for unlisted trading privileges in two issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval of a proposed rule change filed by the National Association of Securities Dealers, Inc. (SR-NASD-87-32) which would extend the period of effectivenes of the Pilot Program undertaken by the NASD and the Stock Exchange of the United Kingdom and the Republic of Ireland, Ltd. (Exchange) until September 30. The Pilot Program is a transatlantic communication linkage through which quotation information on select NASDAQ and Exchange-listed securities is exchanged. NOTICE OF PROPOSED RULE CHANGE

The Midwest Stock Exchange filed a proposed rule change (SR-MSTC-87-5) that would authorize it to charge its participants for failure to eliminate certain outstanding negative balances. Publication of the proposal is expected to be made in the <u>Federal</u> <u>Register</u> during the week of August 31. (Rel. 34-24865)

TRUST INDENTURE ACT RELEASES

RAIL CAR ASSOCIATES LIMITED PARTNERSHIP
