(MSU), a registered holding company, and its generating subsidiary, System Energy Resources, Inc., to guarantee certain potential obligations of Mississippi Power & Light Company, an electric utility subsidiary of MSU, to refund rates to its consumers pending the final disposition of an appeal to the United States Supreme Court from a judgment of the Mississippi Supreme Court. (AMEX-87-21) to increase the size of eligible orders in its AUTO-EX system from 10 to

20 contracts (Rel. 34-24899); and the <u>Chicago Board Options Exchange</u>, <u>Inc.</u> (SR-CBOE-87-33) to increase the number of <u>Standard & Poor's 100 Index option</u> contracts eligible for execution through the Retail Automatic Execution System from 10 to 20 per order (Rel. 34-24900).
