CIVIL PROCEEDINGS

COMPLAINT NAMES UNITED STATES VIDEO VENDING CORPORATION

The Commission announced that on September 17 the U.S. District Court for the District of Columbia entered a Final Order against United States Video Vending Corporation of New York, New York. The Final Order required Video to file with the Commission its delinquent Quarterly Report on Form 10-Q for its fiscal quarter ended June 30, 1987 and its delinquent amendment of its Form 8-K filed May 5, 1987 with audited financial statements.

In its June 23 complaint, the Commission alleged that Video, as part of a continuing course of violative conduct, failed to file its Annual Report on Form 10-K for its fiscal year ended December 31, 1986, its Quarterly Report on Form 10-Q for its fiscal quarter ended March 31, 1987, three Notifications of Late Filing on Form 12b-25, and its amendment to a Current Report on Form 8-K. Video, consenting to the Court's Order, admitted that it failed to file or filed late four Annual and Quarterly Reports, three Notifications of Late Filing, and its Current Report on Form 8-K. (SEC v. United States Video Vending Corporation, USDC DC, Civil Action No. 87-1711-NHJ). (LR-11544)

COMPLAINT NAMES FINANCIAL CORPORATION OF AMERICA

The Commission today filed a Complaint for a Permanent Injunction and Other Equitable Relief against Financial Corporation of America (FCA), holding company for American Savings and Loan Association. The Complaint alleges violations of the reporting, books and records, and internal controls provisions of the Securities Exchange Act of 1934. Specifically, the Complaint alleges that FCA recognized prematurely and contrary to generally accepted accounting principles, income from certain real estate transactions, and ADC loans. The Complaint further alleges that FCA failed to maintain adequate reserves to cover losses inherent in its loan and real estate portfolio.

Without admitting or denying the allegations in the Complaint, FCA consented to the Final Judgment of Permanent Injunction and Other Equitable Relief. In addition, FCA consented to have its independent accountants perform a review of the adequacy of FCA's systems of internal accounting controls in accordance with the provisions of Statement on Auditing Standards (SAS) No. 30. Further, FCA consented to have its independent accountants perform, for two years, quarterly reviews in accordance with the provisions of SAS No. 36. (SEC v. MIDDLE SOUTH UTILITIES, INC.; ENERGY CREDIT INSURANCE LIMITED

Notices have been issued giving interested persons until October 13 to request a hearing on a proposal by the following companies filed under Release 35-24462, dated September 17: System Energy Resources, Inc. - subsidiary of Middle South Utilities, Inc., to amend its Domestic Bank Loan Agreement and its Foreign Bank Loan Agreement in connection with the deferral to no later than December 15, 1987 of payment of installments; and <u>New England Power Company (NEPCO)</u> - subsidiary of New England Electric System, Connecticut Light and Power Company (CL&P) and Western Massachusetts Electric Company (WMECO), both subsidiaries of Northeast Utilities, Inc., Montaup Electric Company and EUA Power Corporation, both subsidiaries of Eastern Utilities Associates, to acquire an interest in Energy Credit Insurance Limited (ECIL), a nuclear decommissing fund insurance company in Bermuda.
