ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AND FINDINGS AND ORDER ENTERED AGAINST SETRAG MOORADIAN

The Commission today instituted public administrative proceedings against Setrag Mooradian under Section 15(b)(6) of the Securities Exchange Act of 1934. Simultaneously, Mooradian submitted an Offer of Settlement in which, without admitting or denying the findings of violations, he consented to the Findings an Order by the Commission.

Mooradian, at various times, was employed as a principal accountant and vice president of Seemala Corporation, formerly a registered broker-dealer controlled by Ivan F. Boesky. As such, he was responsible for the maintenance of certain of the books and records of Seemala. The Commission found that Mooradian aided and abetted Seemala's violations of Section 17(a)(1) of the Exchange Act and Rules 17a-3 and 17a-4 in that he failed to cause Seemala's records to reflect accurately the identities of and other required information with respect to the person or persons who had beneficial interests in certain securities of Fischbach Corporation and other issuers acquired and held by Seemala.

Mooradian consented to an Order suspending him from association with any broker, dealer, investment adviser, investment company, municipal securities dealer, or government securities broker or dealer for 12 months. Mooradian undertakes to cooperate with the Commission in all matters arising from certain inquiries and investigations. (Rel. 34-24937)

CIVIL INJUNCTIVE ACTION FILED AGAINST CAPITAL ENTERPRISES, INC.

The Denver Regional Office announced that on September 22 a civil injunctive action was filed in the U.S. District Court for the District of Columbia against Capital Enterprises, Inc. of Denver, Colorado. The Complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Complaint alleges, among other things, that Capital failed to file its Annual Reports on Forms 10-K for its fiscal years ended June 30, 1985 and June 30, 1986, and its Quarterly Reports on Forms 10-Q for its fiscal quarters ended March 31, 1985, September 30, 1985, December 31, 1985, March 31, 1986, September 30, 1986, December 31, 1986, and March 31, 1987. The Complaint seeks a court order compelling Capital to file its delinquent Annual and Quarterly Reports and enjoining it from future violations of the reporting provisions of the securities laws. (SEC v. Capital Enterprises, Inc., USDC DC, Civil Action No. 87-2603). (LR-11548)

CIVIL INJUNCTIVE ACTION FILED AGAINST CENTENNIAL ACQUISITIONS, INC.

The Denver Regional Office announced that on September 22 a civil injunctive action was filed in the U.S. District Court for the District of Columbia against Centennial Acquisitions, Inc. of Billings, Montana. The Complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Complaint alleges, among other things, that Centennial failed to file its Annual Reports on Forms 10-K for its fiscal years ended November 30, 1985 and November 30, 1986, and its Quarterly Reports on Forms 10-Q for its fiscal quarters ended February 28, 1986, May 31, 1986, August 31, 1986, February 28, 1987, and May 31, 1987. The Complaint further alleges that Centennial failed to file complete and accurate reports on Forms 8-K including audited historical financial statements and pro forma financial

statements. The Complaint seeks a court order compelling Centennial to file its delinquent Annual and Quarterly Reports and complete and accurate Current Reports and Form SR and enjoining it from future violations of the reporting provisions of the securities laws. (SEC v. Centennial Acquisitions, Inc., USDC DC, Civil Action No. 87-2604). (LR-11549)

CIVIL INJUNCTIVE ACTION FILED AGAINST COASTAL FUNDING CORPORATION

The Denver Regional Office announced that on September 22 a civil injunctive action was filed in the U.S. District Court for the District of Columbia against Coastal Funding Corporation of King of Prussia, Pennsylvania. The Complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Complaint alleges, among other things, that Coastal failed to file its Annual Reports on Forms 10-K for its fiscal years ended June 30, 1985 and June 30, 1986, and its Quarterly Reports on Forms 10-Q for its fiscal quarters ended September 30, 1984, December 31, 1984, March 31, 1985, September 30, 1985, December 31, 1985, and March 31, 1986, September 30, 1986, December 31, 1986, and March 31, 1987. The Complaint seeks a court order compelling Coastal to file its delinquent Annual and Quarterly Reports and enjoining it from future violations of the reporting provisions of the securities laws. (SEC v. Coastal Funding Corporation, USDC DC, Civil Action No. 87-2606). (LR-11550)

CIVIL INJUNCTIVE ACTION FILED AGAINST ENCIBAR, INC.

The Denver Regional Office announced that on September 22 a civil injunctive action was filed in the U.S. District Court for the District of Columbia against Encibar, Inc. of Encinitos, California. The Complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Complaint alleges, among other things, that Encibar failed to file its Annual Reports on Forms 10-K for its fiscal years ended March 31, 1986 and March 31, 1987, and its Quarterly Reports on Forms 10-Q for its fiscal guarters ended December 31, 1985, June 30, 1986, September 30, 1986, December 31, 1986, and June 30, 1987. The Complaint seeks a court order compelling Encibar to file its delinquent Annual and Quarterly Reports and enjoining it from future violations of the reporting provisions of the securities laws. (SEC v. Encibar, Inc., USDC DC, Civil Action No. 87-2605). (LR-11551)

CIVIL INJUNCTIVE ACTION FILED AGAINST FINTECH, INC.

The Denver Regional Office announced that on September 22 a civil injunctive action was filed in the U.S. District Court for the District of Columbia against Fintech, Inc. of Salt Lake City, Utah. The Complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Complaint alleges, among other things, that Fintech failed to file its Annual Reports on Forms 10-K for its fiscal years ended September 30, 1985 and September 30, 1986, and its Quarterly Reports on Forms 10-Q for its fiscal guarters ended March 31, 1986, June 30, 1986, December 31, 1986, March 31, 1987, and June 30, 1987. The Complaint seeks a court order compelling Fintech to file its delinquent Annual and Quarterly Reports and enjoining it from future violations of the reporting provisions of the securities laws. (SEC v. Fintech, Inc., USDC DC, Civil Action No. 87-2601). (LR-11552)

CIVIL INJUNCTIVE ACTION FILED AGAINST GUIDE ENERGY, INC.

The Denver Regional Office announced that on September 22 a civil injunctive action was filed in the U.S. District Court for the District of Columbia against Guide Energy, Inc. of Midland, Texas. The Complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Complaint alleges, among other things, that Guide failed to timely file its Annual Reports on Forms 10-K for its fiscal years ended March 31, 1986 and March 31, 1987, and its Quarterly Reports on Forms 10-Q for its fiscal quarters ended June 30, 1986, September 30, 1986, and December 31, 1986. The Complaint further alleges that Guide failed to file complete and accurate reports on Forms 8-K including audited historical

financial statements and pro forma financial statements. The Complaint seeks a court order compelling Guide to file complete and accurate Current Reports and enjoining it from future violations of the reporting provisions of the securities laws. (SEC v. Guide Energy, Inc., USDC DC, Civil Action No. 87-2602). (LR-11553)

INVESTMENT COMPANY ACT RELEASES

COLLEGE AND UNIVERSITY FACILITY LOAN TRUST

An order has been issued granting an application filed by the First National Bank of Boston, not in its individual capacity, but solely as trustee, on behalf of a trust (to be formed), the College and University Facility Loan Trust (Trust), in connection with the Federal government's pilot loan asset sales program. The requested order conditionally exempts the Trust from the provisions of Sections 10(h), 14(a), 16(a), 17(a), 18(a), (c) and (i), and 32(a) of the Investment Company Act, in connection

with the issuance of bonds and senior and junior certificates of beneficial interest in the Trust collateralized by certain loans originated by the United States Department of Education. (Rel. IC-15990 - Sept. 18)

LUTHERAN BROTHERHOOD VARIABLE INSURANCE PRODUCTS COMPANY
