RULE 15c2-2 RESCINDED

The Commission rescinded Rule 15c2-2 concerning the use of predispute arbitration clauses since, in light of the development of case law, the rule is no longer appropriate. (Rel. 34-25034)

# ADMINISTRATIVE PROCEEDINGS

TAX & FINANCIAL PROGRAMMING, INC. AND JOHN W. DISTERDICK SANCTIONED

The Commission instituted public administrative proceedings under the Investment Advisers Act of 1940 against Tax & Financial Programming, Inc., a registered investment adviser, and John W. Disterdick, its president and sole shareholder. Simultaneously, the Commission accepted their Offer of Settlement in which they admitted the Commission's finding that they were permanently enjoined, by consent, from violations of the registration and antifraud provisions of the Securities Act of 1933, the antifraud provisions of the Securities Exchange Act of 1934, and the antifraud, reporting, books and records, and custody and possession of client funds provisions of the Investment Advisers Act of 1940 in SEC v. Tax & Financial Programming Inc., et al., Civil Action No. 84-5962, TJH. The respondents also consented to the Commission's Order barring them from having custody or possession of, or discretionary trading authority or control over, any client funds or securities, and also barring them from association with, in a proprietary or supervisory capacity, any broker, dealer, investment adviser, investment company, or municipal securities dealer having custody or possession of, or discretionary trading authority or control over, any client funds or securities. ORDER MAKING FINDINGS AND IMPOSING REMEDIAL SANCTIONS AGAINST LAWRENCE CIANCHETTA

The Commission accepted an Offer of Settlement in public administrative proceedings previously instituted against Lawrence Cianchetta, also known as Larry Powers, formerly a registered representative and chief trader with Brooks, Hamburger, Satnick, Inc., a broker-dealer formerly registered with the Commission. Powers consented, without admitting or denying the findings in the Order, to findings that he wilfully violated and aided and abetted violations of various registration, antifraud, and antimanipulative provisions of the securities laws in connection with three initial public offerings made in 1983. Powers was barred from association with any broker, dealer, investment company, investment adviser, or municipal securities dealer in any capacity, provided that after four years he may make application to reenter the securities industry in a non-supervisory, non-proprietary capacity. ## CIVIL PROCEEDINGS

COMPLAINT FILED AGAINST WILLIAM EDGAR CROWDER, OTHERS

The Los Angeles Regional Office filed a Complaint on September 28 seeking injunctive relief in the U.S. District Court for the Central District of California against William Edgar Crowder, Bretcourt Securities Corporation (BSC), formerly a registered broker-dealer, and Bretcourt Financial Planning, Inc. (BFP), a registered investment adviser. The Complaint alleges that Crowder, BSC, and BFP raised \$39 million in three real estate limited partnership offerings, and that between March 1982 to September 1985 they used \$7.3 million for non-partnership expenses, including overhead for the entities and Crowder's personal expenses, in contravention of the terms of

the respective limited partnership agreements. Additionally, there was no disclosure to investors and potential investors of the risks of investment or the actual uses to which investors' funds would be put. Defendants are alleged to have violated the antifraud provisions of the Securities Exchange Act; BSC, aided and abetted by Crowder, is alleged to have violated the broker-dealer, antifraud provisions of the Exchange Act; and BFP, aided and abetted by Crowder, is alleged to have violated the antifraud provisions of the Investment Advisers Act. # **INVESTMENT COMPANY ACT RELEASES**

#### THE HORIZON FUNDS

A notice has been issued giving interested persons until November 3 to request a hearing on an application for an order exempting the Horizon Funds from the provisions of Sections 18(f)(1), 18(g), and 18(i) of the Investment Company Act to permit it to issue separate classes of shares representing interests in the same investment portfolio that would be identical in all respects except for class designation and the allocation of certain expenses and voting rights.
