The Municipal Securities Rulemaking Board filed a proposed rule change under Rule 19b-4 (SR-MSRB-87-13) amending its Rule G-32. The proposed rule change would provide an objective definition of "underwriting period" for sold underwritings for purposes of the Rule G-32 requirement that, during the underwriting period, official statements for new issues be delivered to customers no later than settlement. Publication of the proposal is expected to be made in the Federal Register during the week of November 2. (Rel. 34-25084)
