## RULES AND RELATED MATTERS

---

### COMMENTS REQUESTED ON AMENDMENTS TO RULE 204-2

The Commission is proposing for public comment several amendments to Rule 204-2, the recordkeeping rule under the Investment Advisers Act of 1940. The proposed amendments would require advisers to retain, for Commission inspection, all advertisements and supporting records for performance information in advertisements. These advertisements and supporting records would be required to be kept for five years from the end of the fiscal year in which the advertisement was last published.

Comments should be submitted in triplicate to Jonathan G. Katz, Secretary, Securities and Exchange Commission, 450 Fifth Street, NW, Washington, DC 20549. Comments must be received by December 29 and should refer to File No. S7-33-87. All submissions will be available for inspection in the Public Reference Room. (Rel. IA-1093)

## CIVIL PROCEEDINGS

---

### COMPLAINT NAMES STEPHEN L. READ; CIVIL CONTEMPT FILED AGAINST THE ROLFITE COMPANY AND READ

The Commission filed on November 5 a Motion in the U.S. District Court for the District of Columbia To Reopen Judgment, and For an Order To Show Cause Why The Rolfite Company and Stephen L. Read Should Not Be Held in Civil Contempt and Read Sanctioned. At the same time, the Commission filed an action against Read seeking a Final Judgment of Permanent Injunction restraining and enjoining him from failing to timely file Forms 3 and 4 and Schedules 13D and from aiding and abetting any issuer's failure to file its Annual, Quarterly and Current Reports, and Notifications of Late Filing.

On May 12, the Court enjoined Rolfite, which is located in Miami, Florida, from failing to file timely Annual and Quarterly Reports and Notifications of Late Filing, and ordered Rolfite to file its delinquent Annual and Quarterly Reports by June 23 [See LR-11387, March 31, 1987, and LR-11434, May 14, 1987]. The Commission is moving the Court to find Rolfite and Read in contempt because Rolfite has failed to meet the Court's deadline and has not filed any reports since November 1985. Read has been Chairman, CEO and a director of Rolfite since August 1985 and, as beneficial owner of more than 50 percent of its outstanding common stock, is its principal shareholder. In its Complaint, the Commission alleges that Read failed until April 16, 1987 to file a Schedule 13D and two amendments to it, as well as a Form 3 and three Forms 4. (SEC v. The Rolfite Company, USDC DC, Civil Action No. 87-0881-CRR [May 12, 1987] and SEC v. Stephen L. Read, USDC DC, Civil Action No. 87-3006-CRR). (LR-11597)

### FIRST INVESTORS NATURAL RESOURCES FUND, INC.

A notice has been issued giving interested persons until November 19 to request a hearing on an application filed by First Investors Natural Resources Fund, Inc., (Natural Resources Fund), First Investors International Securities Fund, Inc., (International Fund), First Investors Corporation (Sponsor), and First Investors Single Payment and Periodic Payment Plans for the Accumulation of Shares of First Investors Natural Resources Fund, Inc. (Plan) for an order granting exemption and approval for the proposed exchange of, and the resulting substitution of, shares of International Fund for the shares of Natural Resources Fund as the underlying investment for the Plan, and certain affiliated transactions in connection therewith. ## RODNEY SQUARE MULTI-MANAGER FUND

A notice has been issued giving interested persons until November 19 to request a hearing on an application filed by The Rodney Square Multi-Manager Fund, Rodney Square Management Corporation (RSMC), and Tremont Partners, Inc. for an order exempting them from the provisions of Section 15(a) of the Investment Company Act to permit Tremont to serve as an investment adviser to the Fund pursuant to an interim contract, approved by the Fund's Board of Trustees until the next annual meeting of Fund Shareholders. ## HOLDING COMPANY ACT RELEASES

---

### INDIANA MICHIGAN POWER COMPANY

An order has been issued authorizing Indiana Michigan Power Company, subsidiary of American Electric Power Company, Inc., to issue and sell through December 31, 1988 an aggregate principal amount of up to \$300 million of securities comprised of up to \$300 million of first mortgage bonds, \$50 million of cumulative preferred stock, and/or \$300 million of unsecured long-term notes. ### GPU SERVICE CORPORATION

An order has been issued authorizing GPU Service Corporation to issue and sell short-term notes in an aggregate amount of \$15.4 million at any one time outstanding and its parent, General Public Utilities Corporation, a registered holding company, to guarantee such notes. (Rel. 35-24489 - Nov. 4)

### UNLISTED TRADING SOUGHT

## SELF-REGULATORY ORGANIZATIONS

---

### NOTICE OF PROPOSED RULE CHANGE

The Boston Stock Exchange filed a proposed rule change under Rule 19b-4 (SR-BSE-87-6) to eliminate the quotation portion of its Specialist Performance Evaluation Pilot Program, pending further revisions, and amend other portions of the Evaluation. Publication of the proposal is expected to be made in the Federal Register during the week of November 2. (Rel. 34-25086)

### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The National Association of Securities Dealers, Inc. filed a proposed rule change which became immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposal (SR-NASD-87-46) limited the trading hours of the NASDAQ System on October 23, 26, and 27 and required certain member firms to operate on Saturday, October 24. (Rel. 34-25088)

### UNION CARBIDE CORPORATION

A notice has been issued giving interested persons until November 29 to request a hearing on an application by Union Carbide Corporation, a New York corporation, under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeship of Manufacturers Hanover Trust under two of its indentures is not so likely to involve a material conflict of interest as to make it necessary in the

public interest or for the protection of investors to disqualify Manufacturers from acting as trustee under each such indenture. The indentures are dated January 15, 1975, August 15, 1979, January 1, 1986, December 1, 1986, and April 15, 1987. (Rel. TI-2126)
