WEEKLY CALENDAR

The following is a schedule of speaking engagements, Congressional testimony, Commission hearings and other public events involving the Commission for the week of December 13. (Commission Meetings are announced separately in the News Digest)

Tuesday, December 15

Chairman Ruder will testify before the Securities Subcommittee of the Senate Banking, Housing and Urban Affairs Committee in Room 538, Dirksen Office Building. The subject will be the Commission's proposed definition of insider trading and S.1380, the Insider Trading Proscriptions Act of 1987. The hearing is scheduled to begin at 10:00 a.m.

ADMINISTRATIVE PROCEEDINGS

ADRIAN ANTONIU BARRED

The Commission barred Adrian Antoniu, of Minneapolis, from association with any broker or dealer. Antoniu worked in the corporate finance department of Morgan Stanley & Co., Inc. from 1972 until May 1975, and in the acquisitions department of Lehman Brothers Kuhn Loeb, Inc. from then until July 1978.

Antoniu was convicted in November 1980, on the basis of his guilty plea, of trading on the basis of inside information misappropriated by a confederate from Morgan Stanley. In concluding that the public interest required that Antoniu be barred, the Commission stated: "[Antoniu's misconduct] arose from a carefully conceived scheme that Antoniu devised, using accomplices that he recruited. He engineered a protracted and complex operation to betray his employers' trust by misappropriating confidential information for personal gain." (Rel. 34-25169)

INVESTMENT COMPANY ACT RELEASES

PRUDENTIAL-BACHE CAPITAL PARTNERS I, L.P.

A notice has been issued giving interested persons until December 29 to request a hearing on an application filed by Prudential-Bache Capital Partners I, L.P. (Partnership) and Prudential-Bache Partners Inc. for an order, granting exemption from most provisions of the Investment Company Act, permitting certain affiliated transactions and granting confidential treatment to certain documents in connection the Partnership's operation as an employees' securities company. CHUBB INVESTMENT FUNDS, INC.

An order has been issued on an application filed by Chubb Investment Funds, Inc. (Fund) and Chubb Securities Corporation (Distributor) approving certain offers of exchange among the Fund's present and future investment portfolios for which the Distributor acts as principal underwriter. RUSSELL INSURANCE FUNDS, INC.

A notice has been issued giving interested persons until January 2, 1988 to request a hearing on an application filed by Russell Insurance Funds, Inc. for an order exempting it from the provisions of Sections 9(a), 13(a), 15(a), and 15(b) of the Investment Company Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) to permit Applicant to offer its shares to affiliated and unaffiliated life insurance companies in connection with variable annuity contracts and variable life insurance contracts. HOLDING COMPANY ACT RELEASES

NEES ENERGY, INC.; THE COLUMBIA GAS SYSTEM, INC.

Notices have been issued giving interested persons until December 28 to request a hearing on a proposal by the following companies filed under Release 35-24513, dated December 3: NEES ENERGY, INC. - subsidiary of New England Electric System, to extend its borrowing authority under its current \$10 million short-term credit agreement through December 31, 1988 on the same terms and conditions; and THE COLUMBIA GAS SYSTEM, INC. - a registered holding company, and its subsidiary, TriStar Ventures Corporation. It is proposed through December 31, 1989 that TriStar Ventures establish and finance multiple wholly owned subsidiaries to invest in qualifying cogeneration facilities, as defined under the Public Utility Regulatory Policies Act of 1978, and that Columbia invest up to \$50 million in TriStar Ventures and other cogeneration subsidiaries in the form of common stock, unsecured notes and/or short-term borrowings from the Columbia system money pool.

NOTICE OF PROPOSED RULE CHANGES

Proposed rule changes have been filed under Rule 19b-4 by: The Options Clearing Corporation (SR-OCC-87-21) that would permit it to amend its margin requirements for nonequity options to provide that the minimum additional margin is the lesser of \$150 or 25% of the applicable margin interval. (Rel. 34-25174); and The National Securities Clearing Corporation (SR-NSCC-87-12) that would amend its rules and procedures to establish the new membership category for broker-dealers that only use Fund/SERV, and the new Fund/SERV Clearing Fund contribution requirement. (Rel. 34-25175)

Publication of the proposals are expected to be made in the <u>Federal Register</u> during the week of December 7.
