CRIMINAL PROCEEDINGS

LARRY M. CHENEY CONVICTED

The Chicago Regional Office and the U.S. Attorney for the Western District of Missouri announced that on December 2 Larry M. Cheney pled guilty to one count of securities fraud and no contest to one count of securities fraud and three counts of mail fraud in a federal criminal case pending in Kansas City, Missouri. Cheney promoted the sales of securities in 30 discount long distance telephone partnerships formed in five midwestern states. Cheney and Telecom Management International, Inc. (TMI), the entity which was to operate the telephone companies, raised approximately \$7 million from more than 800 investors. On December 21, 1984 Cheney and TMI consented to Permanent Injunctions in the Commission's action against them which was also filed in Kansas City. Cheney will be sentenced in the criminal case on January 15, 1988. (U.S. v. Larry M. Cheney, WDMO, W. Div., 87-00086-01-CR-W-8). (LR-11621)

INVESTMENT COMPANY ACT RELEASES

ADVISERS MANAGEMENT TRUST

A notice has been issued giving interested persons until January 4, 1988 to request a hearing on an application by Advisers Management Trust, Sentry Life Insurance Company, (Sentry), Sentry Variable Life Account I, and Sentry Equity Services, Inc. for an order exempting them from the provisions of Sections 2(a)(32), 9(a), 13(a), 15(a), 15(b), 22(c), 27(c)(1) and 27(d) of the Investment Company Act and Rules 22c-1, 6e-2 (b)(15), 6e-3(T)(b)(12)(ii), 6e-3(T)(b)(13)(iv), and 6e-3(T)(b)(15). The exemptions will permit the deduction of a contingent deferred administrative charge in connection with the offering of flexible premium variable life insurance contracts, and to permit the Account to invest in shares of Advisers, which are sold to variable annuity and variable life insurance separate accounts of Sentry and of affiliated and unaffiliated life insurance companies. The application requests an amendment to the order [Re1. IC-15324] issued under an earlier application [Re1. IC-15274] to include Advisers as a party. (Re1. IC-16165 - Dec. 9)

M.D.C. MORTGAGE FUNDING CORPORATION II
