## **COMMISSION ANNOUNCEMENTS**

DEPA REPORT ON THE USE OF REPURCHASE AGREEMENTS BY BROKER-DEALERS

The Commission released a report prepared by its Directorate of Economic and Policy Analysis (DEPA) entitled, "The Use of Repurchase Agreements by Broker-Dealers." A repurchase agreement (Repo or RP) is a sale of high grade securities (usually U.S. Treasury or Government Agency issues) under a simultaneous agreement to buy back the same or similar securities at a specified time and price. The party in the transaction that buys the securities under an agreement to resell them is said to be doing a reverse Repo. The report describes how Repos have been used by registered brokers and dealers to finance their short-term liquidity needs, including those for purchases of government securities. The report analyzes how risks may be incurred in such transactions and describes the recent initiatives that have been taken by Congress and the SEC to improve the confidence in this important market.

### **ADMINISTRATIVE PROCEEDINGS**

#### ARTHUR JAMES HUFF SUSPENDED

Administrative Law Judge David J. Markun issued an initial decision suspending Senior Registered Options Principal (SROP) Arthur James Huff from association with any broker or dealer for 60 days. The suspension is based upon findings that Huff, from July 1979 to May 1980, while employed as a SROP of PaineWebber, Incorporated in the compliance department in New York, New York, failed reasonably to supervise the firm's branch manager in Miami, Florida, and a registered representative in the Miami branch, with a view to preventing various violations by those two individuals. The salesman, Dennis Greenman, was found to have committed a massive fraud in conducting a "short-term trading program" in options that resulted in losses of some \$7.6 million in customer accounts during the relevant period.

Judge Markun rejected Respondent's arguments that as SROP he had purely an advisory role and therefore was not responsible for reasonable supervision and that Sections 15(b)(6) and 15(b)(4)(E) of the Securities Exchange Act of 1934 as applied to him are unconstitutionally vague.

The initial decision is subject to review by the Commission on its own motion or on petition of a party.

### MARY S. KATA SUSPENDED

The Commission entered an Order Making Findings and Imposing Remedial Sanctions against Mary S. Kata, based on her consent, submitted without admitting or denying the findings contained in the Order. Administrative proceedings had been instituted against Kata on June 29.

The Commission found that between August 7 and September 23, 1985, Kata willfully aided and abetted violations by a broker-dealer of the recordkeeping, telegraphic notice, and financial reporting provisions of the Securities Exchange Act of 1934. She was found to have filed a monthly FOCUS Report with the NASD which failed to reflect account activity of the introducing broker whose accounts were carried on a fully disclosed basis.

Kata was suspended for six months from association in a proprietary or supervisory capacity with, or functioning as a principal for, any regulated entity, or from assuming responsibility for maintenance of books and records or filing of financial reports with the NASD or the Commission on behalf of any regulated entity. #### DECISION BARRING JOHN G. RINALDO FINAL

The decision of an administrative law judge barring John G. Rinaldo, of Los Angeles, from association with any investment adviser has become final. Rinaldo controlled Western State Pension Corporation, a registered investment adviser. According to the law judge's decision, Rinaldo was convicted in 1985 of mail fraud. In addition, he defrauded investors who purchased investment contracts from Western in the form of fractionalized interests in trust deeds, and was responsible for material misstatements and omissions in Western's registration application.
