U.S. SECURITIES AND EXCHANGE COMMISSION

AMENDMENT TO RULE 45 ADOPTED

Issue 87-244

The Commission adopted an amendment to Rule 45 under the Public Utility Holding Company Act of 1935. The amendment exempts from the requirement of a declaration certain routine agreements whereby a parent company in a registered holding company system guarantees, assumes joint liability upon, or acts as surety or indemnitor for the obligations of its subsidiary company. CRIMINAL PROCEEDINGS

ROBERT C. LABINE, SR. CONVICTED

The Chicago Regional Office and the U.S. Attorney's Office for the Eastern District of Michigan announced that on December 8 a federal jury convicted Robert C. LaBine, Sr. on three counts of mail fraud and one count of submitting a false loan application to a federally insured bank. The jury acquitted LaBine on eight counts of mail fraud and one count of conspiracy and acquitted Armand Dion, of Bloomfield, Michigan, on all counts. Sentencing for LaBine has not yet been scheduled. (U.S. v. Robert C. LaBine, et al., USDC EDMI, CR 87-80229 DT). (LR-11628)

INVESTMENT COMPANY ACT RELEASES

GUIDANCE INVESTMENTS, INC.

A notice has been issued giving interested persons until January 15, 1988 to request a hearing on an application filed by Guidance Investments, Inc. for an order declaring that it has ceased to be an investment company. (Rel. IC-16184 - Dec. 22)

CENTRAL POWER AND LIGHT COMPANY

The supplemental order authorizes an extension to December 31, 1990 of the period during which a remaining balance of 3,061,467 shares of common stock may be issued and sold pursuant to the Plan, as previously authorized.
