U.S. SECURITIES AND EXCHANGE COMMISSION

ADMINISTRATIVE PROCEEDINGS

BROADVIEW FINANCIAL CORPORATION CITED

The Commission issued an Order Instituting Proceedings under Section 15(c)(4) of the Securities Exchange Act of 1934 and Conclusion, Findings and Order against Broadview Financial Corporation, a Cleveland, Ohio savings and loan holding company. The Commission found that Broadview materially overstated income in its June 30 and September 30, 1982 quarterly reports and inappropriately recognized \$4 million as revenue from a real estate transaction in contravention of generally accepted accounting principles.

Broadview consented to the Order without admitting or denying any matters therein. Broadview was ordered to comply with Section 13(a) of the Exchange Act and Rules 13a-13 and 12b-20 and to comply with its undertakings, among other things, for three years, to have its: (a) independent auditors conduct an interim review of guarterly financial statements prior to filing with the Commission; and (b) Audit Committee review, on a quarterly basis, the accounting for all real estate transactions involving acquisition, development or construction loans in excess of \$5 million.
