CIVIL PROCEEDINGS

COMPLAINT NAMES RAN ENERGY, INC.

The Commission filed a civil injunctive action on July 29 in the U.S. District Court for the District of Columbia against Ran Energy, Inc. of Houston, Texas. The complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and other relief.

The Commission alleges that, as part of a continuing course of violative conduct extending over several years, Ran, in disregard of its statutory obligations, failed to file its Annual Report on Form 10-K for its fiscal year ended December 31, 1984, and its Quarterly Report on Form 10-Q for its fiscal guarter ended March 31, 1985, and filed later certain Annual and Quarterly Reports on Forms 10-K and 10-Q. The Commission requests that the Court order Ran to file its delinguent Annual and Quarterly Reports and enjoin it from further violations of the reporting provisions of the securities laws. (SEC v. Ran Energy, Inc., USDC DC, Civil Action No. 85-2415). (LR-10834)

ROBERT S. JONES ENJOINED

The Los Angeles Regional Office announced that on July 17 Judge Andrew A. Hauk, U.S. District of California, entered an Order of Permanent Injunction against Robert S. Jones. Jones consented to the order without admitting or denying the complaint's allegations. The injunction enjoins and restrains Jones from further aiding and abetting violations of: Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5; Sections 17(a)(1), (2) and (3) of the Securities Act of 1933; and Section 37 of the Investment Company Act.

The complaint alleged that from 1981 until August 1984, Jones misappropriated at least \$500,000 from various mutual fund accounts while employed with the transfer agent of the funds' manager. (SEC v. Robert S. Jones, USDC CDCA, Civil Action No. 85-4552). (LR-10835)

An amended order has been issued granting the application of the <u>New York Stock</u> Exchange, Inc. to strike the common stock, par value \$1.00; cumulative preferred stock, \$.50 convertible Series A; and subordinated debentures, due October 1, 1992, of LFE CORPORATION from listing and registration thereon. UNLISTED TRADING SOUGHT

A notice has been issued giving interested persons until August 16 to comment on the applications of the <u>Philadelphia Stock Exchange</u>, Inc. for unlisted trading privileges in one issue which is listed and registered on one or more other national securities exchange and is reported in the consolidated transaction reporting system. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved, on an accelerated basis, a proposed rule change filed by The Pacific Stock Exchange, Inc. (SR-PSE-85-18) to extend its pilot program for the appointment and evaluation of specialists and the creation of new specialist posts from June 30 to September 30, 1985. (Rel. 34-22263) AMENDMENT NO. 2 TO PROPOSED RULE CHANGE

The Chicago Board Options Exchange, Incorporated filed an amendment to a proposed rule change (SR-CBOE-85-16) to revise the retail automatic execution system pilot program for over-the-counter stocks to include such classes of stock options which the exchange deems appropriate. (Rel. 34-22270)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed under Rule 19b-4 by the National Association of Securities Dealers, Inc. (SR-NASD-85-16) which amends Schedules D and G of its By-Laws to add a new subsection that will require members to indicate whether a transaction involving a NASDAQ/NMS stock or a listed stock traded off-board is a buy, sell or cross.
