CIVIL PROCEEDINGS

J.D. ALLEN PERMANENTLY ENJOINED

The Fort Worth Regional Office announced that on December 10 Judge Wayne E. Alley, U.S. District Court for the Western District of Oklahoma, issued an order of permanent injunction against J.D. Allen, formerly president and director of Longhorn Oil and Gas Company, Oklahoma City, Oklahoma. The order permanently enjoins Allen from further violations of the registration and antifraud provisions of the securities laws. The judgment was rendered following a Motion for Default Judgment filed by the Commission and as a sanction for Allen's failure to provide or comply with discovery.

The August 1, 1984 complaint alleges that Allen violated the registration and antifraud provisions of the securities laws in the offer and sale of limited partnerships formed to invest in oil and gas properties and issued by Longhorn. Allen was a general partner for five of the limited partnerships. The complaint further alleges that in connection with the sales of these interests, Allen misrepresented and omitted to state certain material facts concerning, among other things; Longhorn's financial condition, production history and the status of oil and gas reserves.

The action is pending against the remaining defendants. (SEC v. J.D. Allen, et al., USDC WDOK, \$84-1938A). (LR-10963)

INVESTMENT COMPANY ACT RELEASES

COLONIAL PENN SERIES TRUST

The first mortgage bonds will be issued by Penelec to the trustee under the Authority Trust Indenture to finance the costs associated with certain pollution control facilities presently being constructed or to be constructed in connection with Penelec's Front Street, Homer City, Seward, Shawville, Warren and Williamsburg coal-fired generating stations.
