ENFORCEMENT PROCEEDINGS

STANLEY KERRY BARRED

The Commission announced today the entry of an Order in settlement of administrative proceedings previously instituted against Stanley Peter Kerry (Kerry) of Newington, Connecticut, an investment adviser registered with the Commission. The Order finds that, in or about October 1990, Kerry misappropriated a client's funds for his personal use. The Order also finds that, between at least October 1990 and October 1993, Kerry failed to disclose that he maintained custody of client funds, failed to keep true, accurate and complete records of cash receipts and disbursements, including the receipt and disbursement of client funds, failed to have an independent accountant conduct a surprise audit and verification of client funds and securities in his possession and custody, and, between April 1992 and April 1994, failed to file annual supplements on Form ADV-S in a timely manner.

The Order revokes Kerry's investment adviser registration, bars him from association with any broker, dealer, municipal securities dealer, investment adviser or investment company, and orders him to cease and desist from committing or causing future violations. Kerry consented to the entry of the Order without admitting or denying the Commission's findings. (Rel. Nos. 33-7261; 34-36767; IC-21707; IA-1550)

PUBLIC ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST JOSEPH AARON

The Commission instituted public administrative proceedings against Joseph M. Aaron pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act).

The Order Instituting Proceedings (Order) alleges that Aaron was enjoined on January 11 from future violations of Section 17(a) of the Securities Act of 1933, Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. The Commission's complaint in that civil action alleged that, from October 1990 through October 1992, while Aaron was a registered representative of a registered broker dealer, Aaron and Chartwell Financial raised approximately \$16 million by investment trust notes through 12 broker-dealers to approximately 400 investors. While offering and selling the promissory notes issued by the trusts, Aaron and Chartwell made misrepresentations and omissions of material facts regarding certain risk-reducing features of the investments. Aaron offered to settle the administrative proceedings. The Commission ordered that Aaron be suspended for a period of twelve months from association with any broker, dealer, municipal securities dealer, investment adviser or investment company and that he comply with certain undertakings in his offer of settlement. JUDGMENT SETTING AMOUNTS OF DISGORGEMENT AND CIVIL PENALTIES ENTERED IN COMMISSION'S LITIGATION AGAINST JAMES HAMMONDS AND RAYMOND GROSS

On January 17, United States District Court Judge Harry L. Hupp of the Central District of California, entered a Judgment Setting Amounts of Disgorgement and Civil Penalties against Defendants James E. Hammonds (Hammonds) and Raymond C. Gross (Gross) following the granting of the Commission's summary judgment motion.

The Court found that Hammonds and Gross, through Southern California Securities, Inc. (SCSI), a broker-dealer formerly registered with the Commission, raised over \$4.07 million through a scheme involving the fraudulent offer and sale of unregistered limited partnership interests. The Court also found that Hammonds and Gross misrepresented that investor funds would be used for oil and gas operations and investing in "U.S. Government obligations" and that in fact, Gross and Hammonds misused and misappropriated substantial amounts of investor funds to pay themselves, among others.

The Judgment orders Hammonds and Gross to disgorge their ill-gotten gains, together with prejudgment interest thereon. The Judgment orders disgorgement of \$602,561 from Hammonds and \$652,162 from Gross. The Judgment further orders Hammonds to pay civil penalties in the amount of \$602,561 and Gross to pay civil penalties in the amount of \$652,162. [SEC v. SARAH DELANEY ORDERED TO TRANSFER HER HOME FOR THE BENEFIT OF INVESTORS OR BE INCARCERATED

The Commission announced that on January 18 the Honorable Horace Gilmore, U.S. District Court Judge for the Eastern District of Michigan, ordered Defendant Sarah Delaney to assign her redemption

rights in her foreclosed home and execute a quitclaim deed to the Conservator appointed in the litigation or be incarcerated until such action is taken. The Commission had filed a Contempt motion against Delaney on January 8, 1996, alleging that Delaney had misrepresented the value of her home by claiming that it was in foreclosure and that there was no equity in the home. Commission staff learned that in fact the home has equity valued at over \$100,000 and requested that the Court order Delaney to assign her redemption rights in her home to the Conservator, so that the asset would not be lost. Additionally, Delaney was ordered to execute a quitclaim deed for the home so that the Conservator can sell the home for the benefit of investors. Previously, Delaney had been ordered to pay disgorgement and prejudgment interest in the amount of \$323,196.50. Pursuant to a previous Contempt motion by the Commission, Delaney had turned over her cash assets of approximately \$1000 and claimed she had no other assets from which to pay disgorgement. [SEC v. INVESTMENT COMPANY ACT RELEASES

GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Great-West Life & Annuity Company (GWL&A), Maxim Series Account (Separate Account), and The Great-West Life Assurance Company from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The order provides exemptions to the extent necessary to permit GWL&A to deduct a mortality and expense risk charge from the assets of the Separate Account in connection with the offer and sale of certain flexible premium variable annuity contracts issued with a guaranteed death benefit (Contracts), and any contracts (Future Contracts) offered in the future by the Account which are substantially similar in all material respects to the Contracts; and the assets of separate accounts established in the future by GWL&A--which are substantially similar to the Separate Account--in connection with the offer and sale of Contracts and Future Contracts. DFA INVESTMENT DIMENSIONS GROUP INC., ET AL.

An order has been issued on an application filed by the DFA Investment Dimensions Group Inc., et al., under Section 6(c) of the Investment Company Act for an exemption from Section 12(d)(1) of the Act, pursuant to Sections 6(c) and 17(b) of the Act for an exemption

from Section 17(a) of the Act, and pursuant to Section 17(d) and Rule 17d-1 thereunder permitting certain joint transactions. The order would permit an open-end management investment company, DFA International Asset Allocation Fund, to invest substantially all its assets in the shares of another open-end management investment company, The DFA Investment Trust Company. (Rel. IC-21701 - January 24)

MUNIVEST FLORIDA FUND II

A notice has been issued giving interested persons until February 20 to request a hearing on an application filed by MuniVest Florida Fund II for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-21702 - January 24)

MUNINIVEST NEW JERSEY FUND II, INC.

A notice has been issued giving interested persons until February 20 to request a hearing on an application filed by MuniVest New Jersey Fund II, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-21703 - January 24)

MUNIVEST CALIFORNIA FUND, INC.

A notice has been issued giving interested persons until February 20 to request a hearing on an application filed by MuniVest California Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-21704 - January 24)

VAN KAMPEN AMERICAN CAPITAL BOND FUND, INC., ET AL.

A notice has been issued giving interested persons until February 20 to request a hearing on an application filed by Van Kampen American Capital Bond Fund, Inc., et al. seeking to amend a prior order under Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder that permitted the establishment of a joint trading account in repurchase agreements. The amended order would permit certain open-end management investment companies advised by Van Kampen American Capital Investment Advisory Corp. to participate in the joint trading account. (Rel. IC-21705 - January 24)

TOTAL GROWTH TRUST

A notice has been issued giving interested persons until February 20 to request a hearing on an application filed by Total Growth Trust for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-21706 - January 24)

HOLDING COMPANY ACT RELEASES

SYSTEM ENERGY RESOURCES, INC.

A supplemental order has been issued authorizing System Energy Resources, Inc., a subsidiary of Entergy Corporation, a registered holding company, to acquire nuclear fuel by lease in amounts of up to \$250 million. (Rel. 35-26459)

LOUISIANA POWER & LIGHT COMPANY

A supplemental order has been issued authorizing Louisiana Power & Light Company, a subsidiary of Entergy Corporation, a registered holding company, to acquire nuclear fuel by lease in amounts of up to \$160 million. (Rel. 35-26460)

ARKANSAS POWER & LIGHT COMPANY

A supplemental order has been issued authorizing Arkansas Power & Light Company, a subsidiary of Entergy Corporation, a registered holding company, to acquire nuclear fuel by lease in amounts of up to \$250 million. (Rel. 35-26461)

A proposed rule change filed by the <u>Boston Stock Exchange</u> to modify the BSE's Transaction Fee Schedule (SR-BSE-96-01) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal</u> <u>Register</u> during the week of January 29.
