ENFORCEMENT PROCEEDINGS

MONTGOMERY MEDICAL VENTURES, L.P., ET AL. CONSENT TO CEASE-AND-DESIST ORDERS FOR BENEFICIAL OWNERSHIP REPORTING VIOLATIONS

On June 24, the Commission issued Orders pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) against Montgomery Medical Ventures, L.P., Montgomery Medical Partners, L.P., Montgomery Medical Ventures II, L.P., Montgomery Medical Partners II, L.P. (Montgomery entities), Propper, and Olshansky, requiring them to cease and desist from committing or causing any violations or future violations of Sections 13(d), 13(g) and 16(a) of the Exchange Act and Rules 13d-1, 13d-2, 16a-2, 16a-3, and former Rule 16a-1 thereunder. MMV and MMVII are venture capital limited partnerships and MMP and MMPII are the general partners of such partnerships. Propper and Olshansky were the general partners of MMP and MMPII. The respondents, without admitting or denying the allegations in the Commission's Orders, consented to the entry of the Orders finding that: the Montgomery entities failed to timely file nineteen Forms 3 and amendments thereto, thirty Forms 4, a Form 5, and four Schedules 13D and 13G and twenty amendments thereto; Olshansky failed to timely file eight Forms 3 and amendments thereto, thirteen Forms 4, and four Schedules 13D and 13G and twenty amendments thereto; and Propper failed to timely file nine Forms 3 and amendments thereto, thirty-five Forms 4, and four Schedules 13D and 13G and thirteen amendments thereto. The combined value of the transactions by the Montgomery entities, Propper and Olshansky on late Forms 4 is \$7.6 million, \$1.4 million, and \$1.3 million, respectively.

Simultaneously with the entry of the Commission's Order, the Commission filed a civil action pursuant to Section 21(d)(3) of the Exchange Act seeking from each of the Montgomery entities a \$15,000 civil penalty, for a total of \$60,000. Without admitting or denying the Commission's allegations, the Montgomery entities consented to entry of a final judgment imposing the penalties. [SEC v. No. 96-1444, JHG, D.D.C.] (Rel. 34-37352, LR-14959; Rel. 34-37354 (Propper); and Rel. 34-37353 (Olshansky)) NEW YORK STOCK EXCHANGE DISCIPLINARY ACTION AGAINST RALPH PRESUTTI SUSTAINED IN PART

The Commission has sustained in part disciplinary action taken by the New York Stock Exchange against Ralph Joseph Presutti of Wethersfield, Connecticut. The NYSE action was based on Presutti's effecting securities transactions on behalf of customers who were acting on the basis of material, non-public information contained in copies of <u>Business Week</u> magazine that the customers obtained in advance of the magazine's release to the public. Presutti did not trade on this information for his own account. The Exchange found that this conduct was inconsistent with just and equitable principles of trade and violated Section 10(b) of the Securities Exchange Act and Rule 10b-5 thereunder. Presutti was censured and suspended for two months.

The Commission upheld the Exchange's finding that the conduct was inconsistent with just and equitable principles of trade. In light of Presutti's experience, it was reckless to ignore without further inquiry a number of indications of possible wrong-doing by his customers. Because that finding supports the sanctions imposed, the Commission did not reach the Section 10(b) and Rule 10b-5 findings. (Rel. 34-37351)

INVESTMENT COMPANY ACT RELEASES

NATIONS FUND TRUST, ET AL.

A notice has been issued giving interested persons until July 19 to request a hearing on an application filed by Nations Fund Trust, et al. for an order under Section 6(c) of the Investment Company Act granting an exemption from Section 12(d)(1) of the Act and under Sections 6(c) and 17(b) of the Act granting an exemption from Section 17(a) of the Act. The requested order would permit Nations to create a "fund of funds" that would purchase shares of affiliated open-end investment companies in excess of the percentage limitations of Section 12(d)(1). ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission has granted approval of, and is publishing notice of and granting accelerated approval of an amendment to, a proposed rule change filed by the <u>Chicago Board Options Exchange</u> (SR-CBOE-96-19) relating to eligibility requirements for participation on the RAES system in SPX options. Publication of the approval order is expected in the <u>Federal Register</u> during the week of June 24. (Rel. 34-37348)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-CBOE-96-38) filed by the <u>Chicago Board</u> <u>Options Exchange</u> relating to the definition of expiration month for purposes of determining log-on obligations for RAES in SPX options has become effective. Publication of the filing is expected in the <u>Federal Register</u> during the week of June 24. (Rel. 34-37349)
