Consideration of whether to propose amendments to Form N-1A under the Investment Company Act of 1940 and the Securities Act of 1933, Rule 482 under the Securities Act of 1933, and Rule 34b-1 under the Investment Company Act of 1940. The amendments would improve disclosure to investors of the effect of taxes on the performance of open-end management investment companies ("mutual funds" or "funds"). Under the proposed amendments, mutual funds would be required to disclose standardized after-tax returns in the risk/return summary of the prospectus

and in Management's Discussion of Fund Performance, which is typically located in the annual report. The proposal also would require funds that choose to include after-tax returns in advertisements and other sales materials to include standardized after-tax returns For further information, contact Maura S McNulty, Division of Investment Management, at (202) 942-0721.
