RULE CHANGES ADOPTED IN CONNECTION WITH THE NEXT STAGE OF EDGAR MODERNIZATION

The Commission has issued a release adopting amendments to existing rules and forms in connection with the next stage of modernization of the Commission's Electronic Data Gathering, Analysis, and Retrieval (EDGAR) system

Beginning May 30, 2000, EDGAR will include the following new features

- * the ability to include graphic and image files in HTML documents;
- * the ability to use hyperlinks in HTML documents, including links between documents within a submission and to previously filed documents on our public web site EDGAR database at www.sec.gov; and
- * the addition of the Internet as an available means of transmitting filings to the EDGAR system.

The release removes the requirement for filers to submit Financial Data Schedules, effective January 1, 2001. It also removes diskettes as an available means of transmitting filings to the EDGAR system, effective July 10, 2000. All other rule changes are effective May 30, 2000.

ENFORCEMENT PROCEEDINGS

COMPLAINT FILED AGAINST ALAN GIBBONS

The Commission announced on April 12 a civil injunctive action was filed in the Northern District of Illinois against Alan C. Gibbons, seeking a permanent injunction from future violations of the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934, civil penalties, and disgorgement, including prejudgment interest

The complaint alleges that between September 1995 and March 1999, Gibbons, a recidivist securities laws violator, offered and sold approximately \$172,000 in stock and promissory notes issued by companies he formed and owned. The complaint alleges that Gibbons told investors their funds would be used for his companies However, the complaint alleges that Gibbons used the funds for personal expenses. The complaint alleges that Gibbons materially misrepresented to investors the use, safety, liquidity, and returns on the investments. The complaint alleges that Gibbons told investors that the investments were risk-free, guaranteed, and would produce large returns. For example, the complaint alleges that Gibbons told some investors that they would receive a return of 5% per month on their investments. However, the complaint alleges that Gibbons' companies conducted little or no business, lacked a guarantor, lacked sufficient liquid assets to pay the investors, and the investors received no returns on their investments. HOLDING COMPANY ACT RELEASES

NATIONAL FUEL GAS COMPANY, ET AL.

A supplemental order has been issued authorizing a proposal by National Fuel Gas Company (NFG), a registered holding company, and its utility and nonutility subsidiaries. The supplemental order allows NFR Power, Inc (Power), a nonutility subsidiary of NFG, limited participation in the NFG system money pool through December 31, 2002. The supplemental order also authorizes NFG to include Power in its existing guarantee authority that consists of guaranteeing securities of, and providing other forms of credit support with respect to the obligations of, NFG's subsidiaries in a maximum amount not to exceed \$2 billion at any one time through December 31, 2002. ENERGY EAST CORP., ET AL.

A notice has been issued giving interested persons until May 16, 2000, to request a hearing on a proposal by Energy East Corp., a holding company exempt from registration under Section 3(a)(1) of the Act, to acquire by merger, CMP Group, Inc., a holding company exempt from registration under Section 3(a)(1) of the Act, CTG Resources, Inc., a holding company exempt from registration under Section 3(a)(1) by Rule 2 under the Act, and Berkshire Energy Resources, a holding company exempt from registration under Section 3(a)(2) by Rule 2 under the Act. Energy East will register with the Commission as a public utility holding company under Section 5 of the Act. (Rel. 35-27171)
