COMMISSION ANNOUNCEMENTS

SUSAN NASH NAMED ASSOCIATE DIRECTOR OF THE DIVISION OF INVESTMENT MANAGEMENT

Securities and Exchange Commission Director of Investment Management Paul F. Roye today named Susan Nash as Associate Director for Disclosure and Insurance Product Regulation. In her new position, Ms. Nash will be responsible for policy initiatives relating to disclosure by mutual funds and other investment companies, as well as the regulation of variable annuities and variable life insurance.

SEC Chairman Levitt said, "Susan has outstanding judgment and dedication. I am delighted that we will continue to benefit from the breadth and depth of her knowledge and experience relating to the securities markets and the mutual fund and variable insurance industries."

Paul F. Roye, Director of the Division of Investment Management, said, "Susan has made invaluable contributions on many of the most pressing policy issues confronting the mutual fund industry, and she has been instrumental in crafting effective and pragmatic regulatory approaches to the growing and dynamic variable insurance market. She brings tremendous energy, outstanding legal skills, and a wealth of experience to her new position."

Ms. Nash joined the Commission's Office of General Counsel in 1989, where she played a key role in the Commission's program of technical assistance to emerging market countries and other international matters. She also served as counsel to former Chairman Richard C. Breeden.

Since 1993, Ms. Nash has been a member of the Division of Investment Management, where she has had a major part in many important policy initiatives. Most recently, she played a lead role on the Commission's after-tax return proposal, mutual fund governance initiatives, and technology issues, as well as the Commission's examination of bonus variable annuity products.

Prior to joining the Commission, Ms. Nash was an attorney specializing in tax, corporate, and securities law at the Washington, D.C. law firm of Covington & Burling. Ms. Nash holds a J.D. from Harvard Law School, an M.A. from the University of Chicago, and a B.A. from The University of Notre Dame. (Press Rel. 2000-93)

ENFORCEMENT PROCEEDINGS

IN THE MATTER OF MARSHALL MELTON AND ASSET MANAGEMENT & RESEARCH, INC.

Administrative Law Judge James T. Kelly issued an initial decision today in the above-referenced matter. The Commission's Order Instituting Public Proceedings (OIP) alleged that the United States District Court for the Middle District of North Carolina permanently enjoined Marshall E. Melton and Asset Management & Research, Inc. (AMR), a registered investment adviser, on May 4, 1998. The district court found that Mr. Melton and AMR violated Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act), and Rule 10b-5 thereunder. The district court order also found that AMR, aided and abetted by Mr. Melton, violated Section 206 of the Investment Advisers Act. The administrative proceedings were instituted in order to determine whether the allegations in the OIP were true and, if so, whether sanctions ought to be imposed in the public interest.

Judge Kelly barred Marshall E. Melton from association with any broker, dealer, member of a national securities exchange, or registered securities association pursuant to Sections 15(b) and 19(h) of the Exchange Act and Section 203(f) of the Advisers Act; and revoked the registration of AMR pursuant to Section 203(e) of the Advisers Act. COURT ENTERS JUDGMENT AGAINST GATEWAYS TO SPACE SALES AGENT FOR OFFERING FRAUD

United States District Judge Maxine M. Chesney entered judgment against Stephen L. Boyd of Chico, California, for his role in a fraudulent sale of unregistered stock in Gateways to Space, Inc. The judgment, entered June 20, 2000, forbids Boyd from violating the antifraud and registration provisions of the federal securities laws and requires him to pay disgorgement of \$102,084 and a civil money penalty of \$50,000.

The Commission alleged in its action that Boyd was employed by Gateways owner Louis Karabochos in 1995 to sell unregistered, restricted Gateways stock to investors. Gateways, a company formerly based in Pleasanton, California, marketed videotapes about space exploration. Boyd and others sold Gateways stock to over 850 investors nationwide. Investors lost approximately \$5 million when the company collapsed. In selling the stock, Boyd failed to disclose that he was being paid commissions on the sales. Indeed, when asked about commissions by some investors, Boyd denied that he was being paid commissions.

The judgment enjoins Boyd from future violations of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(a) of the Securities Exchange Act of 1934 and Rule 10b-5. CIVIL ACTION AGAINST REFAEL SHAOULIAN

The Commission announced that on May 3, 2000, the U.S. District Court for the Central District of California issued a temporary restraining order against 24 year-old Refael Shaoulian (Shaoulian) barring him from violations of the antifraud provisions of the federal securities laws. The Court, also on May 3rd, issued an asset freeze against Shaoulian and his father, Samuel Shaoulian.

In its original complaint filed on May 3rd (Original Complaint), the Commission alleged that Shaoulian used the Internet to manipulate the price of a thinly traded stock by spreading false information to various Internet message boards, allowing him to reap more than \$172,000 in trading profits. The Original Complaint, also named Shaoulian's father, Samuel Shaoulian, as a relief defendant based on his receipt of ill-gotten gains from the manipulation. Based upon evidence of additional manipulations by Shaoulian, on July 6, 2000, the Commission filed an amended complaint (Amended Complaint) charging that from April 1999 through July 1999, Shaoulian engaged in virtually identical Internet pump and dump schemes involving four additional stocks. With these four additional stock manipulations charged against Shaoulian, the Commission is seeking more than \$388,000 in disgorgement from Shaoulian, his father and brother, as The Amended Complaint also names well as civil penalties against Shaoulian. Shaoulian's brother, Rabin Shaoulian of Beverly Hills, as a relief defendant because he received some of the ill-gotten gains from the manipulations.

According to the Commission's Original Complaint, in January 2000, Shaoulian manipulated the common stock price of Universal Standard Healthcare, Inc. (Universal), a stock traded through the NASD's OTC Bulletin Board system, by posting numerous false messages on Internet message boards. The complaint alleges that Shaoulian, a 24 year-old Beverly Hills resident and UCLA graduate, obtained more than \$172,000 in profits from his Internet pump and dump manipulation of Universal stock. Shaoulian did so by first buying a large block of Universal shares between January 24 and 26, 2000. According to the complaint, during the weekend of January 29th and 30th, Shaoulian posted hundreds of messages, under multiple pseudonyms, to Internet financial message boards using publicly available computers located on the UCLA campus. messages falsely stated that Universal was about to be purchased by another company and that Universal was profitable. In fact, Universal had ceased all operations in August 1999, when it filed for Chapter 7 bankruptcy protection. Universal's stock price closed at \$0.03 per share on January 21, 2000, and peaked at \$1.50 per share within the opening hour of trading on January 31st, before declining precipitously. On January 31 and February 1, 2000, Shaoulian sold all his Universal shares for a \$172,690 profit. After Shaoulian's Internet message campaign ended, Universal's price plummeted. Based on this conduct, the Commission in its complaint sought a temporary restraining order and a preliminary and permanent injunction barring Shaoulian from future violations of the antifraud provisions of the federal securities laws, disgorgement of ill-gotten gains, and civil monetary penalties. On May 11th, the Court, with Shaoulian's consent, entered a preliminary injunction against him and continued the asset freeze.

The Amended Complaint alleges that Shaoulian manipulated the stock of: iChargeit, Inc., Worldtradeshow.com, Inc., Casino Pirata.com Ltd. and E*TwoMedia.com, Inc. Each of these stocks traded on the OTC Bulletin Board at the time of these manipulations. In each instance, the Commission alleges that Shaoulian purchased a substantial block of shares in these companies, posted hundreds of false messages about each company to various Internet message boards using publicly available computers at the campuses of UCLA and the University of Southern California and then sold his own shares into the buying surge prompted by the false Internet messages. In each instance, Shaoulian obtained substantial profits.

In a related action, the Commission today announced civil charges against two other individuals who, it alleged, participated in the manipulations of iChargit, Worldtradeshow.com, Casino Parata.com, E*TwoMedia.com and other issuers (See, SEC v. Aziz Golshani, et al., Civ. Action No. 99-13139, CBM, AJWx, C.D. Cal., LR-16620, July 6, 2000).

FINAL JUDGMENTS ISSUED AGAINST ROBERT DALTON AND JAMES MASINI

On June 7, the Honorable Richard A. Paez, United States Circuit Judge sitting by designation for the Central District of California, issued Final Judgments of Permanent Injunction and Other Relief (Final Judgments) against defendants Robert J. Dalton (Dalton) and James L. Masini (Masini). The Final Judgments permanently enjoin Dalton and Masini from future violations of the antifraud and registration provisions of the federal securities laws. The Final Judgments also order Dalton and Masini to pay disgorgement of \$677,339 and \$179,500, respectively, but waive payment due to their financial inability to pay, except that Masini is required to disgorge a modest amount.

The Commission's complaint alleged that, from 1995 to 1998, the defendants engaged in the fraudulent offer and sale of unregistered securities in connection with a California worm farming business operated by Ecology Farms Management, Inc. The defendants raised approximately \$8.5 million from more than 250 investors nationwide. The complaint alleged that Dalton and Masini violated the antifraud provisions of Section 17(a) of the Securities Act of 1933 (Securities Act), Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder and the securities registration provisions of Sections 5(a) and 5(c) of the Securities Act, and also alleged that Dalton violated the broker-dealer registration provisions of Section 15(a) of the

HOLDING COMPANY ACT RELEASES

GPU, INC.

An order has been issued authorizing GPU, Inc. (GPU), a registered holding company, to acquire securities in a nonutility subsidiary UMICO Holdings, Inc. (UMICO). GPU and its subsidiaries purchase workers compensation insurance from Utilities Mutual Insurance Company (UMI), a captive mutual insurer. UMI plans to convert from a mutual company to a stock company. Once UMI becomes a stock company, each policy holder will receive shares of common stock of a newly formed holding company, UMICO, in proportion to their current ownership interest in UMI. GPU seeks to acquire approximately 36% interest in UMICO. (Rel. 35-27196)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-NASD-00-40) filed by the National Association of Securities Dealers relating to mandatory decimal pricing testing has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of July 3. (Rel. 34-43003)

PROPOSED RULE CHANGE

The Chicago Stock Exchange filed a proposed rule change (SR-CHX-00-08) to establish a Board review process for decisions of the Exchange's Committee on Specialist Assignment and Evaluation regarding specialist firm consolidations.
