CHANGE IN THE MEETING: CANCELLATION

The closed meeting scheduled for Thursday, November 2, 2000, at 11:00 a.m. has been cancelled.

ENFORCEMENT PROCEEDINGS

COMMISSION DENIES PETITION OF MICHAEL MARKOWSKI AND JOSEPH RICCIO FOR RECONSIDERATION

The Commission has denied the petition of Michael J. Markowski and Joseph F. Riccio for reconsideration of its decision sustaining disciplinary action taken against them by the NASD. The NASD censured Markowski and Riccio, barred them from association with any NASD member, and fined Markowski \$300,000 and Riccio \$250,000.

Markowski was chairman, chief executive officer, and majority shareholder of Global America, Inc., a former NASD member firm located in New York City. Riccio was Global's trader. The Commission found that, during the period June 1990 to January 1991, respondents manipulated the market for securities of Mountaintop Corporation and published non-bona fide bids for those securities. The Commission also found that Markowski violated a restriction agreement between his firm and the NASD, and that Markowski refused to submit timely to an NASD investigative interview.

In rejecting respondents' petition for reconsideration, the Commission found that all of respondents' objections to its decision were lacking in merit. (Rel. 34-43503; File No. 3-9671)

COURT **ORDERS** PERMANENT INJUNCTION AGAINST **AMQUEST** INTERNATIONAL, LTD., DAVID MORGENSTERN AND FRED MORGENSTERN AND APPOINTS SPECIAL MASTER

The Commission announced today that on October 18, 2000, Judge Patricia A. Seitz entered an order of permanent injunction and other relief against Amquest International, Ltd. (Amquest), a Fort Lauderdale, Florida financial services firm and two affiliated individuals for engaging, throughout 1996, in offering fraud and an attempted pump and The Court ordered that the three defendants pay \$3,750,000 in disgorgement within 30 days and appointed a Special Master to conduct a pro-rata distribution of the funds to investors. Judge Seitz also ordered that the individuals David Morgenstern (D. Morgenstern) and Fred Morgenstern (F. Morgenstern), both aged 51 and of Boca Raton, Florida, each pay a civil penalty of \$20,000 within 30 days. Amquest and the two individuals consented to the entry of the order without admitting or denying the allegations of the Commission's complaint.

The Commission alleged in its complaint that Amquest, D. Morgenstern, F. Morgenstern and defendant Bernadette Stevens (Stevens), engaged in securities fraud in connection with a private offering of common stock by Amquest, which resulted in approximately \$4.1 million in losses to investors. The Court's order did not resolve the relief sought from Stevens. In its complaint, the Commission alleged that, in the offer and sale of Amguest's securities, Amguest, D. Morgenstern, F. Morgenstern and Stevens used fraudulent offering documents calculated to deceive prospective investors through misleading representations and omissions.

The SEC further charged in its suit that the defendants misappropriated the bulk of the Amquest offering proceeds, including approximately \$700,000 in proceeds from a related offering of stock issued by SleepSource International, Ltd. The complaint alleged D. Morgenstern and F. Morgenstern used the offering proceeds to fund an attempted scheme to inflate artificially the price of Amquest stock by engaging in prearranged trades in nominee brokerage accounts. [SEC v.
