ENFORCEMENT PROCEEDINGS

COURT APPOINTS TEMPORARY RECEIVER FOR BRYCAR FINANCIAL CORPORATION

On November 13, the Honorable Lloyd D. George of the U.S. District Court for the District of Nevada entered an order appointing Las Vegas attorney John E. Ham as temporary receiver for defendant BryCar Financial Corporation in the Commission's action against BryCar, its president, Bryan J. Egan, and relief defendant Carol A. Egan. The Commission alleges that BryCar and Egan engaged in fraudulent activities and offered or sold securities while failing to be registered with the Commission as a broker-dealer. Defendants consented to the appointment of the temporary receiver.

The Court's order provides, among other things, that as temporary receiver, Mr. Ham has the authority to take immediate custody and control of all assets of BryCar. Moreover, the order empowers Mr. Ham to search for any hidden or undisclosed assets of BryCar. By the terms of the order, the temporary receiver shall file with the Court a summary report based upon his investigation and shall also report upon whether continuance of the receivership is necessary. The Court additionally ordered that no defendant shall take any action which would interfere with the temporary receiver's actions to discharge his duties.

PERMANENT INJUNCTION ENTERED AGAINST TAMARACK FUNDING CORP. AND GARRY ISAACS

The Commission announced that on September 20, 2000, the United States District Court for the Southern District of Florida entered a final judgment of permanent injunction against Tamarack Funding Corporation, a Texas corporation (TFC of Texas), Tamarack Funding Corporation, a Florida corporation (TFC of Florida) (collectively, TFC), and Garry P. Isaacs (Isaacs), their president, for fraud and for selling unregistered securities. TFC and Isaacs, without admitting or denying the SEC's allegations, consented to the Court Order that permanently enjoins them from violating Sections 5(a), 5(c), and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder.

The Commission filed a complaint on May 31, 2000 alleging that the defendants fraudulently raised approximately \$4.7 million from investors nationwide by offering and selling unregistered securities in the form of interest-bearing "promissory notes." According to the complaint, investors were told that their funds would be used to purchase retail automobile installment loan contracts (vehicle loans) and that their investment would be 100% collateralized. Contrary to these representations, the complaint alleged that only \$1.4 million was actually used by TFC to purchase vehicle loans. According to the SEC, the remaining portion of investor funds was used to pay TFC's operating costs and unrelated expenses. The complaint further alleged that TFC used some investor funds to repay interest to existing investors and was thereby engaged in a Ponzi scheme. In addition, the compliant alleged that investors funds were not 100% collateralized.

As a result, the Commission charges TFC of Texas, TFC of Florida, and Isaacs with violations of the registration and antifraud provisions. For relief, the Commission continues to seek accountings, disgorgement of ill-gotten gains with prejudgment interest, and civil penalties.

Also named in the lawsuit as relief defendants were two companies, controlled and owned by Isaacs, that received over \$4 million in investor funds. These entities are Tamarack Lender's Trust and Tamarack Capital Management Corp. [SEC v. Tamarack Funding Corporation and Garry P. Isaacs, Civil Action No. 00-6730, S.D. Florida] (LR-16811)

CIVIL ACTION AGAINST STEPHEN COWLEY

The Commission today announced that on November 28 it charged Stephen J. Cowley, a British subject and resident, with insider trading in the securities of 4Front Technologies, Inc., in advance of the August 3, 2000 public announcement that NCR Corporation would acquire 4Front. At the same time that the complaint was filed, the Commission sought a temporary restraining order freezing Cowley's assets located in the United States. The Honorable John G. Koeltl, United States District Judge in the Southern District of New York, issued an order, with Cowley's consent, freezing all assets located in the United States with the exception of \$10,000 that Cowley could use to retain counsel. The frozen assets include a brokerage account maintained by Cowley at Salomon Smith Barney that held assets worth over \$280,000 as of yesterday. The Commission's complaint alleges that in the three weeks immediately preceding the 4Front/NCR merger announcement, Cowley purchased 8,000 shares of 4Front common stock and 460 call options at a cost of over \$250,000. After the announcement on August 3, Cowley sold his entire position of 4Front securities realizing illicit trading profits of \$127,288. The complaint alleges that Cowley had highly specific knowledge of material nonpublic information which was revealed in a series of tape-recorded conversations Cowley had with his broker when he purchased the 4Front securities. The complaint alleges that in these conversations Cowley was concerned that his purchases not generate scrutiny; expressed his desire to purchase as many 4Front securities as he could afford; and revealed his knowledge of material nonpublic information concerning the merger negotiations, including information about the price of the proposed transaction, and the timing of the contemplated agreement and announcement. The Commission alleges that Cowley violated Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. INVESTMENT COMPANY ACT RELEASES

NATIONAL LIFE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 26(b) of the Investment Company Act to National Life Insurance Company (NLIC), National Variable Annuity Account II (Annuity Account), and National Variable Life Insurance Account (Life Account) (collectively, Applicants) approving the substitution of securities issued by certain management investment companies and held by either the Annuity Account or the Life Account to support variable annuity contracts or variable life insurance contracts issued by NLIC. The order also grants exemptions to the Applicants, Market Street Fund, Inc. (MSF) and Sentinel Variable Products Trust (SVPT), and certain investment portfolios of each, from Section 17(a) of the Act to the extent necessary to permit NLIC to carry out certain of the above-referenced substitutions of securities by redeeming shares issued by MSF in kind and using the proceeds to purchase shares issued by SVPT. HOLDING COMPANY ACT RELEASES

APPALACHIAN POWER COMPANY

An order has been issued authorizing Appalachian Power Company, an electric publicutility subsidiary company of American Electric Power Company, Inc., a registered holding company, to effect the refunding of \$10 million of pollution control revenue bonds issued in connection with the financing of certain pollution control facilities. (Rel. 35-27282)

APPALACHIAN POWER COMPANY

An order has been issued authorizing Appalachian Power Company, an electric publicutility subsidiary company of American Electric Power Company, Inc., a registered holding company, to effect the refunding of \$17.5 million of pollution control revenue bonds issued in connection with the financing of certain pollution control facilities. (Rel. 35-27283)

CP&L ENERGY, INC.

The Commission has issued an order approving an application-declaration by CP&L Energy, Inc. (CP&L Energy), a North Carolina holding company exempt from registration under Section 3(a)(1) of the Act by Rule 2, and Florida Progress Corporation (Florida Progress) in connection with a proposed acquisition of Florida Progress by CP&L Energy. Following the acquisition, CP&L Energy will register as a holding company under Section 5 of the Act. The order authorizes CP&L Energy, following the acquisition, to retain ownership of certain of its and Florida Progress' nonutility businesses and reserves jurisdiction over others. The order further provides that investments in nonutility businesses made prior to the acquisition will not be counted in the calculation of the 15% investment limitation of Rule 58. The order exempts Florida Progress from registration under Section 3(a)(1) of the Act following the acquisition. Finally, the order approves the organization of a CP&L Energy system service company and approves the pricing of certain coal supply agreements. (Rel. 35-27284)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted under Rule 19b-4 by the <u>New York Stock Exchange</u> (SR-NYSE-00-36) extending the pilot fee structure governing the reimbursement of member organizations for costs incurred in the transmission of proxy and other shareholder communication materials and amending the components of coordination activities through September 1, 2001. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 27. (Rel. 34-43603)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission, under Rule 19b-4 of the Securities Exchange Act of 1934, has granted accelerated approval to a proposed rule change (SR-CSE-00-05) and Amendment No. 1 thereto by the Cincinnati Stock Exchange, Incorporated to provide for the listing and trading of certain Trust Issued Receipts. (Rel. 34-43604)

The Commission, under Rule 19b-4 of the Securities Exchange Act of 1934, has granted accelerated approval to a proposed rule change (SR-CSE-00-06) and Amendment No. 1 thereto by the Cincinnati Stock Exchange, Incorporated to provide for the listing and trading of certain Index Fund Shares. (Rel. 34-43620)

The Depository Trust Company filed a proposed rule change (SR-DTC-00-13) under Section 19(b)(1) of the Exchange Act to clarify its policy (i) not to make an offeror's information about a low volume tender offer available to participants through DTC's Reorganization Inquiry for Participants System unless the offeror uses DTC's Automated Tender Offer Program (ATOP) to process the offer and (ii) not to make securities available to the offeror at the conclusion of a low volume tender offer processed through ATOP until DTC has received payment for the securities from the offeror. The Commission has approved the proposed rule change on an accelerated basis. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 27. (Rel. 34-43624)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-PCX-00-44) filed by the <u>Pacific Exchange</u> relating to committee voting requirements has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 27. (Rel. 34-43619)
