## **ENFORCEMENT PROCEEDINGS**

# COMMISSION SANCTIONS H.J. MEYERS & CO., INC. FOR MARKET MANIPULATION

The Commission entered an Order Making Findings and Imposing Remedial Sanctions, and Cease And Desist Order Against H.J. Meyers & Co., Inc. (H.J. Meyers). H.J. Meyers, while neither admitting nor denying the Order's findings, consented to the entry of the Order and the imposition of sanctions against it. During the relevant time period, H.J. Meyers, based in Rochester, NY, was a broker-dealer registered with the Commission, and had 15 offices across the United States, and employed approximately 700 employees.

On June 24, 1996, H.J. Meyers underwrote the initial public offering (IPO) of Borealis Technology Corporation (Borealis), a small capitalization company. H.J. Meyers sold approximately 1.9 million, or 80%, of the Borealis IPO shares to its retail customers. The Order finds that H.J. Meyers manipulated the price of Borealis stock by effecting a series of transactions in which it purchased a total of approximately 914,405 Borealis shares and sold approximately 1,048,253 Borealis shares, and by raising the price of Borealis from the IPO price of \$5.00 to \$8.49. The Order further finds that H.J. Meyers fraudulently sold Borealis shares to its customers at undisclosed, excessively marked up prices by basing its markups on inside interdealer ask prices rather than on its contemporaneous cost, and failing to disclose the size of the markups it was charging on the Borealis stock.

The Order finds that H.J. Meyers's conduct violated Section 17(a) of the Securities Act of 1933 (Securities Act) and Sections 10(b) and 15(c)(1) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 10b-5, 15c1-2, and 15c1-8 thereunder. The Order requires H.J. Meyers to cease and desist from committing or causing any current or future violations of Section 17(a) of the Securities Act and Sections 10(b) and 15(c)(1) of the Exchange Act and Rules 10b-5, 15c1-2, and 15c1-8 thereunder. The Order further requires disgorgement against H.J. Meyers in the amount of \$514,000. The obligation of H.J. Meyers shall be satisfied by a guaranteed dividend of \$50,000 pursuant to a further order of the bankruptcy court in H.J. Meyers & Co., Inc., No. 99-21107 (Bankr. W.D.N.Y.). ## SEC SETTLES FOREIGN CORRUPT PRACTICES ACT CASE AGAINST IBM

The Commission today announced the filing of a settled cease and desist proceeding against International Business Machines Corporation (IBM). The case involves violations of the books and records provisions of the Securities Exchange Act of 1934, resulting from presumed illicit payments to foreign officials by one of IBM's whollyowned subsidiaries during 1994. Without admitting or denying the Commission's findings, IBM consented to the entry of an Order that requires IBM to cease and desist from committing or causing any future violation of Section 13(b)(2)(A) of the Exchange Act. In addition, the Commission announced the filing of a complaint in the United States District Court for the District of Columbia against IBM seeking a civil money

penalty. Without admitting or denying the allegations in the complaint, IBM consented to the entry of a judgment ordering IBM to pay a \$300,000 penalty.

The Order finds that IBM violated Section 13(b)(2)(A) of the Exchange Act in connection with a \$250 million contract to integrate and modernize the computer system of a commercial bank owned by the Argentine government. According to the Order, certain former senior management of IBM-Argentina, S.A. ("IBM-Argentina"), a wholly-owned subsidiary of IBM, caused IBM-Argentina to enter into a subcontract with Capacitacion Y Computacion Rural, S.A. (CCR), and money paid to CCR by IBM-Argentina in connection with the subcontract was apparently subsequently paid by CCR to certain bank officials. Specifically, the Order finds that, during 1994 and 1995, IBM-Argentina paid CCR approximately \$22 million under the subcontract, of which at least \$4.5 million was transferred to several bank directors by CCR.

The Order further finds that, in connection with the subcontract, IBM-Argentina's former senior management overrode IBM procurement and contracting procedures, and hid the details of the subcontract from the technical and financial review personnel assigned to the contract. In the Order, the Commission finds that IBM-Argentina's former senior management provided IBM-Argentina's procurement department with fabricated documentation, including a backdated authorization letter and a document that stated incomplete and inaccurate reasons for hiring CCR. According to the Order, IBM-Argentina recorded the payments to CCR in its books and records as third-party subcontractor expenses. This information was incorporated into IBM's 1994 Form 10-K, which was filed with the Commission on March 23, 1995. (Rel. 34-43761; AAE Rel. 1355; File No. 3-10397); [SEC v. ## SEC BARS JON WILLIAMS FROM ASSOCIATION WITH BROKER-DEALERS

The Commission has instituted and simultaneously settled administrative proceedings against Jon F. Williams, a former principal of Global Strategies Group, Inc. (Global), a registered broker dealer based in San Francisco, California. The Commission entered an order barring Williams from association with any broker or dealer.

The Commission's order was based upon the entry of a judgment against Williams in the United States District Court for the Northern District of California, SEC v. Jon F. Williams, et al. In that action, the Commission alleged that Williams and others engaged in a fraudulent scheme to sell "stock repurchase agreements" by falsely portraying the risks of the investment and the use of investor funds. The district court enjoined Williams from future violations of Section 17(a) of the Securities Act and Section 10(b) of the Exchange Act and Rule 10b-5. Williams consented to the entry of the district court judgment without admitting or denying the Commission's allegations of fraud. In addition to the injunction, Williams consented to pay a penalty of \$100,000. (Rel. 34-43764; File No. 3-10398)

# SEC OBTAINS JURY VERDICT AGAINST TWO DEFENDANTS IN SCHOLASTIC INSIDER TRADING CASE

The Commission announced today that on December 14 a federal jury found two Tampa-area real estate agents, Donna Yun of Longwood, Florida, and Jerry Burch of Heathrow, Florida, liable for illegal insider trading in options on the stock of Scholastic Corporation. The jury returned its verdict after an eight-day trial presided over by U.S. District Judge Ann Aldrich.

In its complaint, filed on February 3, 1999, the Commission alleged the following: on or before February 18, 1997, Yun's husband, an officer of Scholastic, told Yun in confidence that Scholastic would announce that it expected a loss for the quarter ending at the end of that month. Yun's husband also told her that he expected Scholastic common stock, then trading at approximately \$65 per share, to decline to \$55 as a result of the announcement. At a cocktail party that evening Yun disclosed this information to her co-worker Burch. During the following two days Burch purchased 130 Scholastic put option contracts, which would rise in value if Scholastic stock went down. After the close of trading on the second day, Scholastic announced the expected loss. The next day the price of Scholastic common stock dropped approximately 40 percent, and Burch exercised his put options, making a net profit of approximately \$269,000

The Court entered judgment against Yun and Burch on December 19. At a later date the Court will determine the appropriate relief, which may include permanent injunctions, civil penalties, and disgorgement of ill-gotten gains. [SEC v. An order has been issued authorizing National Grid Group plc (National Grid), a registered public utility holding company to solicit proxies from its common shareholders to obtain required approval for a proposed merger between National Grid and Niagara Mohawk Holdings, Inc., a public utility holding company exempt from registration under Section 3(a)(1) of the Act.
