COMMISSION ANNOUNCEMENTS

ORDER SUSPENDING UNIT INVESTMENT TRUST REDEMPTIONS

An order has been issued suspending redemptions of Western Guaranteed Income Trust, Series 85-1 and Series 2, pursuant to a determination under Section 22(e)(3) of the Investment Company Act that an emergency exists as a result of which it is not reasonably practicable for either unit investment trust series fairly to determine the value of its net assets; protection of security holders of the investment companies requires suspension until such time as the Commission on its own initiative rescinds this Order. CIVIL PROCEEDINGS

WORLDWIDE INVESTMENT RESEARCH, LTD. AND PAUL K. KOERNER ENJOINED

The Chicago Regional Office announced that on December 23, 1987 Judge Clyde S. Cahill, U.S. District Court for the Eastern District of Missouri, entered Orders of Permanent Injunction Pursuant to Default Judgment against Worldwide Investment Research, Ltd. and Paul K. Koerner. The Orders enjoins the defendants from further violations of the registration and antifraud provisions of the securities laws. The Orders also provide for an accounting from Worldwide and Koerner of all funds received from investors, within 60 days of the entry of the Orders. (SEC v. Worldwide Investment Research, Ltd., et al., EDMO, No. 87-1764-C-4, filed September 25, 1987). (LR-11640)

INVESTMENT COMPANY ACT RELEASES

BANCO DE VIZCAYA S.A.

A notice has been issued giving interested persons until February 1 to request a hearing on an application of Banco De Vizcaya, S.A. for an order granting exemption from all provisions of the Investment Company Act in connection with its proposed issuance of equity securities in the United States. RUSSELL INSURANCE FUND, INC.

An order has been issued exempting Russell Insurance Fund, Inc. from Sections 9(a), 13(a), 15(a), and 15(b) of the Investment Company Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) to permit the Fund to offer it shares to affiliated and unaffiliated life insurance companies in conjunction with variable annuity contracts and variable life insurance contracts. ADVISERS MANAGEMENT TRUST

An order has been issued granting Advisers Management Trust, Sentry Life Insurance Company (Sentry), Sentry Variable Life Account I (Account), and Sentry Equity Services, Inc. exemptions from the provisions of Sections 2(a)(32), 9(a), 13(a), 15(a), 15(b), 22(c), 27(c)(1), and 27(d) of the Investment Company Act and Rules 22c-1, 6e-2(b)(15), 6e-3(T)(b)(12)(ii), 6e-3(T)(b)(13)(iv), and 6e-3(T)(b)(15) to permit the deduction of a contingent deferred administrative charge in connection with the offering of flexible premium variable life insurance contracts, and to permit the Account to invest in shares of Advisers, which are sold to variable annuity and variable life insurance separate accounts of Sentry and of affiliated and unaffiliated life insurance companies. The order amends an order dated September 23, 1986 [Rel. IC-15324] issued pursuant to an earlier application [Rel. IC-15274] to include Advisers as a party. (Rel. IC-16207 - Jan. 7)

HOLDING COMPANY ACT RELEASES

PATIONAL FUEL GAS COMPANY

An order has been issued authorizing National Fuel Gas Company (National), a registered holding company, and its subsidiaries, National Fuel Gas Distribution Corporation, National Fuel Gas Supply Corporation, Empire Exploration, Inc., Penn-York Energy Corporation, Seneca Resources Corporation, Utility Constructors, Inc., and Highland Land & Minerals, Inc., to establish external short-term lines of credit and, in the case of National, to issue and sell commercial paper to dealers and/or short-term notes to banks through December 31, 1989. National and the subsidiaries have also been authorized to continue the system money pool arrangement through December 31, 1989. Proceeds from the proposed borrowings by National will be loaned to the subsidiaries through the Money Pool.
