CIVIL PROCEEDINGS

CIVIL INJUNCTIVE ACTION FILED AGAINST DAVID P. BLOOM AND GREATER SUTTON INVESTORS GROUP, INC.

The Commission today announced the institution of a civil injunction action against David Peter Bloom, a 23 year old Manhattan resident, and an entity controlled by him, Greater Sutton Investors Group, Inc., also known as Sutton Investors Group and Sutton Investment Group.

The Complaint alleges that Bloom and Sutton diverted a substantial portion of more than \$10 million of funds obtained from approximately 100 investment advisory clients since January 1986 and entrusted to defendants. According to the Complaint, beginning at least by January 1986, Bloom diverted a substantial portion of clients' funds to acquire at a cost exceeding \$8 million approximately 40 paintings, a three bedroom condominium apartment in Manhattan, a home in East Hampton, Long Island, furnishings, two luxury automobiles, and expensive jewelry.

The Honorable Michael B. Mukasey, U.S. District Court for the Southern District of New York, issued a Final Judgment of Permanent Injunction and Other Equitable Relief. The Court appointed Irving H. Picard, of the law firm of Olshan, Grundman & Frome, as a Receiver. Defendants have been ordered to transfer substantially all of their assets to the Receiver.

Bloom and Sutton, based on the Final Judgment, consented to administrative orders barring them from serving or being associated with any broker, dealer, investment adviser, investment company, or municipal securities dealer.
