# ADMINISTRATIVE PROCEEDINGS

STOP ORDER PROCEEDING INSTITUTED AGAINST MOKAN PRODUCTIONS, LTD.

The Commission announced that public administrative proceedings under Section 8(d) of the Securities Act of 1933 were instituted with respect to a registration statement on Form S-18 filed with the Commission by Mokan Products, Ltd. A hearing will be held to determine whether the registration statement includes untrue statements of material facts or omits material facts required to be stated therein, and to determine whether to issue a stop order suspending the effectiveness of the registration statement. The Division of Enforcement alleges that Mokan misrepresented its backlog of incomplete projects and overstated its revenues and income in its registration statement. (Rel. 33-6745)

STOP ORDER PROCEEDINGS INSTITUTED AGAINST CENTRAC ASSOCIATES, INC.

The Commission issued an Order Fixing Time and Place of Public Hearing under Section 8(d) of the Securities Act of 1933 to determine whether a Stop Order should be issued suspending the effectiveness of the registration statement of Centrac Associates, Inc.

The hearing has been set for 10:00 a.m. on January 28 at the Seattle Regional Office, 3040 Federal Building, 915 Second Avenue, Seattle, Washington 98174.

The Commission instituted the proceeding because of alleged untrue, false, and misleading statements made in and omissions in the registration statement concerning, among other things, Centrac's use of the proceeds derived from the offering; failure of the underwriters to perform and complete the offering under a firm commitment underwriting; and failure of the underwriters to remit all proceeds of the underwriting to the issuer. ## CIVIL PROCEEDINGS

COMPLAINT NAMES LEONARD LEVY, OTHERS

The Commission filed a Complaint on January 21 in the U.S. District Court for the District of Columbia against Leonard Levy, a California businessman, formerly chairman of the board of Information Displays, Inc.; Robert L. Boynton, formerly an officer and director of Carmel Bancorporation (CBC), and its subsidiary, The National Bank of Carmel (NBC); and Richard D. Fritz, formerly an officer of NBC and CBC. The Complaint alleges that Levy violated Sections 10(b) and 13(d) of the Exchange Act and Rules 10b-5, 13d-1, and 13d-2. It further alleges that Boynton and Fritz violated Section 17(a) of the Securities Act, Sections 10(b) and 13(d) of the Exchange Act, and Rules 10b-5 and 13d-1, and aided and abetted CBC's violations of Section 13(a) of the Exchange Act and Rules 12b-20 and 13a-1.

The Complaint alleges that Levy entered into an agreement with Boynton and Fritz whereby Boynton and Fritz agreed to have NBC finance Levy's acquisition of a stake in IDI. As part of the scheme, Levy filed a Schedule 13D (and amendments) which failed to disclose that Boynton and Fritz were acting in concert with Levy. Boynton and Fritz concealed the arrangement from CBC's board of directors. (SBC v. Leonard Levy, et al., USDC DC, Civil Action No. 88-0131). (LR-11648)

# INVESTMENT COMPANY ACT RELEASES

MACKAY-SHIELDS MAINSTAY TAX FREE BOND FUND

A notice has been issued giving interested persons until February 8 to request a hearing on an application filed by MacKay-Shields MainStay Tax Free Bond Fund for an order declaring that it has ceased to be an investment company. (Rel. IC-16227 - Jan. 15)

#### TRIDENT MORTGAGE SECURITIES COMPANY

A notice has been issued giving interested persons until February 8 to request a hearing on an application filed by Trident Mortgage Securities Company (Applicant), a limited purpose Delaware subsidiary of Trident Financial Corporation, on behalf of itself and all owner trusts (each, a Trust), and partnerships (each, a Partnership) it may establish in the future, exempting Applicant, and each Trust and Partnership (collectively, an Issuing Affiliate), from all provisions of the Investment Company Act in connection with the issuance of mortgage-backed bonds, and the sale of residual interests in the Issuing Affiliate. #### LOMAS MORTGAGE FUNDING CORPORATION II

An order has been issued exempting Lomas Mortgage Funding Corporation II from all provisions of the Investment Company Act in connection with the issuance and sale of mortgage-backed securities. (Rel. IC-16229 - Jan. 19)

#### LUTHERAN BROTHERHOOD VARIABLE INSURANCE PRODUCTS COMPANY

An order has been issued exempting Lutheran Brotherhood Variable Insurance Products Company, LBVIP Variable Insurance Account II, LBVIP Series Fund, Inc., and Lutheran Brotherhood Securities Corp. from Sections 9(a), 13(a), 15(a), and 15(b) of the Investment Company Act and Rule 6e-2(b)(15) to permit the sale of shares of LBVIP Series Fund to both variable annuity and variable life separate accounts of the Company and its affiliates. (Rel. IC-16230 - Jan. 19)

### **HOLDING COMPANY ACT RELEASES**

#### NEW ENGLAND ELECTRIC SYSTEM

A supplemental order has been issued correcting a Commission order dated December 30, 1987 [Rel. 35-24553] which authorized a proposal by New England Electric System (NEES), a registered holding company, and its subsidiary, NEES Energy, Inc. (Energy), whereby Energy will provide certain energy management services, and engage in cogeneration and small power production enterprises financed by NEES in outstanding amounts up to \$250 million. This supplemental order corrects the December 30, 1987 order regarding the beginning and ending dates for investments by Energy for energy management services, and reserves jurisdiction over energy management services expenditures in 1989.
