SEC SETS RELEASE OF MARKET REPORT, SUBSEQUENT PRESS BRIEFING

FRIEND-OF-THE-COURT BRIEF FILED IN COURT OF APPEALS CONCERNING TENDER OFFER FINANCING

General Counsel Daniel L. Goelzer announced that the Commission filed a friend-of-thecourt brief in <u>IU International Corp. v. NX Acquisition Corp.</u>, in the Fourth Circuit Court of Appeals. IU International, target of a hostile tender offer by NX Acquisition, contends that NX violated the Williams Act and Commission rules because the offer was made before NX had financing in place. The Commission's brief disagrees, arguing that the Act and rules do not require financing before a tender offer commences. The brief explains that if a bidder does not have financing at the start of a tender offer, it must fully and accurately disclose its plans for obtaining financing and whatever steps it has taken to implement them. When financing arrangements are later made during the offer, the bidder must disclose them and may, depending upon the circumstances, have to extend the offer to allow shareholders to consider the information. Because the bidder must pay for any shares tendered and accepted, or return them, promptly after an offer closes (usually within five days), the bidder almost certainly must have financing arrangements in place, and must disclose these arrangements to shareholders, before the close of the offer. EBI SERIES TRUST

#### **HOLDING COMPANY ACT RELEASES**

COLUMBUS SOUTHERN POWER COMPANY

A supplemental order has been issued authorizing Columbus Southern Power Company, subsidiary of American Electric Power Company, Inc., to amend certain aspects of its proposal to undertake a \$260 million financing program through December 31, 1988, consisting of any combination of the issuance and sales of first mortgage bonds and/or unsecured long-term notes in up to that aggregate principal amount, and of up to \$80 million of cumulative preferred stock. THE COLUMBIA GAS SYSTEM, INC.

An order has been issued authorizing a proposal by The Columbia Gas Company, a registered holding company, to acquire on the open market from time-to time through December 31, 1989 up to 2% of its outstanding shares of common stock, \$10 par value per share. (Rel. 35-24565 - Jan. 27)

SIERRA PACIFIC RESOURCES

A memorandum opinion and order has been issued authorizing Sierra Pacific Resources, a Nevada corporation and an exempt holding company under the Public Utility Holding Company Act of 1935, to acquire a 14.5% stock interest in a new company that will construct a 250-megawatt, coal-fired generating unit in Nevada to sell electric energy at wholesale. Ten non-utility companies will acquire the balance of the stock in the new company, with no one such company owning as much as 10% thereof. (Rel. 35-24566 -Jan. 28)

# **ACQUISITIONS OF SECURITIES**

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section (3)(3)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the prior percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
