U.S. CEOURITIES AND EXCHANCE COMMISSION

ADDITION TO WEEKLY CALENDAR

David S. Ruder, Chairman of the Commission, will testify on Glass-Steagall reforms before the Subcommittee on Telecommunications and Finance of the House Energy and Commerce Committee on Wednesday, April 13. The hearing will begin at 9:30 a.m. in Room 2123, Rayburn House Office Building.

ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST ROBERT M. WINSTON, OTHERS

The Commission ordered public administrative proceedings under the Securities Exchange Act of 1934 against MCG Portfolio Management Corporation (Registrant), its president, Thomas C. Mullen, and three individuals associated with it, Robert M. Winston, Joseph G. Antonucci, and Lon Roy Kavanaugh, Jr.

The Order Instituting Proceedings alleges that Winston and Antonucci were convicted of crimes enumerated in Section 15(b)(4)(B) of the Exchange Act, within the last ten years, and thereafter became associated with Registrant. It also alleges that Ravanaugh became associated with Registrant while he was subject to a 1978 Commission bar, and that Registrant, aided and abetted by Mullen, knowingly allowed Kavanaugh to associate with Registrant. It further alleges that Registrant allowed Barry Braison, another individual who was convicted of a crime enumerated in Section 15(b)(4)(B) of the Exchange Act, to become associated with it.

A hearing will be scheduled to determine whether these allegations are true and, if so, to decide what remedial action, if any, is appropriate. (Rel. 34-25548)

INVESTMENT COMPANY ACT RELEASES

THE LIFE INSURANCE COMPANY OF VIRGINIA

An order has been issued exempting The Life Insurance Company of Virginia, Life of Virginia Separate Account 4, and Forth Financial Securities Corporation from the provisions of Sections 26(a)(2) and 27(c)(2) of the Investment Company Act to permit the deduction of mortality and expense risk charges from the assets of Separate Account 4. (Rel. IC-16350 - April 6)

WELLS FARGO BANK, N.A.

An order has been issued on an application filed by Wells Fargo Bank, N.A. and Wells Fargo Investment Advisors granting permanent exemption under Section 9(c) of the Investment Company Act from the provisions of Section 9(a) of the Act to allow Applicants to serve or act in certain capacities for registered investment companies. KENTUCKY POWER COMPANY; HOLYOKE WATER POWER COMPANY; NOVERCO INC.; EASTERN EDISON COMPANY

Notices have been issued giving interested persons until May 2 to request a hearing on a proposal by the following companies filed under Release 35-24619, dated April 7: <u>KENTUCKY POWER COMPANY</u> - subsidiary of American Electric Power Company, Inc., to issue and sell up to \$75 million of long-term unsecured promissory notes, pursuant to a term loan agreement; <u>HOLYOKE WATER POWER COMPANY</u> - subsidiary of Northeast Utilities, to refinance up to \$8 million of pollution control revenue bonds; <u>NOVERCO INC</u>. - of Montreal, Canada, (1) to acquire the common stock of Northern New England Gas Corporation, a Vermont corporation and an exempt holding company, and (2) for an exemption under Section 3(a)(5) of the Public Utility Holding Company Act of 1935; and <u>EASTERN</u> <u>EDISON COMPANY</u> - subsidiary of Eastern Utilities Associates, to extend the <u>period</u> from April 30 to May 31, 1988 during which Eastern Edison may issue and sell, in one or more series from time to time, by competitive bidding not more than \$100 million aggregate principal amount of first mortgage bonds and collateral trust bonds.
